# Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 911A(2)(l) – Exemption

# **Enabling legislation**

1. The Australian Securities and Investments Commission makes this instrument under paragraph 911A(2)(1) of the *Corporations Act 2001* (the *Act*).

#### Title

2. This instrument is ASIC Class Order [CO 11/927].

#### Commencement

- 3. This instrument commences on the later of:
  - (a) the date it is registered under the Legislative Instruments Act 2003; and.
  - (b) the date of its gazettal.

Note: An instrument is registered when it is recorded on the Federal Register of Legislative Instruments (FRLI) in electronic form: see Legislative Instruments Act 2003, section 4 (definition of register). The FRLI may be accessed at <a href="http://www.frli.gov.au/">http://www.frli.gov.au/</a>.

# Exemption

4. A money management service provider does not have to hold an Australian financial services licence covering the provision of financial product advice to a person (the *client*) in relation to a basic deposit product.

# Where this instrument applies

- 5. This instrument applies where all of the following are satisfied:
  - (a) the financial product advice is provided to the client as part of a money management service;
  - (b) no fees or charges (however described) are payable by or on behalf of the client in relation to the advice or any other aspect of the money management service;
  - (c) no remuneration (whether by way of commission or otherwise) is payable to or for the benefit of the money management service provider, their representatives or associates by any person in relation to any action by or on behalf of the client arising from either the advice or any other aspect of the money management service;
  - (d) the money management service provider:

- (i) does not carry on or otherwise participate in a financial services business which involves the provision of a financial service other than the financial service to which this instrument relates; and
- (ii) takes all reasonable steps to ensure that none of its representatives provides or participates in the provision of a financial service other than the financial service to which this instrument relates;
- (e) the money management service provider takes all reasonable steps to ensure that each representative who provides the financial service on its behalf has undertaken appropriate training to ensure that they have adequate skills, knowledge and experience to satisfactorily provide the financial service and any other aspect of the money management service.

Note: By paragraph 911B(1)(e) of the Act, a person providing a financial service on behalf of a money management service provider is exempt from the requirement to hold an Australian financial services licence for the provision of the service if the service provider would have been so exempt under this instrument had the provider provided the service.

#### Interpretation

6. In this instrument:

basic deposit product has the meaning given by section 761A of the Act.

financial product advice has the meaning given by section 766B of the Act.

money management service means a financial literacy and capacity building service provided predominantly to improve the financial knowledge and skills of persons, principally Indigenous persons located in regional and remote Indigenous communities.

money management service provider means a body that is funded in whole or in part by the Commonwealth through the Department of Families, Housing, Community Services and Indigenous Affairs to provide a money management service.

representative has the meaning given by section 910A of the Act.

# Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 601QA(1)(a) and 911A(2)(l) — Revocation and Exemption

- 1. Under paragraph 601QA(1)(a) of the *Corporations Act 2011 (Act*), the Australian Securities and Investments Commission (*ASIC*) revokes ASIC instrument [01/0782] dated 18 June 2001.
- Under paragraph 601QA(1)(a) of the Act, ASIC exempts Magnetic Shoals Limited ACN 010 491 282 (the Operator) in the case specified in Schedule A on the conditions set out in Schedule B for so long as those conditions are met from section 601ED of the Act
- 3. Under paragraph 911A(2)(1) of the Act, ASIC exempts the Operator from the requirement to hold an Australian financial services licence for the provision of financial services, in the case specified in Schedule A on the conditions set out in Schedule C for so long as those conditions are met.

#### Schedule A

- 1. The operation of the time-sharing scheme known as Island Palms Resort located at 13 The Esplanade, Nelly Bay, Magnetic Island in the State of Queensland (*the Scheme*), where:
  - (a) the management of the property to which the Scheme relates is supervised by a company (the *Club*);
  - (b) at least 90% of the votes that may be cast on a resolution by the members of the Club are held by members that are not, and are not associated in relation to the Scheme with, any operator, manager, promoter or developer in relation to the Scheme, other than where held by members solely in their capacity as an associate of the Club;
  - (c) at least 90% by value or number of all the interests in the Scheme that can be issued have been issued and are held by persons who are not, and are not associated in relation to the Scheme with, the Operator, any operator, manager, promoter or developer in relation to the Scheme, other than where held by members solely in their capacity as an associate of the Club;
  - (d) no promoter of the Scheme nor any developer in relation to the property to which the Scheme relates has failed to perform any contractual obligation to any member in relation to the Scheme that is likely to adversely affect the member's interests; and
  - (e) the constitution of the Club provides for the removal of a director if a resolution for their removal is supported by more than 50% of its members by value or, if the constitution so provides, by number.

#### Schedule B

- 1. In relation to each building that was to be built under the terms of any prospectus in relation to the scheme, the Operator:
  - (a) ensures that the building is substantially completed to the extent that members will not be materially affected if no further construction occurs; or
  - (b) gives ASIC a notice in writing stating that the building will not be substantially completed and that the members of the Scheme will not be materially affected by its not being substantially completed.
- 2. No offers of interests in the Scheme for issue that would need disclosure under Part 6D.2 of the Act if the Scheme were a registered scheme have been, or were made, on or after 1 June 2000, other than an offer of interests referred to in Schedule C.
- 3. The Operator must ensure that each member of the Scheme:
  - (a) has received share or membership certificates in the Club (or, where the constitution of the Scheme and the Act has permitted and where no share or membership certificates in the Club are issued, documentation or other evidence of membership in the Club); and
  - (b) falls into one or more of the following categories:
    - (i) they have received a certificate of title (and, where there is no certificate of title issued by the relevant titles registry, a copy of a registration confirmation statement or other evidence of title issued by the relevant titles registry) showing the member as holding title in a portion of the real property to which the Scheme relates in accordance with their entitlement; or
    - (ii) they have received a copy of the certificate of title certified as a true copy by a Justice of the Peace or a lawyer, where the Club has acknowledged that it is holding such a certificate in safe custody to be dealt with in accordance with provisions in the Club's constitution that provide for the certificate to be used only to facilitate a transfer authorised by the member, or on forfeiture of the interest; or
    - (iii) they became a member as a result of the forfeiture of the interest by a former member.
- 4. The Operator must ensure that any management agreement for the Scheme or property that members have a right to use, occupy or possess as part of the Scheme provides for the dismissal of the manager without any additional payment when members of the Club pass a resolution to that effect in at least one of the following cases:
  - (a) more than 50% of all members vote for dismissal;
  - (b) members holding more than 50% by value of the interests vote for dismissal;

- (c) 75% of members voting (whether in person or by proxy) vote for dismissal where at least 25% of members eligible to vote do so; or
- (d) members holding 75% by value of the interests that are held by members voting (whether in person or by proxy) vote for dismissal where members holding at least 25% by value of the interests eligible to vote do so,

unless all of the following apply:

- (e) the management agreement was in force on 6 December 1999;
- (f) there has not since that date been any lawful means for the Club to terminate the agreement;
- (g) members are given at least 21 days' written notice that the Operator seeks to rely on the exception contained in paragraphs 4(e) to 4(n) of this Schedule and that the management agreement does not meet the usual requirements of ASIC policy concerning how a management agreement may be terminated;
- (h) the notice sent to members allows the member to requisition a vote by ticking a form accompanying the notice;
- (i) the notice contains a summary of all material information that is relevant to a member's decision whether to requisition a vote;
- (j) the notice states prominently a reply paid address to which the form requisitioning a vote may be sent;
- (k) the notice states prominently that if:
  - (i) members who together hold at least 5% of the total value of the interests; or
  - (ii) at least 100 members,
- requisition a vote by giving written notice to the reply paid address within 21 days from the date that the notice may reasonably be expected to be received by them, a postal vote will be held on whether the Operator should be able to rely on this exception or should be required to comply with the usual ASIC policy concerning how a management agreement may be terminated;
- (l) a postal vote is conducted, if requisitioned, in accordance with the notice as soon as practicable;

#### (m) if there is a postal vote:

- (i) a voting paper is sent to each member and states a reply paid address to which the voting paper may be sent; and
- (ii) members must be notified in, or in a document accompanying, the voting paper that:
  - (A) only votes received at the reply paid address within 28 days after the issue of the voting paper will be counted; and

- (B) the vote will be taken as passed if supported by either a majority by value or by number of votes cast (as specified in the notice); and
- (iii) the voting paper must be accompanied by a notice which explains that, unless members vote against permitting the Operator from relying upon this exception, the Operator may be permitted to do so despite the management agreement not complying with the usual ASIC policy concerning how a management agreement may be terminated; and
- (iv) the notice accompanying the voting paper must contain a summary of information that is materially relevant to a member's decision whether to vote for or against the proposed resolution;
- (n) ASIC is notified in writing where a vote was required and, if so, whether the vote was passed.
- 5. The Operator of the Scheme establishes, and maintains, an adequate internal dispute resolution procedure:
  - (a) in accordance with subparagraph 912A(2)(a)(i) of the Act as if the Operator were a licensee that was subject to that subparagraph; and
  - (b) that covers complaints against the Operator made by members in connection with the operation of the Scheme.
- 6. The Operator must not make or facilitate the making of any offer for issue or sale of an interest in the Scheme unless the issue or sale is subject to a cooling-off period of not less than:
  - (a) if the Operator is a member of ATHOC and has not been notified in writing by ASIC that it cannot continue to give a cooling-off period of 7 calendar days not less than 7 days; or
  - (b) otherwise not less than 14 calendar days.

#### Schedule C

- 1. The Operator does not sell more than 5% of the interests in the Scheme in one calendar year.
- 2. The Operator must ensure that any application for an investment in the Scheme is voidable at the option of the applicant during a period of:
  - (a) if the Operator is a member of ATHOC and has not been notified in writing by ASIC that it cannot continue to give a cooling-off period of 7 calendar days not less than 7 days; or
  - (b) otherwise not less than 14 calendar days,

commencing on the date on which the applicant acknowledged receipt of any required disclosure document and the cooling-off statement referred to in paragraph 4 of this Schedule.

- 3. The Operator must not resell any interest in the Scheme, unless the applicant has provided the acknowledgment of receipt referred to in paragraph 2 of this Schedule.
- 4. Each application form relating to an interest in the Scheme must be accompanied by a separate statement in a form approved by ASIC which:
  - (a) describes the effect of the cooling-off period referred to in paragraph 2 of this Schedule; and
  - (b) states that the signed application form will be of no effect unless the applicant also signs an acknowledgement of receipt of such a cooling-off statement.
- 5. The cooling-off rights referred to in paragraph 2 of this Schedule must be disclosed prominently in any required disclosure document and the application form which relate to the offer of interests in the Scheme.
- 6. The Operator must maintain written records relating to the issue by it of all cooling-off statements referred to in paragraph 4 of the Schedule, which include:
  - (a) each applicant's signed acknowledgement of receipt of such a statement; and
  - (b) the date of issue of each statement; and
  - (c) the identity of the applicant to whom each statement has been issued.
- 7. The Operator must return the deposit for an interest in the Scheme, and must not deduct any fees or expenses, if the applicant decides not to proceed with the purchase of an interest in the Scheme during the cooling-off period referred to in paragraph 2 of this Schedule.
- 8. If the Operator receives a deposit for an interest in the Scheme, it must:
  - (a) pay, by the next business day, the deposit into an account that is held with an Australian ADI into which only deposit monies from an application for the purchase of an interest in the Scheme and interest on those deposit monies are paid; and
  - (b) hold the deposit on trust for the applicant until the cooling-off period in paragraph 2 of this Schedule has expired.
- 9. The Operator establishes and maintains membership of an external dispute resolution scheme:
  - (a) in accordance with subparagraph 912A(2)(b)(i) of the Act as if the Operator were a licensee that was subject to that subparagraph; and

(b) that covers complaints against the Operator made by members in connection with the operation of the Scheme.

#### Australian Securities and Investments Commission Corporations Act 2001 — Subsection 655A(1) – Declaration

# **Enabling legislation**

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under subsection 655A(1) of the Corporations Act 2001 (the Act).

#### Title

2. This instrument is ASIC Instrument [11-1100].

#### Commencement

3. This instrument commences on 24 October 2011.

#### Revocation

- 4. The following instruments are revoked:
  - (a) ASIC Instrument [11-0917]; and
  - (b) ASIC Instrument [11-0918].

#### **Declaration**

- 5. Chapter 6 of the Act applies to SABMiller plc, a body incorporated under the laws of England and Wales (*SABM*) and SABMiller Beverage Investments Pty Limited (ACN 150 900 093) (*SBI*) as if section 631 were modified or varied by omitting subsection (1) and inserting:
  - "(1) Subject to subsection (1AA), a person contravenes this subsection if:
    - (a) either alone or with other persons, the person publicly proposes to make a takeover bid for securities in a company;
    - (aa) after the person makes the public proposal the company enters into an agreement (scheme agreement) to propose a compromise or arrangement under Part 5.1 which, if approved, will result in the person acquiring a relevant interest in securities in the company (scheme proposal); and
    - (b) the person has not made offers for the securities referred to in paragraph (a) under a takeover bid within:
      - (i) if a party to the scheme agreement publicly announces that:
        - (A) the scheme agreement has been terminated; or
        - (B) the scheme agreement has been varied without the prior written consent of ASIC; or

- (C) any offer to acquire securities in the company contemplated in the scheme agreement will not be made in accordance with the terms specified in the scheme agreement; or
- (D) the scheme proposal will otherwise not proceed, 3 weeks after that announcement; or
- in any other case-4 months and 14 days after the public proposal.

The terms and conditions of the bid must be the same as or not substantially less favourable than those in the public proposal.

(1AA) A person does not contravene subsection (1) if orders of the Court approving the scheme proposal under paragraph 411(4)(b) are lodged with ASIC before the time the person must make a takeover bid in accordance with paragraph (1)(b)."

# Where this instrument applies

- 6. This instrument applies in relation to the public proposal by SABM on 17 August 2011 that SBI make a takeover bid for all of the issued shares in Foster's Group Limited (ACN 007 620 886) (*Foster's*) where:
  - (a) prior to 8:00pm AEDT on 25 October 2011, SBI has provided ASIC with an executed copy of a document varying the scheme implementation agreement between SABM and Foster's provided to ASIC on 22 September 2011 (SIA), such that, following the variation, the terms of the SIA are the same, in all material respects, as those set out in documentation provided to ASIC by email at 4:01pm AEDT on 21 October 2011; and
  - (b) any explanatory statement issued by Foster's in relation to the scheme the subject of the SIA:
    - (i) includes a copy of the SIA as varied; and
    - (ii) includes a statement describing the need for, and effect of, the relief contained in this instrument (including that the relief has taken effect).




