Pursuant to paragraph 601QA(1)(b) of the *Corporations Act 2001* (the “Act”) the Australian Securities and Investments Commission (“ASIC”) hereby declares that Chapter 5C applies to the person mentioned in Schedule A in relation to each of the registered schemes specified in Schedule B in the case set out in Schedule C as if section 601FL of the Act were modified or varied as follows:

1. omitting from subsection (1) all the text after the word “it” and substitute the following text:

“must either:

- (a) call a members’ meeting to explain its reason for wanting to retire and to enable the members to vote on a resolution (which must be an extraordinary resolution if the scheme is not listed) to choose a company to be the new responsible entity; or
- (b) propose a related body corporate to be the new responsible entity in accordance with subsection (1A).”;

2. inserting after subsection (1) the following subsection:

“(1A) The requirements for proposing a related body corporate to be the new responsible entity are as follows:

- (a) The responsible entity must give members notice of a proposal to choose a company (the *proposed responsible entity*), which is a related body corporate, to be the scheme’s new responsible entity.
- (b) The notice to members must:
 - (i) set out:
 - (A) the responsible entity’s reasons for wanting to retire; and
 - (B) such information as can reasonably be expected to be material to a member in forming a view as to the choice of the proposed responsible entity; and
 - (ii) state prominently that if:
 - (A) members who together hold at least 5% of the total value of the interests held by members; or
 - (B) 100 members,

- who would be entitled to vote if the proposal were put as a proposed resolution to a meeting of members under paragraph (1)(a), ask for a vote on the choice of the proposed responsible entity by giving written notice received by the responsible entity within 21 days from the date the notice is sent, the responsible entity will either arrange a postal vote or convene a meeting to vote on a resolution for the choice of the proposed responsible entity; and
- (iii) be accompanied by a form which can be ticked to ask for a vote; and
 - (iv) state prominently a reply paid address of the responsible entity to which the form may be sent.
- (c) If sufficient members ask for a vote in accordance with the notice, the responsible entity must arrange for a postal vote or, if the responsible entity chooses, convene a meeting in accordance with Part 2G.4 to vote on the choice of the proposed responsible entity as soon as possible.
- (d) If there is a postal vote:
- (i) a voting paper must be sent to each member stating a reply paid address of the responsible entity to which the voting paper may be sent;
 - (ii) the responsible entity must notify the members in, or in a document accompanying, the voting paper that:
 - (A) the proposed responsible entity will be chosen as the new responsible entity if at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the choice; and
 - (B) only votes received by the responsible entity within 28 days after the issue of the voting paper will be counted.
- (e) If a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed"; and

3. inserting after subsection (2), the following subsections:

“(2A) If a postal vote is arranged under paragraph (1A)(c) and at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the proposed responsible entity, that entity is taken for the purposes of subsection (2) to have been chosen by a resolution of members on the last day on which postal votes may be received in order to be counted.

(2B) If:

- (a) a related body corporate is proposed to be the new responsible entity in accordance with subsection (1A); and
- (b) sufficient members do not ask for a vote to choose the entity in accordance with the notice referred to in paragraph (1A)(b); and
- (c) the entity has consented in writing to becoming the scheme’s responsible entity,

then:

- (d) as soon as practicable and in any event within 2 business days after the end of the period in which a member may ask for such a vote, the current responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme’s registration to name the proposed responsible entity as the scheme’s responsible entity; and
- (e) the notice must be accompanied by a certificate from the current responsible entity that it reasonably considers that the appointment of the proposed responsible entity would be in the best interests of members with a summary of the responsible entity’s reasons as to why this is the case; and
- (f) unless ASIC reasonably believes that the appointment of the proposed responsible entity would not be in the best interests of members, ASIC must comply with the notice as soon as practicable after the notice and summary are lodged.”.

Under paragraph 911A(2)(h) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts Macquarie Goodman (NZ) Limited (*MGNZ*), a New Zealand Corporation having company number 1467292 as manager of the Macquarie Goodman Property Trust (*MGPT*), from subsection 911A(1) of the Act in the case referred to in Schedule A on the conditions specified in Schedule B for so long as they are met.

Schedule A

Providing financial product advice or dealing in units in the MGPT where:

- (i) the financial services relate to the distribution reinvestment plan for the MGPT; and
- (ii) the financial services are only provided to 10 persons or less in Australia that are wholesale clients in terms of section 761G of the Act.

Schedule B

1. The financial services are provided by MGNZ in Australia only to wholesale clients.
2. The financial services are provided by MGNZ in accordance with the requirements of the New Zealand Unit Trusts Act 1960 (*Unit Trusts Act*), the New Zealand Securities Act (1978) (*Securities Act*), the New Zealand Securities Commission (*NZSC*), the Listing Rules of New Zealand Exchange Limited (*NZX Listing Rules*) and any other applicable requirements of New Zealand law relating to the financial services.
3. MGPT continues to be regulated by NZSC and listed on the New Zealand Stock Exchange (*NZX*).
4. The NZSC requirements, including the Unit Trusts Act and the Securities Act, and NZX Listing Rules and any other applicable requirements of New Zealand law relating to the financial services do not materially change.
5. MGNZ notifies ASIC of:
 - (i) any significant changes to the general NZSC regulatory regime of New Zealand relevant to the financial services;
 - (ii) any enforcement or disciplinary activity against MGNZ or MGPT in a foreign jurisdiction, including any events in New Zealand leading to disciplinary or enforcement action by the NZSC or NZX against MGNZ or MGPT;
 - (iii) any significant exemption or other relief which MGNZ or MGPT may obtain from the New Zealand regulatory requirements.
6. MGNZ discloses to any wholesale client to whom the financial services are provided in Australia that:

- (i) MGNZ is exempt from the requirement to hold an Australian financial services licence in respect of the financial services and that MGNZ has the benefit of this relief; and
- (ii) the financial services are regulated by NZSC and NZX and that the rules set by those organisations differ from the Australian regulatory regime;

7. MGNZ:

- (i) submits to the non-exclusive jurisdiction of the Australian courts;
- (ii) complies with any order of an Australian court in respect of the financial services;
- (iii) provides ASIC with:
 - (a) a deed for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - (A) the deed is irrevocable except with the prior written consent of ASIC;
 - (B) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise;
 - (C) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
 - (D) if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent referred to in paragraph (8) below; and
 - (E) the body covenants that, on written request of either NZSC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist NZSC to disclose to ASIC and ASIC to disclose to NZSC any information or document that NZSC or ASIC has that relates to the body; and
 - (b) written consent to the disclosure by NZSC to ASIC and ASIC to NZSC of any information or document that NZSC or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

8. MGNZ appoints a local Agent in accordance with the Act.
