Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts Australian Skandia Limited (ACN 093 415 251) (*Australian Skandia*) from the requirement to hold an Australian financial services licence for dealing in a financial product in the case set out in Schedule A on the conditions set out in Schedule B for so long as they are met.
2. Under paragraph 911A(2)(l), ASIC exempts EB Trustees Limited, a foreign trustee company incorporated under the laws of Jersey (the *Trustee*) from the requirement to hold an Australian financial services licence for the provision of the following financial services in the case set out in Schedule A:
 - (a) the provision of a custodial or depositary service in connection with the exercise of an option issued under a Previous Offer where the Trustee performs its duties in good faith and has sufficient resources to perform those duties; and
 - (b) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph (a).

Schedule A

Where

1. any acquisition by purchase or disposal of the product by Australian Skandia or an associate of the issuer occurs either:
 - (a) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (b) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in those financial products;
2. the dealing occurs in connection with the exercise by an eligible employee of an option issued under a Previous Offer;
3. the number of Participants in the Plans must not exceed 1% of the total number of persons participating in the Plans; and
4. the financial services are provided by the Trustee to the Participants solely for the purpose of the Plans.
