Australian Securities and Investments Commission  
Corporations Act 2001 - Subsection 741(1) - Declaration

Pursuant to subsection 741(1) of the Corporations Act 2001 (the "Act") the Australian Securities and Investments Commission ("ASIC") hereby declares that Chapter 6D of the Act applies to the persons specified in Schedule A in the case specified in Schedule B as if:

1. the text of paragraph 723(3)(b) of the Act was omitted and the following substituted:  
"the securities are not admitted to quotation within 3 months after the later of:
  - (i) the date of the disclosure document; and
  - (ii) the date of a supplementary disclosure document which relates to the matters referred to in subparagraph 724(1)(b)(ii) or subsection 724(1AA);";
2. paragraph 724(1)(a) of the Act was modified or varied by omitting the words "and that condition is not satisfied within 4 months after the date of the disclosure document" and substituting the words: "and that condition is not satisfied within 4 months after the later of:
  - (iii) the date of the disclosure document; or
  - (iv) the date of a supplementary disclosure document which relates to the matters referred to in subparagraph 724(1)(b)(ii) or subsection 724(1AA) and which explains the effect of this paragraph and subsection 724(1AA)"; and
3. section 724 was amended by inserting the following subsection after subsection 724(1):  
"724(1AA) Where a person lodges a supplementary disclosure document which relates to the matters referred to in subparagraph (1)(b)(ii) or this subsection, and the securities are not admitted to quotation within 3 months after the date of the supplementary disclosure document, the person must deal under subsection (2) with any applications for the securities made under the disclosure document to which the supplementary disclosure document relates that have not resulted in an issue or transfer of the securities. For the purpose of working out whether a condition referred to in paragraph (1)(a) has been satisfied, a person who has agreed to take securities as underwriter is taken to have applied for those securities.".

**Australian Securities and Investments Commission**  
**Corporations Act 2001 — Subsections 741(1) and 1020F(1) — Exemption and**  
**Modification**

1. Under paragraph 741(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts the persons specified in Schedule A in the case described in Schedule D, from subsection 711(6), section 722 and subsection 723(1) of the Act, and from the provisions of Chapter 6D of the Act generally insofar as those provisions may not permit a prospectus to comprise one document only, on the conditions set out in Schedule E, for so long as those conditions are met.
2. Under paragraph 741(1)(b) of the Act, ASIC declares that Part 6D.2 of the Act applies to the persons referred to in Schedule A in the case set out in Schedule F as if subsection 708(13) were modified by omitting paragraph 708(13)(b) and substituting:
  - “(b) an offer of fully-paid shares in a body to 1 or more existing holders of shares in the body, under a plan for the reinvestment of at least one of the following:
    - (i) dividends in respect of shares in the body;
    - (ii) dividends in respect of shares in another body which, on the terms on which they may be traded, must only be transferred together with shares in the body and interests in one or more registered managed investment schemes;
    - (iii) distributions in respect of interests in one or more registered managed investment schemes which, on the terms on which they may be traded, must only be transferred together with shares in one or more bodies.”.
3. Under paragraph 1020F(1)(a) of the Act, ASIC exempts the person specified in Schedule B from subsection 1013B(1), subsection 1013L(2) and subsection 1016A(2) of the Act in the case described in Schedule D, on the conditions set out in Schedule E, for so long as those conditions are met.

  - (a) subsection 1010A(1) were modified by omitting “section 1017F” and substituting “sections 1012D and 1017F”;

    - (i) omitting “either” at the beginning of paragraph 1012D(3)(b) and substituting “one or more of the following applies”;
    - (ii) omitting “or” at the end of subparagraph 1012D(3)(b)(i);

- (A) distributions in respect of interests in the scheme;
- (B) distributions in respect of interests in another registered managed investment scheme which, on the terms on which they may be traded, must only be transferred together with interests in the scheme and shares in one or more bodies;
- (C) dividends in respect of shares in one or more bodies which, on the terms on which they may be traded, must only be transferred together with interests in one or more registered managed investment schemes;

(iv) in an issue situation – the offer or issue that constitutes the relevant conduct is an offer or issue of interests in a registered managed investment scheme, under a plan for the reinvestment of at least one of the following:

- (A) distributions in respect of interests in the scheme;
- (B) distributions in respect of interests in another registered managed investment scheme which, on the terms on which they may be traded, must only be transferred together with interests in the scheme and shares in one or more bodies;
- (C) dividends in respect of shares in one or more bodies which, on the terms on which they may be traded, must only be transferred together with interests in one or more registered managed investment schemes.”.



1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts, for the avoidance of doubt until 14 April 2006, the persons referred to in Schedule A from compliance with Chapter 5C of the Act in relation to the operation of the Sale Facility mentioned in Schedule B on the conditions specified in Schedule C for so long as the conditions are met.
2. 

**Invitation** means an invitation to an Excluded Foreign Person to make an offer to sell or dispose of their APG Stapled Securities or ADIF Stapled Securities or both.

**Offer** means an offer to purchase an APG Stapled Security or an ADIF Stapled Security or both, made to an Excluded Foreign Person including an offer which an Excluded Foreign Person may be deemed to have accepted.


