**Australian Securities and Investments Commission  
Corporations Act 2001 – Paragraphs 655A(1)(a) – Exemption**

    - (ii) informs holders of their right to obtain a copy of the document (or part) free of charge.

**AIM Rules** means the “AIM Rules for Companies” as published by LSE.

**Buttermere Supplementary Bidder's Statement** means a supplementary bidder's statement lodged by Buttermere Australia Pty Limited ACN 120 663 710 (“**Buttermere**”) with ASIC on 13 March 2007 in relation to an off-market takeover bid for all the ordinary shares in Marathon.
