# Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 741(1)(a), 911A(2)(l) and 1020F(1)(a) — Exemptions

- 1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission (ASIC) exempts TOWER Australia Group Limited ACN 003 401 698 (TOWER) from Parts 6D.2 and 6D.3 (except section 736), section 1017F, and Divisions 5A and 6 of Part 7.9 where TOWER makes an Eligible Offer, or issues securities under an Eligible Offer, that does not involve a contribution plan on the conditions set out in the Schedule and for so long as the conditions are met.
- 2. Under paragraph 911A(2)(l) of the Act, ASIC exempts TOWER from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an Eligible Offer (including any general advice given in the Offer Document) where the Offer Document includes a statement to the effect that any advice given by the person in connection with the Eligible Offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 3. Under paragraph 911A(2)(1) of the Act, ASIC exempts TOWER and its related bodies corporate from the requirement to hold an Australian financial services licence for the provision of the following financial services:
  - (a) the provision of a custodial or depository service in connection with an Eligible Offer where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
  - (b) dealing in a financial product in the course of providing a custodial or depository service covered by subparagraph (3)(a); and
  - (c) dealing in a financial product in connection with the Eligible Offer where any acquisition by purchase or disposal of the product (by TOWER or a related body corporate) occurs either:
    - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
    - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 4. Under paragraph 741(1)(a) of the Act, ASIC exempts TOWER and its related bodies corporate from section 736 in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with an Eligible Offer.



#### Schedule

The following conditions apply:

- 1. TOWER must:
  - (a) include the Eligible Offer in an Offer Document; and
  - (b) take reasonable steps to ensure that any eligible employee to whom the Eligible Offer is made is given a copy of the Offer Document; and
  - (c) provide to ASIC a copy of the Offer Document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- 2. TOWER must comply with any undertaking required to be made in the Offer Document by reason of this instrument; and
- 3. in the case where the Plan may involve the issue of shares in TOWER (including as a result of the exercise of an option) TOWER must take reasonable steps to ensure that the number of shares the subject of the Eligible Offer or to be received on exercise of an option when aggregated with:
  - (a) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and options to acquire unissued shares, under the Plan to be accepted or exercised; and
  - (b) the number of shares in the same class issued during the previous 5 years pursuant to the Plan or any other employee share scheme extended only to eligible employees of TOWER;

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or



(g) an offer made under a disclosure document or Product Disclosure Statement,

must not exceed 5% of the total number of issued shares in that class of TOWER as at the time of the offer; and

- 4. TOWER must take reasonable steps to ensure that:
  - (a) the trustee holds the shares in TOWER on trust for each person (a beneficiary) who acquires units of shares under the Eligible Offer; and
  - (b) the trustee causes proper written financial records to be maintained in respect of the activities of the trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the trustee or a place of business of TOWER during normal business hours or such other time as is agreed with beneficiaries; and
  - (c) the trustee ensures that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and
  - (d) the trustee does not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and
  - (e) except as expressly provided by the trust deed, a beneficiary has the capacity to authorise the trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and
  - (f) the trustee provides a copy of the trust deed to ASIC at the same time as a copy of the Offer Document is provided to ASIC in accordance with this instrument; and
  - (g) the trust deed contains covenants binding the trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the shares to which the units of shares they hold relate as if they were the legal owner of the shares, including the right to:
    - (i) direct the trustee how the voting rights attaching to the shares shall be exercised, either generally or in any particular case; and
    - (ii) receive the income deriving from the shares, including dividends declared by TOWER in respect of those shares.

  - (b) options for the issue or transfer of shares referred to in paragraph (a) where each of the options is offered for no more than nominal consideration; or
  - (c) units of fully-paid shares referred to in paragraph (a).
- 6. *financial product* has the meaning given by section 761A.
- 7. financial product advice has the meaning given by section 766B.
- 8. general advice has the meaning given by section 766B.
- 9. *nominal consideration* means consideration of not more than 1 cent per option.
- 10. offer has a meaning affected by sections 700, 702 and 1010C.



- 11. Offer Document means a document setting out the offer under the Plan that:
  - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan under which the offer is made; and
  - (b) if a summary (rather than a copy) of the rules of the Plan is given includes an undertaking that during the period (the offer period) during which an eligible employee may acquire the financial products offered, TOWER will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
  - (c) specifies in respect of the shares, shares subject to options or units of shares:
    - (i) the acquisition price in Australian dollars; or
    - (ii) where the acquisition price is to be worked out in the future under a formula, the acquisition price in Australian dollars were that formula applied at the date of the offer; and

  - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
    - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate; and
    - (B) where a FFE Fund has been established for the investor no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and
  - (iii) where a FFE Fund has been established for the investor one or more payments into the Fund where:
    - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and

- (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme:
- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme;
- (g) the serviced apartment, hotel, motel or resort complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in Schedule D;
  - (h) the promoter or operator is not aware of any circumstances in which the Act required a Product Disclosure Statement to be given to a person in relation to the scheme and:
    - (i) no Product Disclosure Statement was given to the person; or
    - (ii) a Product Disclosure Statement was given to the person, but the Product Disclosure Statement did not comply with the Act.

#### Schedule C

- 1. The operator must ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution must be held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually.
  - 2. Where a FFE Fund has been established for an investor, the operator must ensure that:
    - (a) the money comprising the Fund is held on trust for the investor in a trust account and subject to audit as to whether the money has been dealt with in accordance with the terms of the trust by a registered company auditor at least annually; and

- 1. Transfer of management rights
  - (a) If a majority of scheme members advise the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme.

  - (b) Unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in paragraph 1(b) of this Schedule if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions.
  - (c) If a majority of body corporate members make a decision referred to in paragraph 2(b) of this Schedule, a majority of scheme members may then at any time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with paragraph 1(b) of this Schedule.
  - (d) This paragraph 2 does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under paragraph 1(b) or 2(c) of this Schedule before that notice is given to the operator.

# 3. Price payable on transfer

The price scheme members specify in a notice under paragraph 1(b) of this Schedule must be one of the following:

- (a) the average of two valuations of the management rights by independent qualified valuers nominated by the Australian Property Institute (or another relevant independent professional body approved by ASIC); or

In this Schedule:

#### 4 Grant of licence

This Licence is granted to LME to operate the financial market that includes the electronic trading system provided by LME (currently known as LME Select).

# 5 Class of financial products

The class of financial products that can be dealt with on the market is derivatives.

# 6 Clearing and settlement arrangements

Clearing and settlement arrangements for transactions effected through the market must be provided by:

- (a) LCH.Clearnet Limited; or
- (b) another clearing and settlement facility approved by the Minister.

# 7 Australian participants to be licensed
