Subclause 30(2) of Schedule 4 - Exemption**

Pursuant to subclause 30(2) of Schedule 4 to the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*), being satisfied that a proposed modification of the constitution of Australian Friendly Society Ltd ACN 087 648 851 (the *Company*) will not result in or allow a modification of the mutual structure of the Company, hereby exempts the Company from clauses 29(1)(f), 29(1)(h), 29(4), 31, 32 and 33 of Part 5 of Schedule 4 of the Act in the case mentioned in Schedule A on the conditions mentioned in Schedule B for so long as those conditions are met.

**SCHEDULE A**

Where the Company is proposing to modify its Constitution in substantially the same terms as the draft amendments that were lodged with ASIC on 26 March 2007.

1. gives all the information that members would reasonably require and expect to be given to make an informed decision about the proposed modification, including but not limited to:
  - (a) how the proposed modification will affect the rights of all classes of members to the assets of the Company on a winding up;
  - (b) the advantages and disadvantages to all classes of members of the proposed modification;
  - (c) any benefits, compensation or incentives members, or a class of members, will receive in relation to the proposed modification;
  - (d) the procedural steps required to implement the proposed modification; and
  - (e) how voting on the proposed modification will take place; and
2. is readily comprehensible to members of the Company.


