Australian Securities and Investments Commission Corporations Act 2001 – Subsection 741(1) – Exemption

Under subsection 741(1) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts Pipe Networks Limited ACN 099 104 122 (*Issuer*), in the case referred to in Schedule A, from Parts 6D.2 and 6D.3 of the Act (other than sections 736 and 738).

 - (v) a registered holder must provide the Issuer on application for the shares with a certification to the effect that the aggregate of the application price for:
 - (A) the shares the subject of the application; and
 - (B) any other shares in the class applied for by the holder under the arrangement or any similar arrangement in the 12 months prior to the application, does not exceed \$10,000.

- (d) The written offer document contains the following information:
 - the method used to calculate the issue price and the time when this price will be determined;
 - (ii) a statement describing the relationship between the issue price and the market price; and

- b. any application for the issue of shares or certification for the purposes of paragraph (c)(v) of Schedule A by, and any issue of shares to, the trustee or nominee, is taken to be an application or certification by, or an issue to, the beneficiary; and
- references to an Issuer offering shares include the Issuer inviting applications for 4. the issue of the shares.

3. Omitting the words "subsections (2) and (3)" in the first sentence in subsection 711(4), and substituting the words "subsections (2), (3) and (3A)".
