**Australian Securities and Investments Commission  
Corporations Act 2001 - Paragraph 601QA(1)(b) - Declaration**

Under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission declares that Part 5C of the Act applies to the person referred to in Schedule A in the case referred to in Schedule B as if paragraph 601GC(1)(a) of the Act were modified or varied by deleting "special resolution of the members of the scheme" and substituting "each and every member of the scheme providing their written consent to the modification, or repeal and replacement".

**Schedule A**

Equity Trustees Limited ACN 004 031 298 (the *Responsible Entity*) in its capacity as responsible entity of Credit Suisse PL100 – World Water Trust ARSN 124 201 074 (the *Scheme*).

**Schedule B**

**Australian Securities and Investments Commission  
Corporations Act 2001 - Paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) - Exemption**

**Disclosure relief**

1. Under paragraph 1020F(1)(a) of the *Corporations Act 2001* (the “Act”) the Australian Securities and Investments Commission (“ASIC”) exempts BP plc (“the Issuer”), a body corporate incorporated under the laws of England, from Part 7.9 of the Act where the Issuer:
  - (a) makes an eligible offer;
  - (b) offers to arrange for the issue of securities under an eligible offer;
  - (c) issues a security under an eligible offer,

that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met.

**Licensing and hawking relief**

2. Under paragraph 911A(2)(l) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that eligible employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice, on the conditions set out in the Schedule and for so long as the conditions are met.
3. Under paragraph 911A(2)(l) of the Act, ASIC exempts:
  - (a) the Issuer or an associate of the Issuer;
  - (b) Mellon Bank N.A. (“Mellon”), a body corporate incorporated under the laws of the United States of America;
  - (c) Morgan Guaranty Trust Company of New York (“Morgan”), a body corporate incorporated under the laws of the United States of America; and
  - (d) Guaranty Nominees Limited, a body corporate incorporated under the laws of England,

from the requirement to hold an Australian financial services licence for the provision of the following financial services on the conditions set out in the Schedule and for so long as the conditions are met:

- (e) the provision of a custodial or depository service under the Depository Agreement in connection with an eligible offer covered by paragraph 1 of

this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and

- (f) dealing in a security in the course of providing a custodial or depositary service covered by paragraph (e); and
  - (g) dealing in a security in connection with an eligible offer covered by paragraph 1 of this instrument where any acquisition by purchase or disposal of the security (by the Issuer or an associate) occurs outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in securities in the relevant place.
4. Under paragraph 992B(1)(a) of the Act, ASIC exempts the Issuer from section 992A in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with an eligible offer covered by paragraph 1 of this instrument, on the conditions set out in the Schedule and for so long as the conditions are met.

#### Schedule

The following conditions apply:

1. the Issuer must:
  - (a) include that offer in an offer document; and
  - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
  - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
2. the Issuer must comply (or, in the case where the Issuer does not have a registered office in this jurisdiction, cause an associated body corporate which does so have a registered office to comply) with any undertaking required to be made in the offer document by reason of this instrument; and
3. the Issuer must take reasonable steps to ensure that the number of ADSs to be issued on vesting of a right to acquire an ADS when aggregated with:
  - (a) the number of ADSs in the same class and the number of shares in the Issuer which would be issued were each outstanding offer with respect to shares, units of shares, options to acquire unissued shares, ADSs and rights to acquire ADSs under an employee share scheme to be accepted or exercised; and
  - (b) the number of ADSs in the same class and the number of shares in the Issuer issued during the previous 5 years pursuant to the Plans or any other employee share scheme extended only to eligible employees of the Issuer;

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
  - (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
  - (e) an offer that did not need disclosure to investors because of section 708; or
  - (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
  - (g) an offer made under a disclosure document or Product Disclosure Statement, must not exceed 5% of the total number of issued ADSs in that class and issued shares of the Issuer as at the time of the offer;
4. in the case where an offer of shares is made through a trust:
- (a) the trustee must hold the shares on trust for each person (a "beneficiary") who acquires units of shares under an eligible offer; and
  - (b) the trustee must cause proper written financial records to be maintained in respect of the activities of the trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the trustee or a place of business of the Issuer during normal business hours or such other time as is agreed with beneficiaries; and
  - (c) the trustee must ensure that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and
  - (d) the trustee must not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and
  - (e) except as expressly provided by the trust deed, a beneficiary must have the capacity to authorise the trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and
  - (f) the trustee must provide a copy of the trust deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and
  - (g) the Issuer must ensure that the trust deed contains covenants binding the trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the shares to which the units of shares they hold relate as if they were the legal owner of the shares, including the right to:
    - (i) direct the trustee how the voting rights attaching to the shares shall be exercised, either generally or in any particular case; and

- (ii) receive the income deriving from the shares, including dividends declared by the Issuer in respect of those shares.

5. the Issuer must take all reasonable steps to ensure that the provisions of the Rules of the Plans are complied with; and
6. the Issuer must take all reasonable steps to ensure that the Plans at all times complies with the laws of England.

*Note:* where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

### Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the Act;
2. an employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of rights made to them under the Plans in favour of their nominee;
3. “American Depository Share” or “ADS” means a unit of a fully paid share in the Issuer;
4. “associated body corporate” of the Issuer means:
  - (a) a body corporate that is a related body corporate of the Issuer; or
  - (b) a body corporate that has voting power in the Issuer of not less than 20%; or
  - (c) a body corporate in which the Issuer has voting power of not less than 20%;
5. “Australian dollar equivalent” in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates;
6. “current market price” means in relation to a share or ADS, the price published by the operator of the principal financial market on which the share or ADS is quoted as the final price for the previous day on which the share or ADS was traded on that financial market;
7. “Depository Agreement” means a depositary agreement between the Issuer, Mellon and Morgan, among other parties, dated 31 December 1998, and as amended from time to time, in relation to the issue of ADSs to which the rights relate;
8. “eligible employee” means, in relation to the Issuer, a person who is at the time of an offer under an employee share scheme, a full or part-time employee or director of the Issuer or of an associated body corporate of the Issuer;
9. “eligible offer” means an offer for the issue, for no more than nominal consideration, of rights to acquire, by way of issue, ADSs, made under the Plans and extended only to eligible employees of the Issuer, where the ADSs have been quoted on the financial market operated by the New York Stock Exchange throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days.


10. “financial product advice” has the meaning given by section 766B;
11. “general advice” has the meaning given by section 766B;
12. “nominal consideration” means consideration of not more than 1 cent per right;
13. “offer” has a meaning affected by sections 700 and 702;
14. “offer document” means a document setting out an offer under the Plans that:
  - (a) includes or is accompanied by a copy, or a summary, of the Rules of the Plans under which the offer is made; and
  - (b) if a summary (rather than a copy) of the Rules of the Plans is given - includes an undertaking that during the period (the “offer period”) during which an eligible employee may acquire the right offered or until rights vest under the Plans, the Issuer (or, in the case where the Issuer does not have a registered office in this jurisdiction, an associated body corporate of the Issuer which does so have a registered office) will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the scheme; and
  - (c) specifies in respect of the ADS to which the rights relate:
    - (i) the acquisition price in Australian dollars;
    - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
    - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
  - (d) includes an undertaking, and an explanation of the way in which, the Issuer (or in the case where the Issuer does not have a registered office in this jurisdiction, an associated body corporate of the Issuer which does so have a registered office) will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
    - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of the ADS; and
    - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
  - (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the Issuer or any associated body corporate of it for the purpose of acquiring ADSs on vesting of the right under the Plans.
15. “Plans” means each of the BP Performance Share Plan, the BP Restricted Share Plan, the BP Medium Term Performance Plan 2005 and the Deferred Annual Bonus Plan 2005, as amended from time to time, under which eligible employees may be offered, among other things, right to acquire, by way of issue, ADSs;

Corporations Act 2001 – Paragraph 741(1)(b) – Declaration**

Under paragraph 741(1)(b) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (**ASIC**) declares that Chapter 6D of the Act applies to the persons in Schedule A in the case in Schedule B as if Chapter 6D were modified or varied as follows:

1. after subsection 710(3), insert the following subsection:

"(4) For the purposes of this section, information about the assets and liabilities, financial position and performance, and profits and losses of the body does not need to be prepared in accordance with the accounting standards."; and
2. after subsection 711(4), insert the following subsection:

"(4A) The prospectus satisfies paragraph 711(3)(b), in relation to a person in paragraph 711(4)(b), if the prospectus sets out the total amount that anyone has paid or agreed to pay, or the nature and value of any benefit anyone has given or agreed to give, to the persons specified in paragraph 711(4)(b).".



Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission exempts, for the avoidance of doubt, I.O.O.F.   3. The responsible entity must ensure that the differential fee arrangement referred to in Schedule B is applied without discrimination to all members of the scheme who satisfy the criteria necessary to receive the benefit of the arrangement.

#### Interpretation

In this instrument:

**Net New Investment** means the number of interests acquired by a member less the number of interests redeemed by the member in the same scheme. Where the number of interests acquired by the member is less than the number of interests redeemed by the member in the same scheme, this is deemed to be nil.

**Offer Period** means the period of time specified in the disclosure document referred to at subparagraph (1)(b) of Schedule C for which the differential fee arrangement remains open.

**Australian Securities and Investments Commission  
Corporations Act 2001 – Paragraph 951B(1)(a) – Exemption**

1. The Australian Securities and Investments Commission (*ASIC*) grants this exemption under paragraph 951B(1)(a) of the *Corporations Act 2001* (*Act*).
2. UBS AG ARBN 088 129 613 (*intermediary*), who is a financial services licensee, does not have to comply with subsections 941A(1) or 941B(1) to the extent that a Financial Services Guide (*intermediary FSG*) that the intermediary must give in relation to the provision of the financial service referred to in paragraph 3:
  - (a) must be given in the way required by section 940C; and
  - (b) must be given at the time required by subsections 941D(1), 941D(2) and 941D(4);
  - (c) must have a title in accordance with subsection 942A(1); and
  - (d) must provide the information required by subsection 941D(3).

**Where relief applies**

3. The exemption in paragraph 2 applies where the intermediary provides a financial service consisting of arranging for the issue of a financial product under an intermediary authorisation and all of the following are satisfied:
  - (a) a prospectus offering MBILS has been lodged by Mariner Bridge Investments Limited ACN 088 267 190 (*product provider*) with ASIC on or about 7 May 2007 (*Prospectus*); and
  - (b) the intermediary FSG forms a separate and clearly identifiable part of the Prospectus; and
  - (c) the expression "Financial Services Guide" appears at or near the front of the part of the Prospectus that is the intermediary FSG; and
  - (d) the Prospectus clearly and prominently discloses the identity of:
    - (i) the person that is to issue the product under the intermediary authorisation; and
    - (ii) the intermediary; and
    - (iii) where the intermediary is an authorised representative — the licensee on whose behalf the intermediary acts in relation to the intermediary authorisation; and
  - (e) the Prospectus clearly and prominently discloses the nature of the relationship between the product provider and:

(i) the intermediary; and

(ii) where the intermediary is an authorised representative — the licensee on whose behalf the intermediary acts in relation to the intermediary authorisation.

### Interpretation

In this instrument:

**MBILS** means fully paid ordinary shares in the product provider known as "Mariner Bridge Investments Limited Securities"; and

**authorised representative** has the meaning given by section 761A of the Act; and

**Financial Services Guide** has the meaning given by section 761A of the Act; and

**intermediary authorisation** means an arrangement between the product provider who is the issuer of the MBILS and the intermediary under which:

- (a) the intermediary, or their authorised representatives, may make offers to people to arrange for the issue, variation or disposal of the MBILS by the product provider; and
- (b) the product provider is to issue, vary or dispose of financial products in accordance with such offers, if they are accepted;

provided that the offer pursuant to which the issue, variation or disposal is made was covered by the intermediary's Australian financial services licence.



Corporations Act 2001 – Paragraph 741(1)(b) - Declaration**

Under paragraph 741(1)(b) of the *Corporations Act 2001* (*Act*) the Australian Securities and Investments Commission declares that Chapter 6D applies to the persons specified in Schedule A in the case specified in Schedule B as if section 707 were modified or varied by omitting subsections 707(3) and (4) and substituting:

- “(3) An offer of a body's securities for sale within 12 months after their issue needs disclosure to investors under this Part if the body issued the securities:
- (a) without disclosure to investors under this Part; and


