#### Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 601QA(1)(a) — Exemption

Under paragraph 601QA(1)(a) of the Corporations Act 2001 (the Act) the Australian Securities and Investments Commission exempts the person specified in Schedule A from subsection 601FC(4) of the Act in the case set out in Schedule B and on the conditions set out in Schedule C.

where the interests in the REIT are traded on the New York Stock Exchange, the American Stock Exchange, the National Association of Securities Dealers Automated Quotation National Market or the Nasdaq Stock Market of the USA.

#### SCHEDULE C

1. The Responsible Entity must, at reasonable intervals, make such enquiries as are reasonably necessary to confirm that the election of the REIT referred to in paragraph 2 of Schedule B has not been terminated or revoked as referred to in that paragraph; and

- 2. Before the investment of scheme property in the REIT, the Responsible Entity must prepare a document signed by an officer of the Responsible Entity or agent explaining why the investment would comply with the Responsible Entity's duties, considering the regulation that applies to the REIT and any other relevant matter; and
- 3. The Responsible Entity must keep the document for 7 years.

    - (B) only votes received by the responsible entity within 28 days after the issue of the voting paper will be counted.
- (e) If a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed."; and

- 3. insert after subsection (2), the following subsections:
  - "(2A) If a postal vote is arranged under paragraph (1A)(c) and at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the proposed responsible entity, that entity is taken for the purposes of subsection (2) to have been chosen by a resolution of members on the last day on which postal votes may be received in order to be counted.
  - (2B) If:
    - (a) a related body corporate is proposed to be the new responsible entity in accordance with subsection (1A); and
    - (b) sufficient members do not ask for a vote to choose the entity in accordance with the notice referred to in paragraph (1A)(b); and
    - (c) the entity has consented in writing to becoming the scheme's responsible entity,
