**Enabling legislation**

1. The Australian Securities and Investments Commission makes the variations set out in this instrument under paragraphs 601QA(1)(a), 911A(2)(1), 992B(1)(a) and 1020F(1)(a) of the *Corporations Act 2001*.

**Title**

2. This instrument is ASIC Class Order [CO 06/468].

**Commencement**

3. This instrument commences on the date of its gazettal.

**Variations***ASIC Class Order [CO 03/1094]*

4. ASIC Class Order [CO 03/1094] is varied by:
  - (a) in the first paragraph omitting “1 July 2006” and substituting “1 July 2008”; and
  - (b) under the heading “**Interpretation**”:
    - (i) omitting subparagraph 6(a) and substituting:

“(a) the Legal Practitioners Fidelity Fund under Part 3.4 of the *Legal Profession Act 2004* of New South Wales;”;

    - (ii) omitting subparagraph 6(b) and substituting:



**Corporations Act 2001 — Paragraph 601QA(1)(a) - Exemption**

Under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission exempts DFA Australia Limited (ACN 065 937 671), as the responsible entity of the registered schemes referred to in Schedule A (the *responsible entity*), from paragraph 601FC(1)(d) of the Act to the extent that it requires the responsible entity to treat members who hold interests of the same class equally, in the case referred to in Schedule B, on the conditions set out in Schedule C and for so long as they are met.

**Schedule A**

1. Dimensional Australian Core Equity Trust (ARSN 120 009 163); and
2. Dimensional Global Core Equity Trust (ARSN 120 009 305); (the *registered schemes*).

**Schedule B**

Where:

- (b) disclosed in a clear, concise and effective manner in every Product Disclosure Statement for interests in the registered scheme that is first issued is amended to provide for the arrangement.
2. The responsible entity must ensure that the arrangement is applied without discrimination to all members who make withdrawal requests that exceed the threshold amount.

**Interpretation**

In this instrument:

*dollars* means Australian dollars;

*income tax legislation* means:

- (a) *Income Tax Assessment Act 1936*; and  
(b) *Income Tax Assessment Act 1997*;

*net assets* means the assets of the scheme less its liabilities;

*net asset value* means the current market value of the net assets of the scheme;

*redemption payment* means the consideration paid by the responsible entity to a withdrawing member in respect of a withdrawal request, calculated in accordance with the registered scheme's constitution; and

*withdrawal entitlement* means an amount, determined in accordance with the constitution of the registered scheme, that is equal to the capital gains less capital losses, calculated under the income tax legislation as in force at the time the withdrawal request is made, resulting from either:

- (a) the disposal of scheme assets; or  
(b) the transfer of scheme assets to the withdrawing member,

for the purpose of making a redemption payment to the withdrawing member as permitted under the constitution of the registered scheme.


