Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 1020F(1)(a) — Exemption

Under paragraph 1020F(1)(a) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission (ASIC) exempts Orchard Property Limited ACN 006 387 435 (the responsible person) as responsible entity of Orchard Industrial Property Fund ARSN 120 121 002 (the Fund) from section 1016B(1) of the Act in relation to the Product Disclosure Statement (the replacement PDS) referred to in the Schedule where:

- (a) the replacement PDS is substantially the same as an earlier Product Disclosure Statement (the *earlier PDS*) in relation to which section 1016E of the Act applies except for any changes that are necessary to correct the deficiency referred to in paragraph 1016E(1)(c) of the Act; and
- (b) any application of subsection 1016B(1) to the responsible person because the earlier PDS was lodged with ASIC has ended.

The Product Disclosure Statement relating to the offer of interests in the Fund lodged by the responsible person with ASIC under subsection 1015B(1) of the Act on 31 May 2007.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(a), 601QA(1)(b) and 655A(1)(b) – Exemption and Declarations

- 1. Under paragraph 601QA(1)(b) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission (ASIC) declares that Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if section 601GAC as notionally inserted into the Act by ASIC Class Order [CO 05/26] were modified or varied as follows:
 - (a) omit subsection 601GAC(2), substitute:
 - "(2) The formula or method must:
 - (a) if it applies when the interests in the scheme are not quoted on a financial market be based on the value of scheme property less any liabilities that under the constitution may be met from that property divided by the number of interests on issue and may make allowance for the expenses that are associated with disposing scheme property; or
 - (b) if it applies when the interests in the scheme are quoted on a financial market be based on the market price of interests on the market and may allow for a discount from or a premium to that price by or up to an amount specified in the constitution."; and
 - (b) after subsection 601GAC(11) insert:
 - "(11A) Subsection (2) applies in relation to an interest that forms part of a stapled security (as defined in subsection 601GAA(13)) as if references to an interest in that subsection included a reference to the stapled security."
- 2. Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if Chapter 5C were modified or varied as follows:
 - (a) omit Part 5C.6; and
 - (b) in paragraph 601GA(4)(b):
 - (i) omit "if the right may be exercised while the scheme is liquid (as defined in section 601KA) "; and
 - (ii) omit "; and", substitute "."; and
 - (c) omit paragraph 601GA(4)(c).
- 3. For the avoidance of doubt, under paragraph 601QA(1)(a) of the Act, ASIC exempts the person specified in Schedule A from the requirement in paragraph 601FC(1)(d) of

the Act to treat members who hold interests of the same class equally to the extent that that requirement might otherwise prevent the responsible entity from conducting the transaction on terms that comply with Schedule B.

- 4. Under paragraph 655A(1)(b) of the Act, ASIC declares that Chapter 6 of the Act applies to the person specified in Schedule A in the case referred to in Schedule B as if the table in section 611 were modified or varied by, after item 19, inserting:
 - "19A An acquisition that results from a buy-back of interests by the responsible entity of a listed managed investment scheme."

 - (i) the date and approximate time at which the buy-back arrangement will commence; and
 - (ii) the approximate number of MCQ stapled securities that MCAML, MCAL and MCAIL intend to acquire under the buy-back arrangement; and
 - (iii) the means by which MCAML, MCAL and MCAIL will fund the acquisition of MCQ stapled securities under the buy-back arrangement; and

- (iv) the amount of money MCAML, MCAL and MCAIL reasonably expects will be available to them for the purpose of acquiring MCQ stapled securities under the buy-back arrangement; and
- (v) that the buy-back arrangement will be conducted in accordance with the listing rules of ASX as in force at the date of this instrument and in the ordinary course of trading on ASX; and
- (vi) that the offer period under the buy-back arrangement will not necessarily remain open for a fixed period of time but may close immediately after MCAML, MCAL and MCAIL has acquired the number of MCQ stapled securities they offered to acquire; and
- (vii) where, immediately before the buy-back arrangement takes place, MCAML, MCAL or MCAIL hold MCQ stapled securities whether MCAML, MCAL or MCAIL intends to sell any MCQ stapled securities they hold under the buy-back arrangement; and
- (viii) that associates of, MCAML, MCAL or MCAIL hold MCQ stapled securities and may sell those MCQ stapled securities to MCAML, MCAL and MCAIL under the buy-back arrangement; and
- (ix) any restrictions that constrain MCAML's, MCAL's or MCAIL's discretion to determine the price they pay for the MCQ stapled securities they acquire on the ASX under the buy-back arrangement; and
- (d) the price at which MCAML, MCAL and MCAIL may acquire MCQ stapled securities under the buy-back arrangement does not exceed 105% of the average market price of interests, calculated over the last 5 days in which interests in the MCQ stapled securities were traded on the ASX before the relevant acquisition; and
- (e) MCAML, MCAL and MCAIL give 14 days written notice to ASIC of the intended buy-back arrangement; and
- (f) within 1 month after the MCQ stapled securities are cancelled, MCAML, MCAL and MCAIL lodge with ASIC a notice that sets out:
 - (i) the number of MCQ stapled securities cancelled; and
 - (ii) any amount paid by MCAML, MCAL or MCAIL (in cash or otherwise) under the buy-back arrangement; and
 - (iii) if MCAML, MCAL or MCAIL have different classes of shares or interests the class to which each cancelled share or interest belonged; and
- (g) MCAML, MCAL and MCAIL comply with all relevant listing rules of ASX as in force at the date of this instrument applicable to the buy-back arrangement; and

(h) the buy-back arrangement does not materially prejudice MCAML's ability to pay creditors of the Trust from the scheme assets or the ability of MCAL and MCAIL to pay their creditors.
