Australian Securities and Investments Commission Corporations Act 2001 – Subsection 741(1) – Declaration

Pursuant to subsection 741(1) of the Corporations Act 2001 ("Act") the Australian Securities and Investments Commission ("ASIC") declares that Chapter 6D of the Act applies to persons specified in Schedule A in the case specified in Schedule B as if section 707 of the Act were modified or varied by:

- 1. omitting subsections 707(3) and (4) and substituting:
 - "(3) An offer of a body's securities for sale within 12 months after their issue needs disclosure to investors under this Part if the body issued the securities:
 - (a) without disclosure to investors under this Part; and
 - (b) with the purpose of the person to whom they were issued:
 - (i) selling or transferring them; or
 - (ii) granting, issuing or transferring interests in, or options or warrants over, them;

and section 708 or 708A does not say otherwise.

- (4) Unless the contrary is proved, a body is taken to issue securities with the purpose referred to in paragraph 3(b) if any of the securities are subsequently sold, or offered for sale, within 12 months after their issue."; and
- 2. inserting the following subsection immediately after subsection 707(4):
 - "(4A) Despite subsection (4), a body will not be taken to have the purpose referred to in paragraph 3(b) merely because the body makes available, or causes to be made available:
 - (a) a facility that allows a participant under a compromise or arrangement under Part 5.1 approved by the Court pursuant to subsection 411(6) to sell all of the body's securities that they receive (or are entitled to receive) under the compromise or arrangement; and
 - (b) the above facility in relation to participants under the compromise or arrangement whose address as shown in the register in which details of their holding is recorded is a place outside Australia and the external Territories.".

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 601QA(1)(a) – Exemption

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 601QA(1)(b) – Declaration

Under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) declares that Chapter 5C of the Act applies to Sydney Roads Management Limited ACN 078 327 983 (*SRML*) in its capacity as responsible entity of Sydney Roads Trust ARSN 119 766 540 (*SRT*) in the case set out in Schedule A as if Chapter 5C were modified or varied as follows:

- 1. omit paragraph 601FC(1)(c), substitute:
 - "(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and their interests as holders of shares in a company, where the interests and shares are components of a stapled security) and, if there is a conflict between the interests of the members and its own interests, give priority to the interests of the members; and"; and
- 2. omit paragraph 601FD(1)(c), substitute:

 - "(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
 - (a) the stapled securities are quoted on:
 - (i) the financial market of ASX; or
 - (ii) an approved foreign exchange;

and the quotation of the stapled securities is not suspended;

- (b) the stapled securities are issued at the current market price as defined in the constitution;
- (c) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;
- (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution;

- (e) any acquisition of interests in the scheme by the responsible entity or an associate of the responsible entity is subject to terms and conditions that would not disadvantage other members of the scheme."; and
- 4. after notional subsection 208(2) of the Act as included in section 601LC insert:
 - "(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if:
 - (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme; or
 - (ii) could endanger the scheme property; and
 - (b) all of the interests in the scheme are components of stapled securities together with all of the shares in a company (stapled company); and
 - (c) the benefit is given by:
 - (i) the responsible entity; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity; and
 - (d) the benefit is given to:
 - (i) the stapled company or an entity wholly owned by it;
 - (ii) an entity wholly owned by the scheme;
 - (iii) a company or scheme of which all of the shares or interests (as applicable) are held by one or more of:
 - (A) the scheme; or
 - (B) the entities referred to in subparagraphs (i) and (ii).
 - (2B) For the purposes of this section:
 - (a) An entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and
 - (b) A reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries."; and
- 5. after section 601PC insert:

"601PD For the purposes of sections 601FC, 601FD and 601LC:

stapled security means two or more financial products including at least one interest in a registered scheme where:

- (a) under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.".

Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 5C of the Act applies to SRML in its capacity as responsible entity of SRT in the case set out in Schedule B as if section 601GAA as notionally inserted into the Act by ASIC Class Order [CO 05/26] were modified or varied as follows:

- 6. in subsection 601GAA(1) omit "subsections (2) to (8)", substitute "subsections (2) to (8A)"; and
- 7. after subsection 601GAA(8) insert:
 - "(8A) The issue price of interests in the scheme is determined by a financial services licensee other than the responsible entity, in accordance with a method under which persons who may acquire interests indicate the price or range of prices, and the quantity of interests they would be willing to acquire at that price or those prices, where:
 - (a) the method is referred to in the constitution; and
 - (b) the manner in which the issue price is determined under that method is consistent with ordinary commercial practice; and
 - (c) the interests are issued at that issue price on or before the date the interests are first quoted on the financial market of ASX."; and
- 8. in subsection 601GAA(9) immediately after the words "and (8)", insert "and (8A)" and in paragraph 601GAA(9)(a) immediately after the words "and (8)(b)", insert "subsection (8A) and paragraph (8A)(c)"; and
- 9. after subsection 601GAA(9A) as notionally inserted into the Act by this instrument, insert:
 - "(9B) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
 - (a) the stapled securities are issued at a price determined in accordance with subsection (8A); and
 - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;

- (c) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution;
- (d) any acquisition of interests in the scheme by the responsible entity or an associate of the responsible entity is subject to terms and conditions that would not disadvantage other members of the scheme.".
