#### Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 655A(1)(b) – Declaration

Under paragraph 655A(1)(b) of the Corporations Act 2001 (Act), the Australian Securities and Investments Commission declares that Chapter 6 of the Act applies to the persons referred to in Schedule A in the case referred to in Schedule B as if section 609 were modified or varied by inserting after subsection 609(2) the following subsections:

"(2A) For the purposes of subsection (2B) and subsection (2C):

**CREST** means the system for paperless settlement of trades and holdings of uncertificated securities administered by CRESTCo Limited in the United Kingdom; and

CREST depository interest means an uncertificated interest in a security.

- (2B) Subsection (2) applies to a person (the *trustee*) who would otherwise have a relevant interest in securities because the trustee holds interests in the securities as the trustee of a trust established pursuant to a deed poll (the *deed poll*) under which CREST depository interests are issued representing the interest of the holder of CREST depository interests in the underlying securities despite:
  - (a) the trustee having any of the following discretions under the terms of the deed poll which give it the power to dispose of, or control the exercise of a power to dispose of the underlying securities to which the depository interests relate:
    - (i) discretions where CREST depository interests are owned directly or beneficially by any person in circumstances where, the opinion of the trustee, the trustee or its custodian might suffer any liability to taxation or pecuniary, fiscal or material regulatory disadvantage which it might not otherwise have suffered; or
    - (ii) discretions where the CREST depository interests are owned directly or beneficially, or otherwise for the benefit of, any person in breach of any law or requirement of any jurisdiction or governmental authority or so as to result in ownership of any underlying securities exceeding any limit under or otherwise infringing any law or constitutive documents; or
    - (iii) discretions where the CREST depository interests are owned directly or beneficially by, or otherwise for the benefit of, any person who fails to furnish to the trustee such proof as to matters of fact (including identity), as the trustee may deem necessary or appropriate under the laws and regulations; or
    - (iv) discretions in relation to the appointment of custodians or subcustodians to procure safe custody of the underlying securities; or
    - (v) discretions where the holder of the CREST depository interest ceases at any time to be, or is suspended in whole or part as, a member of CREST; or

- (vi) discretions where the CREST depository interests cease to be capable of being held in the CREST system; or
- (vii) discretions where the CREST depository interests are held by a person who has failed to duly and punctually perform any obligation to the trustee or its custodian under the deed poll or any other relevant agreement or instrument to which the person is a party in relation to CREST depository interests, if the trustee determines that it is appropriate; or
- (b) the holder of the CREST depository interest not having a presently enforceable or unconditional right of the kind referred to in subsection 608(8) because the exercise of the holder's rights in relation to the securities relies on the actions of one or more trustees, custodians or sub-custodians of the securities, each of whom is restricted under the terms of their appointment from exercising any voting rights attached to or disposing of the underlying securities, other than in accordance with a direction made by or on behalf of the holder of CREST depository interests or the trustee under the deed poll acting in accordance with this subsection;

#### where:

- (c) the trustee holds the securities on trust for the benefit of the holders of the CREST depository interests; and
- (d) if the terms of any of the discretions referred to in paragraph (a) require the trustee to form an opinion or determine that an action is necessary or appropriate, the trustee acts reasonably in forming that opinion or making that determination; and
- (e) if the trustee exercises any of the discretions referred to in paragraph (a), it does so:
  - only for the purposes of satisfying its obligations as trustee of interests in the securities underlying the CREST depository interests; and
  - (ii) on ordinary commercial terms or in an ordinary commercial manner as the case requires; and
- (f) the trustee does not dispose of any securities to its associates as a result of the exercise by the trustee of any of the discretions in paragraph (a).
- (2C) Subsection (2) applies to a person (the *nominee*) who would otherwise have a relevant interest in securities because the nominee holds interests in the securities as trustee under a bare trust on behalf of a trustee within subsection (2B), despite such trustee not having a presently enforceable and unconditional right of the kind referred to in subsection 608(8) because the exercise of the trustee's rights in relation to the securities relies on the actions of one or more trustees, custodians or sub-custodians of the securities, each of whom is restricted under the terms of their appointment from exercising any voting rights attached to or disposing of the underlying securities, other than in accordance with a direction made by or on behalf of the holder of CREST

#### Australian Securities and Investments Commission Corporations Act 2001 - Paragraphs 601QA(1)(a), 741(1)(a), 911A(2)(1), 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) - Exemptions

- 1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the Corporations Act 2001 (the Act) the Australian Securities and Investments Commission (ASIC) exempts the Issuer from:
  - (i) Parts 6D.2 and 6D.3 (except section 736); and
  - (ii) Part 7.9

where the Issuer

- (iv) makes an eligible offer; or
- (v) offers to arrange for the issue, or sale of financial products under an eligible offer; or
- (vi) issues a financial product under an eligible offer,

  - (c) the Plan Company,

from sections 736, 992A and 992AA in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

The following conditions apply:

- the Issuer must ensure that the eligible offer is substantially on the terms for the Plan as set out in attachments to email from Kelly & Co Lawyers to ASIC dated 8 June 2007, and 12 June 2007, being a letter, and a copy of the draft rules of the Plan respectively; and

- 6. *contribution plan* means a plan under which a participating eligible employee may save money by regular deductions from wages or salary (including

through salary sacrifice arrangements) towards paying for shares offered for issue or sale under an employee share scheme where the terms and conditions of the contribution plan include terms and conditions to the effect that:

- (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application which is used in respect of the offer, or on a form which is included in or accompanies the offer document; and
- (b) before transferring contributions to acquire shares, any contributions made by an employee as part of the contribution plan must be held by the Issuer in trust for the employee in an account of an Australian ADI which is established and kept by the Issuer only for the purpose of depositing contribution moneys and other money paid by employees for the shares on offer under the employee share scheme; and
- (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election is made all money deposited with the Australian ADI in relation to that employee, including any accumulated interest must be paid to that employee; and
- 7. current market price means, in relation to a share, the price published by the operator of the principal financial market on which the share is quoted as the final price for the previous day on which the share was traded on that financial market; and
- 8. *eligible employee* means a person who is, at the time of an eligible offer, a full or part-time employee or director of the Company or of an associated body corporate of the Company; and
- 9. eligible offer means an offer for the issue, sale or transfer of fully- paid shares in the same class as shares which have been quoted on the financial market operated by the ASX Limited (ACN 008 624 691) throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period made under the Plan; and
- 10. financial product advice has the meaning given by section 766B; and
- 11. general advice has the meaning given by section 766B; and
- 12. Issuer means the Company; and
- 13. offer has a meaning affected by sections 700, 702, and 1010C; and
- 14. offer document means a document setting out an offer under the Plan that:
  - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and
  - (b) if a summary (rather than a copy) of the rules of the Plan is given includes an undertaking that during the period (the *offer period*) during

which an eligible employee may acquire the financial products offered under the Plan, the Issuer (or, in the case of an issuer that does not have a registered office in this jurisdiction, an associated body corporate of the issuer that does so have a registered office) will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and

- (c) specifies in respect of the shares:
  - (i) the acquisition price in Australian dollars; or

- 17. *rules of the Plan* means the written terms of the Plan as at the date of this instrument provided to ASIC as an attachment to the electronic mail from Kelly & Co Lawyers to ASIC dated 8 June 2007 and 12 June 2007, being a letter, and a copy of the draft rules of the Plan respectively; and

#### Commencement

This instrument commences on the date of its gazettal.

#### Disclosure relief

- 1. Under paragraphs 283GA(1)(a), 741(1)(a) and 1020F(1)(a) of the Corporations Act 2001 (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts the issuer or the trustee from:
  - (a) Parts 2L.1, 2L.2, 2L.3, 2L.4 and 2L.5; and
  - (b) Parts 6D.2 and 6D.3 (except section 736); and
  - (c) Part 7.9,

where the issuer or the trustee:

- (d) makes an eligible offer;
- (e) offers to arrange for the issue of financial products under an eligible offer;
- (f) issues a financial product under an eligible offer,

that involves a contribution plan but does not involve the issuer or any associated body corporate offering any eligible employee of the issuer a loan or similar financial assistance for the purpose of, or in connection with, the acquisition of financial products to which the offer relates, on the conditions set out in the Schedule and for so long as the conditions are met.

- 2. Under paragraph 1020F(1)(b) ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 where:
  - (a) a recommendation is made (by a person other than the issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
  - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
- 3. For the avoidance of doubt, under paragraph 601QA(1)(a) ASIC exempts the trustee which operates a managed investment scheme only by reason of operating a contribution plan relating to an eligible offer to which paragraph 1 relates from section 601ED in relation to the operation of that managed investment scheme.

#### Licensing and hawking relief

- 4. Under paragraph 911A(2)(1) ASIC exempts the issuer or the trustee who is exempt from Part 6D.2 or Part 7.9 because of the exemption in paragraph 1 (other than because the person made a recommendation to acquire financial products) from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer referred to in that exemption (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 5. Under paragraph 911A(2)(1) ASIC exempts:
  - (a) the issuer which is exempt from Part 6D.2 or Part 7.9 because of the exemption in paragraph 1; and
  - (b) any associate of the issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depository service in connection with an eligible offer covered by the exemption in paragraph 1 where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by the exemption in paragraph 1 where any acquisition by purchase or disposal of the product (by the issuer or an associate) occurs either:
  - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
  - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place; and
- (f) in the case where the exemption in paragraph 3 applies dealing in an interest in a managed investment scheme that is exempt from section 601ED because of that paragraph.
- 6. Under paragraphs 741(1)(a) and 992B(1)(a) ASIC exempts the issuer or the trustee who is exempt from Part 6D.2 or Part 7.9 because of the exemption in paragraph 1 from sections 736, 992A and 992AA in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

#### Schedule

  - (b) the number of shares in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the issuer;

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the Corporate Law Economic Reform Program Act 1999; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement, must not exceed 5% of the total number of issued shares in that class of the issuer as at the time of the offer; and

- 4. (a) the trustee must hold the shares on trust for each person (a "beneficiary") who acquires units of shares under an eligible offer; and
  - (b) the trustee must cause proper written financial records to be maintained in respect of the activities of the trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the trustee or a place of business of the issuer during normal business hours or such other time as is agreed with beneficiaries; and
  - (c) the trustee must ensure that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and
  - (d) the trustee must not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and
  - (e) except as expressly provided by the trust deed, a beneficiary must have the capacity to authorise the trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and
  - (f) the trustee must provide a copy of the trust deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and
  - (g) the issuer must ensure that the trust deed contains covenants binding the trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the shares to which the units of shares they hold relate as if they were the legal owner of the shares, including the right to:
    - (i) direct the trustee how the voting rights attaching to the shares shall be exercised, either generally or in any particular case; and
    - (ii) receive the income deriving from the shares, including dividends declared by the issuer in respect of those shares.

- 6. "current market price" means in relation to a share, the price published by the operator of the principal financial market on which the share is quoted as the final price for the previous day on which the share was traded on that financial market;
- 7. "eligible employee" means, in relation to an issuer, a person who is at the time of an offer under an employee share scheme, a full or part-time employee or director of the issuer or of an associated body corporate of the issuer;
- 8. "eligible offer" means an offer to issue to an eligible employee a financial product that is:
  - (a) a fully-paid share in an issuer in the same class as shares which have been quoted on the financial market operated by Australian Stock Exchange Limited throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period; or
  - (b) a unit of a fully-paid share referred to in paragraph (a), or
  - (c) a right to receive a fully-paid share referred to in paragraph (a), or
  - (d) a right to receive a unit referred to in paragraph (b), or
  - (e) a right to participate in the contribution plan, made under an employee share scheme extended only to eligible employees of the issuer;
- 9. "financial product advice" has the meaning given by section 766B;
- 10. "general advice" has the meaning given by section 766B;

- 11. "Employee Share Save Plan" means an arrangement that falls within the terms of a proposed arrangement described, by the same name, in a letter dated 18 April 2007 from the issuer to ASIC;
- 12. "issuer" means National Australia Bank Limited ACN 004 044 937;
- 13. "offer" has a meaning affected by sections 700, 702 and 1010C;
- 14. "offer document" means a document setting out an offer under an employee share scheme that:
  - (a) includes or is accompanied by a copy, or a summary, of the rules of the scheme under which the offer is made; and
  - (b) if a summary (rather than a copy) of the rules of the scheme is given includes an undertaking that during the period (the "offer period") during which an eligible employee may acquire the financial products offered or exercise options acquired under the scheme, the issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the scheme; and
  - (c) specifies in respect of the shares or units of shares:
    - (i) the acquisition price in Australian dollars; or
    - (ii) where the acquisition price is to be worked out in the future under a formula, details of that formula; and
  - (d) includes an undertaking, and an explanation of the way in which, the issuer will, during the offer period, within a reasonable period of the employee requesting, make available to the employee the current market price of shares in the same class as those offered or to which the units relate; and
  - (e) specifies:
    - (i) the Australian ADI where contributions for the purposes of the contribution plan are held;
    - (ii) the length of time they may be held; and
    - (iii) the rate of interest payable (if any) on the contributions held in the account; and

- (iv) the procedure by which an employee may elect to discontinue their participation in the contribution plan including an explanation of the matters outlined in paragraph 5(c) of this Interpretation division;
- 15. "trustee" means the trustee operating or administering the contribution plan being either National Australia Trustees Ltd ACN 007 350 405 or another company appointed by the issuer;
- 16. "unit" in relation to a share means a legal or equitable right or interest in the share.
