#### Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a) and 1020F(1)(a) – Revocation and Exemptions

- 1. Under paragraphs 741(1)(a), 911A(2)(l) and 1020F(1)(a) of the *Corporations Act* 2001 (the *Act*), the Australian Securities and Investments Commission (*ASIC*) revokes ASIC Instrument 07/0638 dated 1 August 2007.
- 2. Under paragraphs 741(1)(a) and 1020F(1)(a) of the Act ASIC exempts the persons referred to in Schedule A from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the person:
  - (a) makes an eligible offer; or
  - (b) offers to arrange for the issue of financial products under an eligible offer; or
  - (c) issues a financial product under an eligible offer, on the conditions set out in Schedule B and for so long as the conditions are met.
- 3. Under paragraph 911A(2)(l) of the Act ASIC exempts the persons referred to in Schedule A who are exempt from Part 6D.2 or Part 7.9 because of paragraph 2 of this instrument from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer referred to that paragraph (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 4. Under paragraph 911A(2)(1) of the Act ASIC exempts:
  - (a) the persons referred to in Schedule A who are exempt from Part 6D.2 or Part 7.9 because of paragraph 2 of this instrument; and
  - (b) a related body corporate of those persons,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depositary service in connection with an eligible offer covered by paragraph 2 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (d) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by paragraph 2 of this instrument where any acquisition by purchase or disposal of the product (by OSL or a related body corporate of OSL) occurs either:
  - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or

- (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act ASIC exempts the persons referred to in Schedule A who are exempt from Part 6D.2 because of the paragraph 2 of this instrument from sections 736 and 992A in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

#### Schedule A

Oil Search Limited ARBN 055 079 868 (OSL) and CPU Share Plans Pty Limited ACN 081 600 875 (the Trustee)

#### Schedule B

The following conditions apply:

- 1. the person making the offer must:
  - (a) include that offer in an offer document; and
  - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
  - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- 2. OSL must comply with any undertaking required to be made in the offer document by reason of this instrument; and
- 3. in the case where the Plan involves the issue of shares, OSL must take reasonable steps to ensure that the number of shares the subject of the offer when aggregated with:
  - (a) the number of shares in the same class that would be issued were each outstanding offer with respect to shares and units of shares, under an employee share scheme to be accepted or exercised; and
  - (b) the number of shares in the same class issued during the previous 5 years under the Plan or any other employee share scheme extended only to eligible employees of OSL;

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
- (e) an offer that did not need disclosure to investors because of section 708; or

- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement, must not exceed 5% of the total number of issued shares in that class of OSL as at the time of the offer; and
- 4. in the case where an offer of shares is made through a trust:
  - (a) the Trustee must hold the shares on trust for each person (a *beneficiary*) who acquires units of shares under an eligible offer; and
  - (b) the Trustee must cause proper written financial records to be maintained in respect of the activities of the trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the Trustee or a place of business of OSL during normal business hours or such other time as is agreed with beneficiaries; and
  - (c) the Trustee must ensure that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and
  - (d) the Trustee must not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and
  - (e) except as expressly provided by the trust deed, a beneficiary must have the capacity to authorise the Trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and
  - (f) the Trustee must provide a copy of the trust deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and
  - (g) OSL must ensure that the trust deed contains covenants binding the Trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the shares to which the units of shares they hold relate as if they were the legal owner of the shares, including the right to:
    - (i) direct the trustee how the voting rights attaching to the shares shall be exercised, either generally or in any particular case, but, where the shares are allocated to the beneficiary under a Retention Award or a Short Term Incentive Award, only after the shares have vested in the beneficiary, which must be not more than three years from the date of acquisition of the shares; and
    - (ii) receive the income deriving from the shares, including dividends declared by OSL in respect of those shares, but, where the shares are allocated to the beneficiary under a Retention Award or a Short Term Incentive Award, only after the shares have vested in the beneficiary, which must be not more than three years from the date of acquisition of the shares.

#### Interpretation

In this instrument:

- 1. except where otherwise stated, references to provisions are to provisions of the Act; and
- 2. the Plan shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the Plan in favour of their nominee; and
- 3. associated body corporate of OSL means:
  - (a) a body corporate that is a related body corporate of OSL; or
  - (b) a body corporate that has voting power in OSL of not less than 20%; or
  - (c) a body corporate in which OSL has voting power of not less than 20%;
- 4. Australian dollar equivalent in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates; and
- 5. *current market price* means in relation to a share, the price published by the operator of the principal financial market on which the share is quoted as the final price for the previous day on which the share was traded on that financial market; and
- 6. *eligible employee* means, in relation to OSL, a person who is at the time of an offer under the Plan, a full or part-time employee or director of OSL or of an associated body corporate of OSL; and
- 7. *eligible offer* means an offer for issue or sale of:
  - (a) fully-paid shares in OSL in the same class as shares which have been quoted on the financial market operated by ASX Limited ACN 008 624 691 throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period; or
  - (b) units of fully-paid shares referred to in paragraph (a), made under the Plan extended only to eligible employees of OSL; and
- 8. *financial product advice* has the meaning given by section 766B; and
- 9. **general advice** has the meaning given by section 766B; and
- 10. offer has a meaning affected by sections 700, 702 and 1010C; and
- 11. *offer document* means a document setting out an offer under an employee share scheme that:
  - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and
  - (b) if a summary (rather than a copy) of the rules of the Plan is given includes an undertaking that during the period (the *offer period*) during which an eligible employee may acquire the financial products offered or exercise options acquired under the Plan, OSL will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
  - (c) specifies in respect of the shares or units of shares:

- (i) the acquisition price in Australian dollars; or
- (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
- (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
- (d) includes an undertaking, and an explanation of the way in which, OSL will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
  - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of shares in the same class as those offered or to which the units relate; and
  - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
- (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by OSL or any associated body corporate of it for the purpose of acquiring financial products under the Plan; and
- 12. **Plan** means the Oil Search Restricted Shares Plan, by whatever name it is known from time to time provided that the terms of the Plan are substantially similar to the terms of the Plan as at the date of this instrument; and
- 13. **Retention Award** means an allocation of shares and an issue of units in those shares to an eligible employee under the Plan that is identified in the rules of the Plan as a Retention Award; and
- 14. **Short Term Incentive Deferral Award** means an allocation of shares and an issue of units in those shares to an eligible employee under the Plan that is identified in the rules of the Plan as a Short Term Incentive Deferral Award; and
- 15. *unit* in relation to a share means a legal or equitable right or interest in the share.

# Australian Securities and Investments Commission Output Outp

Under paragraph 741(1)(b) of the Corporations Act 2001 ("Act") the Australian Securities and Investments Commission ("ASIC") declares that Chapter 6D of the Act applies to the person named in Schedule A as if section 708A of the Act were modified by inserting after the word "issued" in subparagraph 5(b) the words:

", not including a suspension that:

- (i) is required by the market operator under the rules of the prescribed financial market; and
- (ii) relates to a significant change to the nature or scale of activities of the body's activities under the rules of the prescribed financial market; and
- (iii) is lifted following compliance by the body of the rules of the prescribed financial market for admission to the official list of the prescribed financial market."

A person holding a share in Citadel Resource Group Limited ACN 009 727 959 that was issued pursuant to an offer made to investors on or about 27 March 2008 where, but for subsection 708(8) of the Act, disclosure would have been required by subsection 707(1) of the Act.

#### Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 926A(2)(b), 992B(1)(b) and 1020F(1)(b) — Exemption

#### **Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 926A(2)(b), 992B(1)(b) and 1020F(1)(b) of the *Corporations Act 2001* (the *Act*).

#### Exemption

- 2. This exemption applies to an interest in a managed investment scheme (serviced strata scheme) which involves an owner (investor) of real property (strata unit), in the investor's discretion, making their strata unit available for use by a person (operator) as part of a serviced apartment, hotel, motel or resort complex located at Strata Plan 52051, formerly Lots 4421 and 5116 Yallingup Beach Road, Yallingup, Western Australia developed in accordance with an approval from the Shire of Busselton that was provided to ASIC on 4 February 2008 and in relation to which, on 1 March 2000, there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme.
- 3. An interest in the serviced strata scheme is exempt from the following provisions of the Act:
  - (a) Part 7.6 (other than Divisions 4 and 8); and
  - (b) section 992AA; and
  - (c) section 1017F.

#### Where exemption applies

- 4. The exemption in paragraph 3 only applies where all of the following requirements are satisfied:
  - (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;
  - (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:

- (i) by a person other than the operator or an associate of the operator; and
- (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;
- (c) each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
- (d) the operator is licensed in relation to the conduct of the letting services under the law of a State or Territory or is a financial services licensee;
- (e) no payment is liable to be made by an investor to participate in the scheme other than:
  - (i) payment of money to buy the strata unit; and
  - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
    - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate; and
    - (B) where a FFE Fund has been established for the investor no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and
  - (iii) where a FFE Fund has been established for the investor one or more payments into the Fund where:
    - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and
  - (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;

- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme;
- (g) the serviced apartment, hotel, motel or resort complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in paragraph 5;
- (h) the operator takes reasonable steps to ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution is held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
- (i) where a FFE Fund has been established for an investor, the operator takes reasonable steps to ensure that:
  - (A) the money comprising the Fund is held on trust for the investor in a trust account and subject to audit as to whether the money has been dealt with in accordance with the terms of the trust by a registered company auditor at least annually: and
  - (B) the balance of the Fund is promptly returned to the investor at the termination of the scheme or upon the investor's withdrawal from the scheme, whichever occurs first:
- (j) each person that is involved in making an offer of interests in the scheme for issue does not engage in any misleading or deceptive conduct or conduct that is likely to mislead or deceive in connection with those offers;
- (k) the operator complies with the provisions specified in paragraph 5 which are included in the agreement referred to in subparagraph (g).

#### Terms of agreement between investor and operator

- 5. The agreement specified in subparagraph 4(g) is to contain provisions to the following effect:
  - (a) Transfer of management rights
- (i) If a majority of scheme members advise the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer

the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme; and

- (ii) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice; and
- (iii) A transfer referred to in subparagraph (i) or (ii) must be done as soon as practicable, but if there is a body corporate for the real property to which the scheme relates, there must be a reasonable time for members of the body corporate to consider whether to make a decision referred to in subparagraph (b)(ii) unless the body corporate has consented to the transfer; and
- (b) Consent of body corporate to new care-taking arrangements
  - (i) If an operator receives a notice under subparagraph (a)(i), the operator must advise all body corporate members of the name of the person to whom the transfer is to be made; and
    - (ii) Unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in subparagraph (a)(ii) if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions; and
    - (iii) If a majority of body corporate members make a decision referred to in subparagraph (b)(ii), a majority of scheme members may then at any time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with subparagraph (a)(ii); and
    - (iv) This subparagraph does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under subparagraph (a)(ii) or (b)(iii) before that notice is given to the operator; and

#### (c) Price payable on transfer

The price scheme members specify in a notice under subparagraph (b)(ii) must be one of the following:

- (i) the average of two valuations of the management rights by independent qualified valuers nominated by the Australian Property Institute (or another relevant independent professional body approved by ASIC); or
  - (ii) the highest bona fide bid for the management rights (excluding a bid by the operator or its associates) at an auction of which at least 60 days' notice had been given; or
  - (iii) the highest bona fide amount tendered (excluding any tender by the operator or its associates) for the management rights following reasonable efforts to market the property for at least 60 days; and

#### (d) Voting

- (i) In determining if there is a majority of scheme members or body corporate members, the operator and its associates and any person nominated as a replacement operator and associates of that person must not be counted; and
  - (ii) For scheme members, a majority is based on their entitlement to vote at body corporate meetings if there is a body corporate for the property to which the scheme relates, and otherwise each member shall have one vote; and
  - (iii) For body corporate members, a majority is based on their entitlement to vote at body corporate meetings; and
  - (iv) A scheme member or a body corporate member makes a decision by signing a document that sets out the decision;
     and

#### (e) Costs

(i) Any member may arrange a valuation or auction of, or may market, the management rights before or after the expiration of the 9 month period referred to in subparagraph (a)(i) for the purposes of determining a price to be specified in a notice under subparagraph (a)(ii); and

(ii) If a member incurs any reasonable valuation, auction or marketing costs under subparagraph (i) that member is entitled to be reimbursed out of the price payable by any person nominated by the members as transferee of the management rights when the price is paid to the operator; and

#### (f) Assistance

The operator must give reasonable assistance to enable the transferee to operate the resort, hotel, motel or serviced apartment complex including making available information concerning any prospective bookings; and


#### (g) Definitions

In this paragraph:

scheme members means investors in the scheme excluding the operator and its associates.

management rights means all real or personal property (including contractual rights) held by the operator or any of its associates that facilitates the operation of the scheme.

*transfer* in relation to management rights means to assign or transfer the management rights or to cause another person to become the holder of those rights or rights substantially the same as those rights.



#### Interpretation

#### 6. In this instrument:

FFE Fund means a fund established for an investor consisting of money paid by the investor and any interest accrued on that money, to be used from time to time in accordance with the written agreement referred to in subparagraph 4(g) for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit made available by the investor for use as part of the scheme.

offer is to be interpreted in accordance with subsection 1010C(2) of the Act.

# Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 741(1)(b) and 1020F(1)(a) – Declaration and Exemption

- 1. Under subsection 741(1)(b) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) declares that Chapter 6D of the Act applies to shareholders of the Company in the case specified in the Schedule as if subsections 707(3) and (4) were omitted.
- 2. Under paragraph 1020F(1)(a) of the Act, ASIC exempts members of the Trust in the case specified in the Schedule from subsections 1012C(6) and (7) of the Act.

#### Schedule

#### Where:

- 1. an offer to sell a stapled security is made; and
- 2. the stapled securities are acquired by subscription or purchased on-market by the Plan Trustee and subsequently transferred to a Relevant Employee in accordance with the terms of the Valad Employee Security Ownership Plan (Exempt); and
- 3. the stapled securities are issued without disclosure to investors under Part 6D.2 or without a Product Disclosure Statement being prepared in the circumstances because the Company and the Responsible Entity relied on ASIC Class Order [CO 03/184]; and
- 4. the Company and the Responsible Entity did not issue the stapled securities with the purpose of the Relevant Employee selling or transferring the stapled securities, or granting, issuing or transferring interests in, or options or warrants over, the stapled securities:
  - (a) within 3 years of the Relevant Employee receiving the stapled securities; or
  - (b) the date the Relevant Employee is no longer employed by the Company or a related body corporate of the Company.

#### Interpretation

#### In this instrument:

- 1. Company means Valad Funds Management Limited ACN 102 249 294; and
- 2. *Plan Trustee* means Valad LTIP Nominee Pty Ltd ACN 104 096 773, as the Plan Trustee under the Valad Employee Security Ownership Plan (Exempt); and
- 3. *Relevant Employee* means a full-time or part-time employee and director of the Company or a related body corporate of the Company; and

- 4. *Responsible Entity* means Valad Commercial Management Limited ACN 101 802 046 in its capacity as the responsible entity of the Trust; and
- 5. *stapled security* means a share in the Company and an interest in the Trust which, under the terms on which each is to be traded, must be transferred together; and
- 6. *subscription* means an offer to acquire a specified number of unissued shares in the Company; and
- 7. Trust means Valad Property Trust ARSN 102 618 824; and
- 8. Valad Employee Security Ownership Plan (Exempt) means an employee share scheme that is known by that name as at the date of this instrument, where the terms of the scheme are substantially on the terms as set out in the General Terms of the Valad Employee Security Ownership Plan (Exempt) dated on or around 13 March 2008; and
- 9. *Valad Employee Security Ownership Plan (Exempt) Trust* means a trust established by the Company under the Valad Employee Security Ownership Plan (Exempt) Trust Deed dated on or around 13 March 2008.

#### Australian Securities and Investments Commission Corporations Act 2001 - Paragraphs 655A(1)(b) and 673(1)(b) — Revocation and Declarations

- 1. Under paragraph 655A(1)(b) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) revokes ASIC Instrument [08/0116] dated 20 February 2008.
- 2. Under paragraphs 655A(1)(b) and 673(1)(b) of the Act, ASIC declares that Chapters 6 and 6C of the Act applies to the persons referred to in Schedule A in the case referred to in Schedule B as if section 609 of the Act were modified or varied by inserting after subsection 609(6) the following subsections:
  - "(6A) A person does not have a relevant interest in securities merely because the person is a trustee who would otherwise have a relevant interest in securities as the trustee of a trust established pursuant to a trust deed under which units of securities (*eligible units*) are issued or made available for the purpose of satisfying rights or obligations of the holder of eligible units despite:
