Australian Securities and Investments Commission Corporations Act 2001 — Section 283GA — Declaration

 - (b) the requirement to hold an Australian financial services licence for the provision of financial services by Woolworths in relation to a facility (gift facility) through which, or through the acquisition of which, a person makes non-cash payments for goods or services.

- 1. Betfair is authorised to conduct a betting exchange under a Gaming Licence.
- 2. Betfair is the sole counterparty to all bets offered or accepted by clients who are in this jurisdiction.

 - (c) information about any significant risks associated with the Betfair Facility;
 - (d) information about the procedures for dealing with any unauthorised or mistaken transactions relating to the Betfair Facility; and
 - (e) fees or charges for acquiring and using the Betfair Facility and, where any such fees or charges are subject to change during the life of the Betfair Facility, a statement of how the client may get information about the new fees or charges;
- 2. Where the Betfair Facility is held by a person before this instrument takes effect, Betfair must comply with the requirements of paragraph 1 of this Schedule as soon as reasonably practicable.



- 3. The disclosure document is worded and presented in a clear, concise and effective manner;
- 4. A convenient means is available, that involves no charge by Betfair or its associates, for the client to do all of the following:
 - (a) check the amount standing to the credit of the Betfair Facility; and
 - (b) obtain at reasonable intervals a record of the past 10 transactions (or such lesser number of transactions that have occurred) under the Betfair Facility;
- 5. If the terms and conditions of the Betfair Facility are unilaterally varied, or the fees or charges for using the Betfair Facility are changed during the life of the Betfair Facility:
 - (a) a statement setting out the effect of the variation or change is displayed in a clear and prominent notice on Betfair's website;
 - (b) information about the variation or change is made available to the client in accordance with the statement in paragraph 1(a);
 - (c) the new terms and conditions or fees and charges are made available to the client are displayed in a clear and prominent notice on Betfair's website; and
 - (d) if Betfair makes available information about the Betfair Facility on an Internet website — the statement in paragraph 4(a), information about the variation or change, and the new terms and conditions or fees and charges are made available on Betfair's website in a manner reasonably likely to come to the attention of persons seeking information about the Betfair Facility; and

- (b) holds at least one-half of the issued share capital of Betfair.

makes non-cash payments has the meaning given by section 763D.

offer has a meaning affected by subsection 1010C(2) of the Act.
