Australian Securities and Investments Commission 0 6 / 0 6 3 5 Corporations Act 2001 – Paragraph 1020F(1)(c) – Declaration

Under paragraph 1020F(1)(c) of the Corporations Act 2001 (the Act) the Australian Securities and Investments Commission declares that Part 7.9 applies in relation to the persons specified in Schedule A in the case specified in Schedule B as if section 1012C were modified or varied by omitting subsections 1012C(6) and (7) and substituting the following subsections:

- "(6) This subsection covers the circumstances in which:
 - (a) an offer is made within 12 months after the issue of the financial product; and
 - (b) the product was issued without a Product Disclosure Statement (*PDS*) for the product being prepared; and
 - (c) the issuer issued the product with the purpose of the person to whom it was issued selling or transferring the product, or granting, issuing or transferring interests in, or options or warrants over, the product.

Under paragraphs 926A(2)(a) and 951B(1)(a) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission exempts St George Bank Limited ABN 92 055 513 070 (St George) from Parts 7.6 (other than Divisions 4 and 8) and 7.7 of the Act for dealing in and giving financial product advice in relation to a factoring arrangement on the conditions referred to in the Schedule for so long as the conditions are met.

Schedule

St George must:

- ensure that the terms and conditions of the factoring arrangement are given in writing to each retail client to whom the factoring arrangement is issued before the arrangement is issued; and
- 2. establish and maintain an internal dispute resolution system that complies with the Australian Standard on *Customer satisfaction Guidelines for complaints handling in organizations* (AS ISO 100002-2006) that covers complaints made by retail clients against the person in connection with the factoring arrangement.

Interpretation

factoring arrangement means an arrangement (within the meaning of section 761A of the Act) under which a person acquires debt obligations, such as receivables, at a discount.

financial product advice has the meaning given by section 766B of the Act.

retail client has the meaning given by section 761G of the Act.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 911A(2)(1) — Exemption

Under paragraph 911A(2)(l) of the Corporations Act 2001 ("the Act") the Australian Securities and Investments Commission ("ASIC") exempts DBS Vickers Research (Singapore) Pte Ltd ("DBSVR"), a body corporate incorporated in Singapore, from the requirement to hold an Australian financial services licence in the case referred to in Schedule A.

Schedule A

Where:

- 1. DBSVR provides financial product advice (the "financial services") in this jurisdiction to wholesale clients in respect of any of the following financial products:
 - (a) derivatives;
 - (b) foreign exchange contracts;
 - (c) securities;
 - (d) debentures, stocks or bonds issued by a government;
 - (e) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act;
 - (f) managed investment products; and
- 2. DBSVR has a current financial adviser's licence; and
- 3. DBSVR:
 - (a) is registered under Division 2 of Part 5B.2 of the Act; or
 - (b) has not failed for more than the last 10 business days to have an Agent; and
- 4. DBSVR's primary business is the provision of financial services; and
- 5. Neither DBSVR nor its Agent has been notified by ASIC that DBSVR is excluded from relying on this instrument; and
- 6. If DBSVR becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule B:
 - (a) 15 business days have not passed since DBSVR became so aware or should reasonably have become so aware without DBSVR providing full particulars of the failure to ASIC (to the extent that DBSVR knows those particulars or would have known them if it had undertaken reasonable enquiries); and

- (b) 30 business days have not passed from ASIC receiving those particulars from DBSVR without ASIC notifying DBSVR that it may continue to rely on this instrument; and
- 7. DBSVR has not notified ASIC that it will not rely on this instrument; and
- 8. DBSVR has provided ASIC with:
 - (a) a copy of the financial adviser's licence granted to it by MAS;
 - (b) a notice that it will provide the financial services in this jurisdiction in reliance on this instrument;
 - (c) a deed of DBSVR for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that DBSVR may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - (i) the deed is irrevocable except with the prior written consent of ASIC;
 - (ii) DBSVR submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise;
 - (iii) DBSVR covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
 - (iv) if DBSVR is not registered under Division 2 of Part 5B.2 of the Act, service of process on DBSVR in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
 - (v) DBSVR covenants that, on written request of either MAS or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist MAS to disclose to ASIC and ASIC to disclose to MAS any information or document that MAS or ASIC has that relates to DBSVR; and
 - (d) written consents to the disclosure by MAS to ASIC and ASIC to MAS of any information or document that MAS or ASIC has that relates to DBSVR. The consents must be in such form (if any) as ASIC specifies in writing.

Schedule B

1. DBSVR must provide the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the Singaporean regulatory requirements if the financial services were provided in Singapore in like circumstances.

2. DBSVR must:

- (a) notify ASIC, as soon as practicable and in such form if any as ASIC may from time to time specify in writing, of the details of:
 - (i) each significant change to, including the termination of, the financial adviser's licence of DBSVR relevant to the financial services DBSVR provides or intends to provide in this jurisdiction; and
 - (ii) each significant particular exemption or other relief which DBSVR may obtain from the Singaporean regulatory requirements relevant to the financial services DBSVR provides or intends to provide in this jurisdiction; and
- (b) notify ASIC by 31 March and 30 September of each year in such form if any as ASIC may from time to time specify in writing:
 - (i) either:
 - (A) of the details of each significant change (a "notifiable regulatory change") to the Singaporean regulatory requirements (including in the power or authority of MAS to supervise, monitor or procure compliance by DBSVR with the Singaporean regulatory requirements with respect to the provision of the financial services) in the 6 months (the notification period) ending on the 15th day of the month by the end of which the notification is required that is relevant to the financial services DBSVR provides or intends to provide in this jurisdiction and is not a change that ASIC has stated in writing is not required to be notified for the purpose of this instrument; or
 - (B) where there have been no notifiable regulatory changes—that there have been no notifiable regulatory changes; and
 - (ii) either:
 - (A) of the details of each enforcement or disciplinary action (a *notifiable regulatory action*) taken by MAS or any other overseas regulatory authority against DBSVR during the notification period; or
 - (B) where there have been no notifiable regulatory actions that there have been no notifiable regulatory actions; and
- (c) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction as a wholesale client (before the financial services are provided) containing prominent statements to the following effect:
 - (i) DBSVR is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
 - (ii) DBSVR is regulated by MAS under Singaporean laws, which differ from Australian laws.

financial services law has the meaning given by section 761A of the Act.

foreign exchange contract has the meaning given by section 761A of the Act.

MAS means the Monetary Authority of Singapore.

notice and notified mean, respectively, written notice and notified in writing.

overseas regulatory authority means a foreign regulatory authority (other than MAS) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body.
