**Australian Securities and Investments Commission**  
**Corporations Act 2001 - Paragraphs 741(1)(a) and 911A(2)(l) -Exemption**

**Disclosure relief**

1. Under paragraph 741(1)(a) of the *Corporations Act 2001* (the "Act") the Australian Securities and Investments Commission ("ASIC") exempts BP plc ("the Issuer"), a body corporate incorporated under the laws of England, from Parts 6D.2 and 6D.3 (except section 736) where the Issuer:
  - (a) makes an eligible offer;
  - (b) offers to arrange for the issue of securities under an eligible offer;
  - (c) issues a security under an eligible offer,that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met.

**Licensing and hawking relief**

2. Under paragraph 911A(2)(l) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that eligible employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice, on the conditions set out in the Schedule and for so long as the conditions are met.
3. Under paragraph 911A(2)(l) of the Act, ASIC exempts:
  - (a) the Issuer or an associate of the Issuer;
  - (b) Mellon Bank N.A. ("Mellon"), a body corporate incorporated under the laws of the United States of America;
  - (c) Morgan Guaranty Trust Company of New York ("Morgan"), a body corporate incorporated under the laws of the United States of America; and
  - (d) Guaranty Nominees Limited, a body corporate incorporated under the laws of England,from the requirement to hold an Australian financial services licence for the provision of the following financial services on the conditions set out in the Schedule and for so long as the conditions are met:
  - (e) the provision of a custodial or depositary service under the Depositary Agreement in connection with an eligible offer covered by paragraph 1 of

- this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (f) dealing in a security in the course of providing a custodial or depositary service covered by paragraph (e); and
  - (g) dealing in a security in connection with an eligible offer covered by paragraph 1 of this instrument where any acquisition by purchase or disposal of the security (by the Issuer or an associate) occurs outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in securities in the relevant place.
4. Under paragraph 741(1)(a) of the Act, ASIC exempts the Issuer from section 736 in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with an eligible offer covered by paragraph 1 of this instrument, on the conditions set out in the Schedule and for so long as the conditions are met.

#### Schedule

The following conditions apply:

1. the Issuer must:
  - (a) include that offer in an offer document; and
  - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
  - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
2. the Issuer must comply (or, in the case where the Issuer does not have a registered office in this jurisdiction, cause an associated body corporate which does so have a registered office to comply) with any undertaking required to be made in the offer document by reason of this instrument; and
3. the Issuer must take reasonable steps to ensure that the number of ADSs to be issued on exercise of an option to acquire an ADS when aggregated with:
  - (a) the number of ADSs in the same class and the number of shares in the Issuer which would be issued were each outstanding offer with respect to shares, units of shares, options to acquire unissued shares, ADSs and options to acquire ADSs under an employee share scheme to be accepted or exercised; and
  - (b) the number of ADSs in the same class and the number of shares in the Issuer issued during the previous 5 years pursuant to the Plan or any other employee share scheme extended only to eligible employees of the Issuer;

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
  - (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
  - (e) an offer that did not need disclosure to investors because of section 708; or
  - (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
  - (g) an offer made under a disclosure document or Product Disclosure Statement, must not exceed 5% of the total number of issued ADSs in that class and issued shares of the Issuer as at the time of the offer;
4. in the case where an offer of shares is made through a trust:
- (a) the trustee must hold the shares on trust for each person (a “beneficiary”) who acquires units of shares under an eligible offer; and
  - (b) the trustee must cause proper written financial records to be maintained in respect of the activities of the trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the trustee or a place of business of the Issuer during normal business hours or such other time as is agreed with beneficiaries; and
  - (c) the trustee must ensure that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and
  - (d) the trustee must not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and
  - (e) except as expressly provided by the trust deed, a beneficiary must have the capacity to authorise the trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and
  - (f) the trustee must provide a copy of the trust deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and
  - (g) the Issuer must ensure that the trust deed contains covenants binding the trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the shares to which the units of shares they hold relate as if they were the legal owner of the shares, including the right to:
    - (i) direct the trustee how the voting rights attaching to the shares shall be exercised, either generally or in any particular case; and
-

- (ii) receive the income deriving from the shares, including dividends declared by the Issuer in respect of those shares.
5. the Issuer must take all reasonable steps to ensure that the provisions of the Rules of the Plan are complied with; and
6. the Issuer must take all reasonable steps to ensure that the Plan at all times complies with the laws of England.

*Note:* where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

### Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the Act;
2. an employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of options made to them under the Plan in favour of their nominee;
3. "American Depository Share" or "ADS" means a unit of a fully paid share in the Issuer;
4. "associated body corporate" of the Issuer means:
  - (a) a body corporate that is a related body corporate of the Issuer; or
  - (b) a body corporate that has voting power in the Issuer of not less than 20%; or
  - (c) a body corporate in which the Issuer has voting power of not less than 20%;
5. "Australian dollar equivalent" in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates;
6. "current market price" means in relation to a share or ADS, the price published by the operator of the principal financial market on which the share or ADS is quoted as the final price for the previous day on which the share or ADS was traded on that financial market;
7. "Depository Agreement" means a depository agreement between the Issuer, Mellon and Morgan, among other parties, dated 31 December 1998, and as amended from time to time, in relation to the issue of ADSs to which the options relate;
8. "eligible employee" means, in relation to the Issuer, a person who is at the time of an offer under an employee share scheme, a full or part-time employee or director of the Issuer or of an associated body corporate of the Issuer;
9. "eligible offer" means an offer for the issue, for no more than nominal consideration, of options to acquire, by way of issue, ADSs, made under the Plan and extended only to eligible employees of the Issuer, where the ADSs have been quoted on the financial market operated by the New York Stock Exchange throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days.

10. "financial product advice" has the meaning given by section 766B;
  11. "general advice" has the meaning given by section 766B;
  12. "nominal consideration" means consideration of not more than 1 cent per option;
  13. "offer" has a meaning affected by sections 700 and 702;
  14. "offer document" means a document setting out an offer under the Plan that:
    - (a) includes or is accompanied by a copy, or a summary, of the Rules of the Plan under which the offer is made; and
    - (b) if a summary (rather than a copy) of the Rules of the Plan is given - includes an undertaking that during the period (the "offer period") during which an eligible employee may acquire the options offered or exercise options acquired under the Plan, the Issuer (or, in the case where the Issuer does not have a registered office in this jurisdiction, an associated body corporate of the Issuer which does so have a registered office) will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the scheme; and
    - (c) specifies in respect of the ADS to which the options relate:
      - (i) the acquisition price in Australian dollars;
      - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
      - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
    - (d) includes an undertaking, and an explanation of the way in which, the Issuer (or in the case where the Issuer does not have a registered office in this jurisdiction, an associated body corporate of the Issuer which does so have a registered office) will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
      - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of the ADS; and
      - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
    - (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the Issuer or any associated body corporate of it for the purpose of acquiring ADSs on exercise of the option under the Plan.
  15. "Plan" means the BP Share Option Plan, as amended from time to time, under which eligible employees may be offered, among other things, options to acquire, by way of issue, ADSs;

16. "Rules" means the rules of the Plan included with or accompanying the offer document;
17. "unit" in relation to a share means a legal or equitable right or interest in the share.



1. Under paragraphs 601QA(1)(a), 911A(2)(l) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts Wentworth Bridgewater Pty Ltd ACN 118 033 373 (the *operator*) in the case referred to in Schedule A from:
  - (a) compliance with section 601ED of the Act;

**Exemption**

Harrison Lovegrove (Australia) Limited ACN 106 717 971 (*Harrison Lovegrove*) does not have to comply with subsection 911A(1) of the Act to the extent it is required to hold an Australian financial services licence to deal in a financial product where the dealing is, is part of, or is incidental to, an *asset transaction*.

**Interpretation**

In this instrument:

*Asset transaction* means a transaction where all the shares in a body corporate that holds petroleum assets are purchased, sold or transferred for the purpose of the acquisition or disposal of that body corporate's petroleum assets.

*Dealing* has the meaning given by section 766C of the Act.

*Petroleum* means any naturally occurring hydrocarbon, whether in a gaseous or liquid state.



Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts Macquarie Goodman (NZ) Limited (*MGNZ*), a New Zealand Corporation having company number 1467292 as manager of the Macquarie Goodman Property Trust (*MGPT*), from subsection 911A(1) of the Act in the case referred to in Schedule A on the conditions specified in Schedule B for so long as they are met.

**Schedule A**

Providing financial product advice or dealing in units in the MGPT where:

- (i) the financial services relate to the distribution reinvestment plan for the MGPT; and
- (ii) the financial services are only provided to 12 persons or less in Australia that are wholesale clients in terms of section 761G of the Act.

**Schedule B**

1. The financial services are provided by MGNZ in Australia only to wholesale clients.
  2. The financial services are provided by MGNZ in accordance with the requirements of the New Zealand Unit Trusts Act 1960 (*Unit Trusts Act*), the New Zealand Securities Act (1978) (*Securities Act*), the New Zealand Securities Commission (*NZSC*), the Listing Rules of New Zealand Exchange Limited (*NZX Listing Rules*) and any other applicable requirements of New Zealand law relating to the financial services.
  3. MGPT continues to be regulated by NZSC and listed on the New Zealand Stock Exchange (*NZX*).
  4. The NZSC requirements, including the Unit Trusts Act and the Securities Act, and NZX Listing Rules and any other applicable requirements of New Zealand law relating to the financial services do not materially change.
  5. MGNZ notifies ASIC of:
    - (i) any significant changes to the general NZSC regulatory regime of New Zealand relevant to the financial services;
    - (ii) any enforcement or disciplinary activity against MGNZ or MGPT in a foreign jurisdiction, including any events in New Zealand leading to disciplinary or enforcement action by the NZSC or NZX against MGNZ or MGPT;
    - (iii) any significant exemption or other relief which MGNZ or MGPT may obtain from the New Zealand regulatory requirements.
  6. MGNZ discloses to any wholesale client to whom the financial services are provided in Australia that:

- (i) MGNZ is exempt from the requirement to hold an Australian financial services licence in respect of the financial services and that MGNZ has the benefit of this relief; and
- (ii) the financial services are regulated by NZSC and NZX and that the rules set by those organisations differ from the Australian regulatory regime;

- (i) submits to the non-exclusive jurisdiction of the Australian courts;
- (ii) complies with any order of an Australian court in respect of the financial services;
- (iii) provides ASIC with:

    - (E) the body covenants that, on written request of either NZSC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist NZSC to disclose to ASIC and ASIC to disclose to NZSC any information or document that NZSC or ASIC has that relates to the body; and
  - (b) written consent to the disclosure by NZSC to ASIC and ASIC to NZSC of any information or document that NZSC or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.


