CORPORATIONS ACT 2001

Subsection 601AA(4)

The notice of the proposed deregistration of **PABX SERVICES PTY LTD ACN 094 089 264** published in **ASIC Gazette 32/07** dated 14 August 2007 was published in error.

No application has been made under subsection 601AA(1) for PABX SERVICES PTY LTD to be deregistered

Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(b) and 655A(1)(b) –Declarations

- 1. Under paragraph 601QA(1)(b) of the Corporations Act 2001 (the Act), the Australian Securities and Investments Commission (ASIC) declares that Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if section 601GAC as notionally inserted into the Act by ASIC Class Order [CO 05/26] were modified or varied as follows:
- (a) omit subsection 601GAC(2), substitute:
 - "(2) The formula or method must:
 - (a) if it applies when the interests in the scheme are not quoted on a financial market be based on the value of scheme property less any liabilities that under the constitution may be met from that property divided by the number of interests on issue and may make allowance for the expenses that are associated with disposing scheme property; or
 - (b) if it applies when the interests in the scheme are quoted on a financial market be based on the market price of interests on the market and may allow for a discount from or a premium to that price by or up to an amount specified in the constitution."; and
- (b) after subsection 601GAC(11) insert:
 - "(11A) Subsection (2) applies in relation to an interest that forms part of a stapled security (as defined in subsection 601GAA(13)) as if references to an interest in that subsection included a reference to the stapled security."
- 2. Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if Chapter 5C were modified or varied as follows:
 - (a) omit Part 5C.6; and
 - (b) in paragraph 601GA(4)(b):
 - (i) omit "if the right may be exercised while the scheme is liquid (as defined in section 601KA) "; and
 - (ii) omit "; and", substitute "."; and
 - (c) omit paragraph 601GA(4)(c).

3. Under paragraph 655A(1)(b) of the Act, ASIC declares that Chapter 6 of the Act applies to the person specified in Schedule A in the case referred to in Schedule B as if the table in section 611 were modified or varied by, after item 19, inserting:

"19A An acquisition that results from a buy-back of interests by the responsible entity of a listed managed investment scheme."

- (c) MIIML and MIGIL cancel all MIG stapled securities they acquire under the extended buy-back arrangement as soon as practicable after they are acquired; and
- (d) at least 14 days before the extended buy-back arrangement commences, MIIML and MIGIL give written notice to the ASX of the following matters:
 - (i) the date and approximate time at which the extended buy-back arrangement will commence; and
 - (ii) the approximate number of MIG stapled securities that MIIML and MIGIL intend to acquire under the extended buy-back arrangement; and

- (v) that the extended buy-back arrangement will be conducted in accordance with the listing rules of ASX as in force at the date of this instrument and in the ordinary course of trading on ASX; and
- (vi) that the offer period under the extended buy-back arrangement will not necessarily remain open for a fixed period of time but may close immediately after MIIML and MIGIL have acquired the number of MIG stapled securities they offered to acquire; and
- (vii) where, immediately before the extended buy-back arrangement takes place, MIIML or MIGIL hold MIG stapled securities whether MIIML or MIGIL intend to sell any MIG stapled securities they hold under the extended buy-back arrangement; and
- (viii) that associates of MIIML and MIGIL hold MIG stapled securities and may sell those MIG stapled securities to MIIML and MIGIL under the extended buyback arrangement; and
- (ix) any restrictions that constrain MIIML's or MIGIL's discretion to determine the price they pay for the MIG stapled securities they acquire on the ASX under the extended buy-back arrangement; and
- that the extended buy-back arrangement is a continuation of the original buyback arrangement and expires on or before the first anniversary of the date of this instrument; and
- (xi) that the maximum price at which the remaining MIG stapled securities may be bought back under the extended buy-back arrangement is not subject to the net asset backing price ceiling referred to in subparagraph (d)(i) of Schedule B of ASIC Instrument [06/707] dated 24 August 2006 that applied to the original buy-back arrangement; and
- (e) the price at which MIIML and MIGIL may acquire MIG stapled securities under the extended buy-back arrangement does not exceed 105% of the average market price of MIG stapled securities, calculated over the last 5 days in which MIG stapled securities were traded on the ASX; and
- (f) within 1 month after the MIG stapled securities are cancelled, MIIML and MIGIL lodge with ASIC a notice that sets out:
 - (i) the number of MIG stapled securities cancelled; and
 - (ii) any amount paid by MIIML or MIGIL (in cash or otherwise) under the extended buy-back arrangement; and

- (iii) if the stapled schemes or MIGIL have different classes of interests or shares the class to which each cancelled interest or share belonged; and
- (g) MIIML and MIGIL comply with all relevant listing rules of ASX as in force at the date of this instrument applicable to the extended buy-back arrangement; and
- (h) the extended buy-back arrangement does not materially prejudice MIIML's ability to pay creditors of the stapled schemes from the schemes' assets or MIGIL's ability to pay its creditors; and
