## Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 601QA(1)(a), 673(1)(a) and 1020F(1)(a) – Exemptions

- 1. For the avoidance of doubt, under paragraph 601QA(1)(a) of the Corporations Act 2001 (Act) the Australian Securities and Investments Commission (ASIC) exempts until 1 October 2007, the persons specified in Schedule A (other than at paragraph (a)) from Chapter 5C of the Act in relation to the operation of the Sale Facility in the case referred to in Schedule B.
- 2. For the avoidance of doubt, under paragraph 1020F(1)(a) of the Act, ASIC exempts until 1 October 2007, the persons specified in Schedule A (other than at paragraph (a)) from Part 7.9 of the Act in relation to any offers to issue, offers to arrange for the issue or the issue of interests in the Sale Facility in the case referred to in Schedule B.
- 3. Under paragraph 673(1)(a) of the Act, ASIC exempts the persons' specified in paragraphs (a), (k) and (l) of Schedule A and each of those persons associates from section 671B of the Act in relation to:
  - (a) the acquisition specified in Schedule C; and
  - (b) the disposals of the Securities under the terms of the Sales Facility,

on condition that if at 9.30am on the fifth Business Day after the Record Date the Broker has a relevant interest in more than 5% of any class of Securities, the Broker then complies with section 671B in relation to that relevant interest.

For the purpose of this condition, treat the Broker as no longer having a relevant interest in a Security if the Broker has agreed to sell the Security under a contract which is subject to no conditions which would not be implied into an open contract entered into on a financial market operated by ASX Limited, other than a condition postponing settlement until completion of the acquisition referred to in Schedule C.

**BBI EPS** means an exchangeable preference share issued by BBI EPS Limited ACN 125 830 631.

**BBI Stapled Security** means an ordinary share in BBIL and an interest in BBIT (being an ordinary unit) which must, on the terms on which they are traded, only be transferred together.

**BBP Stapled Security** means an ordinary share in BBPL and an interest in BBPT (being an ordinary unit) which must, on the terms on which they are traded, only be transferred together.

**BBW Stapled Security** means an ordinary share in BBWP, an ordinary share in BBWPB and an interest BBWPT which must, on the terms on which they are traded, only be transferred together.

Business Day means a day other than a Saturday, Sunday or public holiday, on which banks are open for business in Sydney.

Cash Out Shareholder means each person or persons who, according to the Alinta Share Register as at the Record Date:

- (a) has a registered address outside Australia or its external territories, Hong Kong, New Zealand, or the United Kingdom;
- (b) holds 1000 or fewer Alinta Shares; or
- (c) has a holding of Alinta Shares as at the Record Date who elects for the maximum cash consideration under the Scheme and would receive an Unmarketable Parcel as part of that consideration;

Invitation means an invitation to a Cash Out Shareholder to participate in the Sale Facility.

**Record Date** means the date for determining entitlements to consideration for Alinta Shares under the Scheme, being in or around August 2007.

Sale Facility means a facility where Cash Out Shareholders will be able to elect or are deemed to have elected to sell or dispose of their Securities in the manner set out in the Invitation.

Scheme means an arrangement under Part 5.1 of the Act and detailed in the scheme booklet lodged with ASIC on 2 July 2007 between Alinta and the holders of Alinta Shares whereby BidCo will acquire all Alinta Shares.

Securities means each of the BBI Stapled Securities, the BBP Stapled Securities, the BBW Stapled Securities, the BBI EPS and the APA Group Stapled Securities.

*Unmarketable Parcel* means a parcel of Securities that is not a "marketable parcel" as defined under section 2 of the ASX Market Rules.

### Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 601QA(1)(a) — Exemption

Under paragraph 601QA(1)(a) of the Corporations Act 2001 (Act), for the avoidance of doubt, the Australian Securities and Investments Commission exempts DFA Australia Limited ACN 065 937 671 (responsible entity), as the responsible entity of Dimensional Global Real Estate Trust ARSN 126 933 131 (the registered scheme), from paragraph 601FC(1)(d) of the Act to the extent that it requires the responsible entity to treat members who hold interests of the same class equally, in the case referred to in Schedule A, on the conditions set out in Schedule B and for so long as they are met.

### Where:

- (a) a member of a registered scheme (the *withdrawing member*) makes a withdrawal from the scheme, and either:

Under paragraph 655A(1)(a) of the Corporations Act 2001 (Act) the Australian Securities and Investments Commission (ASIC) exempts the persons specified in Schedule A from section 606 of the Act in respect of the acquisition specified in Schedule B on the conditions specified in Schedule C.

### Schedule B

An acquisition arising solely from the entry by Toga, Rodiv, Barana, Parsley and Vicaroma (collectively, *Joint Bidders*) into a joint bidding agreement (*Agreement*), for the purposes of:

- (a) Vicaroma proposing to acquire all issued interests it does not already own in Australian Hotel Fund ARSN 092 971 518 (*AHO*) by means of a takeover bid under Chapter 6 of the Act (*Joint Bid*); and
- (b) the Joint Bidders undertaking to each other, for the term of the Agreement, that neither of them nor any of their respective associates will, without prior written consent of the other parties to the Agreement, dispose of or otherwise deal with their respective AHO interests.

### where:

- (c) the Agreement is substantially in the form of the draft agreement provided to ASIC on 7 August 2007;
- (d) as a result of the satisfaction of the condition precedent to the Agreement:
  - (i) Toga's voting power in AHO will increase from 18.45% to 44.31%;
  - (ii) Rodiv's voting power in AHO will increase from 5.99% to 44.31%;
  - (iii) Barana's voting power in AHO will increase from 14.21% to 44.31%;
  - (iv) Parsley's voting power in AHO will increase from 5.66% to 44.31%; and
  - (v) Vicaroma's voting power in AHO will increase from 0% to 44.31%.

### Schedule C

1. Vicaroma subjects the Joint Bid to a defeating condition that, during or at the end of the offer period, Vicaroma has received valid acceptance for not less than 50.1% of the bid class securities that Vicaroma offers to acquire under the

offer, not being securities in which Vicaroma has voting power at the beginning of the offer period, and the bidder's statement in respect of the Joint Bid states the defeating condition will not be waived.

- 2. The Joint Bidders each accept any rival takeover bid (*Rival Bid*) for all the issued units in AHO:
  - (i) if the consideration offered under the Rival Bid is more than 105% of the value of the consideration offered under the Joint Bid (as assessed by ASIC if the consideration offered under the Rival Bid is other than cash or is a combination of cash and other-than-cash consideration); and
  - (ii) where the Rival Bid has become unconditional except for prescribed occurrence conditions;

unless the Joint Bid is varied so that the value of the consideration offered is at least equal to the value of the consideration offered under the Rival bid.

- 3. The Joint Bidders use their best endeavours to have AHO engage an independent expert to prepare a report on whether the Joint Bid is fair and reasonable to holders of AHO interests not associates of the Joint Bidders.
- 4. The Joint Bidders immediately terminate the Agreement if the Joint Bid:
  - (i) does not proceed; or
  - (ii) fails because a defeating condition has neither been satisfied nor waived.

Corporations Act 2001 - Subsection 655A(1) – Revocation, Exemption and Declaration

Under paragraph 655A(1)(a) of the Corporations Act 2001 (Act), the Australian Securities and Investments Commission (ASIC) revokes ASIC instrument [07/0438] dated 1 June 2007.

And under paragraph 655A(1)(a) of the Act, ASIC exempts until 2 August 2009 the persons specified in Schedule A from section 606 of the Act in the case specified in Schedule B on the conditions specified in Schedule C.

And under paragraph 655A(1)(b) of the Act, ASIC declares that, until 2 August 2009, Chapter 6 of the Act applies to the persons specified in Schedule A in the case specified in Schedule D as if item 9 of section 611 of the Act were modified to disregard relevant interests acquired and increases in voting power exempted from section 606 of the Act by the operation of the exemption in this instrument.

### Schedule A

Colonial First State Investments Limited ACN 002 348 352 (CFS) and CFS's related bodies corporate (CBA Group).

### Schedule B

Acquisitions of relevant interests in voting shares or voting interests, or increases in voting power, where such acquisitions or increases occur in the following circumstances:

- 1. One or more entity in the CBA Group manage an index fund (individually, a *CBA Index Fund*) over one or a combination of the:
  - (a) S&P/ASX 100;
  - (b) S&P/ASX 200; or
  - (c) S&P/ASX 300

indices (or their successors).

- 2. The voting shares or voting interests are held by or for the benefit of the CBA Index Fund;
- 3. The CBA Index Fund has an objective of maintaining a less than 0.5% per annum tracking error, and such objective is stated in the investment mandate or offer documents for the relevant fund;

### Schedule C

- 1. The CBA Index Fund maintains systems and processes giving a reasonable assurance that a portfolio tracking error of less than 0.5% per annum for the CBA Index Fund will be maintained;
- 2. A CBA Index Fund's relevant interest in voting shares or interests is never more than 5% over the company or scheme's index weighting in a relevant index;
- 3. On or about 2 September 2007, 2 March 2008, 2 September 2008 and 2 March 2009, CFS provides ASIC a written report by an independent third party (agreed to in writing by ASIC), concerning a review by the independent third party, completed no earlier than 14 days before the report is provided to ASIC, as to the systems and processes of each CBA Index Fund for compliance with paragraphs 1 and 2 of this Schedule C.
- 4. No entity in the CBA Group exercises a right to vote attached to voting shares or interests held by a CBA Index Fund unless and to the extent that voting rights are exercised in accordance with specific instructions received from a client of the relevant CBA Index Fund, where such instructions are permitted by the relevant CBA Index Fund mandate and the client is not an

associate of an entity in CBA Group and an entity in the CBA Group does not have the power to exercise, or control the exercise of, the direction.

- 5. On or about 1 July 2009 CFS provides ASIC with a written report on the practical operation of this exemption, including without limitation where a CBA Index Fund acquires a relevant interest in voting shares or voting interests or increases its voting power in a body or listed registered scheme which would contravene s606 but for the relief in this instrument, details of:
  - (a) the relevant voting shares or voting interests;
  - (b) the maximum relevant interest in the voting securities or voting interests and the maximum voting power in the body or listed registered scheme acquired; and
  - (c) the period during which the CBA Index Fund relied on the relief in this instrument in relation to the relevant voting shares or voting interests.

### Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 601QA(1)(a), 911A(2)(l), 926A(2)(b), 992B(1)(a), 992B(1)(b), 1020F(1)(a) and 1020F(1)(b) — Revocation and Exemption

### **Enabling legislation**

- 1. Under paragraphs 601QA(1)(a), 911(2)(l), 992B(1)(a), 1020F(1)(a) of the *Corporations Act 2001* (the Act) the Australian Securities and Investments Commission (ASIC) revokes ASIC instrument [05/0296].
- 2. ASIC makes this instrument under paragraphs 926A(2)(b), 992B(1)(b) and 1020F(1)(b) of the Act.
- 3. This exemption applies to an interest in a managed investment scheme ("serviced strata scheme") which involves an owner ("investor") of real property ("strata unit"), in the investor's discretion, making their strata unit available for use as part of a serviced apartment, hotel, motel or resort complex, being Lot 2 on Deposited Plan 45279, and being the whole of the land in certificate of title volume 2595 folio 285 located at Smith's Beach Road, Yallingup, Western Australia developed in accordance with an approval of a local government organisation that has been given to ASIC and in relation to which, on 1 March 2000, there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme.
- 4. An interest in the serviced strata scheme is exempt from the following provisions of the Act:
  - (a) Part 7.6 (other than Divisions 4 and 8); and
  - (b) Section 992AA; and
  - (c) Section 1017F.

### Where exemption applies

- 5. The exemption in paragraph 4 only applies where all of the following requirements are satisfied:
  - (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;
  - (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:
    - (i) by a person other than the operator or an associate of the operator; and

- (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;
- each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
