Australian Securities and Investments Commission Corporations Act 2001 — Subsection 655A(1) — Exemption

Pursuant to subsection 655A(1) of the Corporations Act 2001 ("Act") the Australian Securities and Investments Commission ("ASIC") hereby exempts the person specified in Schedule A in the case referred to in Schedule B from the provisions of Chapter 6 of the Act set out in Schedule C (but only to the extent set out in that Schedule) on the conditions set out in Schedule D and for so long as they are met.

SCHEDULE A

Principal Real Estate Investors (Australia) Limited ABN 47 102 488 077 as responsible entity for Principal America Office Trust ARSN 089 822 211 (together, the "target")

SCHEDULE B

Where a supplementary target's statement in relation to a target's statement (the "original target's statement") is lodged by the target with ASIC under paragraph 647(3)(a) of the Act in relation to an off-market takeover bid by Macquarie Office Management Limited ABN 75 006 765 206 as responsible entity for Macquarie Office Trust ARSN 093 016 838, before:

- (a) the time when the original target's statement is sent to any holder of securities the subject of the bid; and
- (b) the latest time allowed by the Act for sending the original target's statement to holders of securities the subject of the bid.

SCHEDULE C

- 1. Item 12 of the table in subsection 633(1) of the Act to the extent that it would require a target to send the original target's statement lodged with ASIC to the persons specified in item 12 of the table in subsection 633(1) of the Act; and
- 2. paragraph 647(3)(c) of the Act to the extent that it would require a target to send the supplementary statement to all holders of securities the subject of the bid who have not accepted an offer under the bid.

SCHEDULE D

- 1. The target lodges with ASIC and sends to the bidder and to the operator of each prescribed financial market on which the target's securities are quoted by no later than 12 noon on 23 August 2004:
 - (a) a replacement target's statement; and

- (b) a copy of that replacement target's statement marked to show all changes from the original target's statement.
- 2. The target sends the replacement target's statement to all persons to whom it would have been required, by item 12 of the table in subsection 633(1) of the Act, to send the original target's statement.
- 3. The target satisfies condition 2:
 - (a) no earlier than the day on which the target sends the replacement target's statement to the bidder; and
 - (b) no later than 15 days after the target received a notice that all offers have been sent as required by item 6 of the table in subsection 633(1) of the Act.
- 4. The target dates the replacement target's statement with the day on which it lodges the replacement target's statement.
- 5. The target in the replacement target's statement:
 - (a) explains that the replacement target's statement replaces the original target's statement; and
 - (b) gives the date that the original target's statement was lodged.

Interpretation

In this instrument "replacement target's statement" means a target's statement that incorporates all the substantive information in an original target's statement and in each supplementary target's statement that was lodged in relation to the original target's statement before, or at the same time as, the time when the replacement target's statement is lodged.

1 Name of Licence

This Licence is the Australian Market Licence (Australia Pacific Exchange Limited) 2004.

2 Commencement

This Licence commences when it is granted.

3 Definitions

In this Licence:

acquisition means the acquisition by APX from Paragon Asset Management Limited (ACN 010 338 324) (*Paragon*) of all the assets that were required by Paragon to carry on markets in securities.

Act means the Corporations Act 2001.

APX means Australia Pacific Exchange Limited (ACN 080 399 220).

capital raising means the acquisition of \$400 000 in capital by APX in addition to the funds raised by APX under the reconstruction.

Division 3 arrangements has the meaning given by section 880B of the Act.

Section 4

fidelity fund has the meaning given by section 880B of the Act.

Note Section 880B has been modified in relation to a licensed market by regulation 7.5.01A of the *Corporations Regulations 2001*.

reconstruction means:

- (a) the reconstruction, comprising the share split, buy-back, share acquisition and rights issue, approved at a meeting of shareholders of APX held on 28 November 2001; and
- (b) the amendment to the constitution of APX approved at a meeting of shareholders of APX held on 10 May 2004.

Note I A number of expressions used in this Licence are defined in section 9 of the Act, including ASIC.

Note 2 Expressions used in this Licence and in Chapter 7 of the Act, including Australian financial services licence, licensed market, managed investment product, participant and security have the same meaning as in Chapter 7 of the Act. For the definitions of these expressions, see section 761A of the Act.

4 Grant of licence

This Licence is granted to APX to operate the financial market to be established by APX through which members of the public can, through participants acting on their behalf, trade securities and managed investment products.

5 Classes of financial products

The classes of financial products that can be dealt with on the market are:

- (a) securities; and
- (b) managed investment products.

6 APX to operate market only in certain circumstances

APX may operate the market only if all of the following occur within 6 months from the date of this Licence:

- (a) the reconstruction is completed;
- (b) the acquisition is completed;
- (c) the capital raising is completed;
- (d) APX has given confirmation in writing to ASIC that the matters mentioned in paragraphs (a) to (c) have occurred;
- (e) 14 days have passed since APX has given the confirmation mentioned in paragraph (d).

7 Clearing and settlement arrangements

(1) APX must, following the execution of a transaction on the market, notify each party to the transaction of the identity of the other party to the transaction.

Section 12

(2) APX must have operating rules for the market that provide for transactions effected through the market to be settled by the parties to the transaction.

8 Compensation arrangements

- (1) The minimum amount of cover required for APX's Division 3 arrangements is \$750 000.
- (2) APX must maintain a fidelity fund as the source of funds for its Division 3 arrangements.

9 Participants to be licensed

APX must require each participant in the market to hold an Australian financial services licence that permits trade in the products offered on the market, unless the participant is exempt under Australian law from the requirement to hold such a licence in relation to participation in the market.

10 Disclosure to clients

APX must require each participant to give to a client, before accepting the first order from the client to deal on the market, a written statement that describes the market and the risks of trading on the market.

11 Reporting

- (1) APX must, within 14 days after the end of each quarter occurring during the first 2 years of operation of the market, give ASIC a report that sets out the following:
 - (a) the number and identity of:
 - (i) the entities listed on the market at the end of the quarter; and
 - (ii) the participants in the market at the end of the quarter;
 - (b) a statement of cash flows for the quarter;
 - (c) a statement of financial position at the end of the quarter;
 - (d) the opinion of the directors of APX, as at the end of the quarter, as to whether APX will be able to pay its debts when they become due and payable;
 - (e) the opinion of the directors of APX, as at the end of the quarter, as to whether APX has sufficient resources to meet, in the next 6 months, its obligations under Chapter 7 of the Act as a market licensee.

(2) In this Licence:

quarter means a period of 3 months ending on 31 March, 30 June, 30 September or 31 December.

12 Suspension of the market

If APX suspends the operation of the market, APX must notify ASIC as soon as practicable in writing of the suspension and the reasons for it.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 601QA(1)(b) – Declaration

 - (a) reasonably believes that the value or amount cannot be objectively ascertained at the relevant time; and
 - (b) discloses a general description of the valuation methods and policies it will apply in determining the value or amount in each Product Disclosure Statement for interests in the scheme that is given to a person as a retail client while the constitution does not make such provision.
 - (7) In this section:

transaction costs means, in relation to the acquisition of an interest in the scheme or a withdrawal request, the amount that is included in the price at which the interest is acquired or has been deducted from the amount that would otherwise be paid in meeting the request that is reasonably attributable to the expenses associated with the acquisition or disposal of scheme assets merely because the interest has been acquired or the withdrawal request is met."

Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 601QA(1)(a), 911A(2)(l), 992B(1)(a) and 1020F(1)(a) — Exemption

- 1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the persons referred to in Schedule A from section 601ED of the Act in the case referred to in Schedule B on the conditions set out in Schedule C.
- 2. Under paragraphs 911A(2)(1), 992B(1)(a) and 1020F(1)(a) of the Act ASIC exempts the persons referred to in Schedule A in the case referred to in Schedule B on the conditions set out in Schedule C from:
 - (a) sections 992AA and 1017F of the Act; and
 - (b) the requirement to hold an Australian financial services licence for the provision of financial services by that person in relation to dealing in interests in a managed investment scheme of the kind and offered on the basis referred to in Schedule B.
- 3. Under paragraphs 992B(1)(a) of the Act ASIC exempts a person (other than a person referred to in Schedule A) in the case of an offer to sell an interest in a managed investment scheme referred to in Schedule B and offered on a basis that appears to comply with Schedule C, from section 992AA of the Act.

SCHEDULE A — WHO IS EXEMPT

Any person who operates the scheme specified in Schedule B (*scheme*) and the following persons (promoters):

- (a) Pacific Eastcoast Securities Limited ACN 095 431 584 and the following persons (*promoters*); and
- (b) any other person offering an interest in the scheme for issue,

other than a person who is aware that any Product Disclosure Statement required to be given to a person under the Act in relation to the scheme, was not given or was given but did not comply with the Act.

SCHEDULE B — SCHEMES EXEMPTED

Operating a managed investment scheme which involves an owner (*investor*) of real property (*strata unit*), in the investor's discretion, making their strata unit available for use by a person (operator) as part of a serviced apartment, hotel, motel or resort complex located at corner of Shoalhaven and Minnamurra Streets, Kiama New South Wales developed in accordance with an approval of a local government organisation that was given to ASIC on 23 July 2004 and in relation to which on 1 March 2000 there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme, where:

- (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;
- (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:
 - (i) by a person other than the operator or an associate of the operator; and
 - (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;
- (c) each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
- (d) the operator is licensed in relation to the conduct of the letting services under the law of a State or Territory or is an financial services licensee;
- (e) no payment is liable to be made by an investor to participate in the scheme other than:
 - (i) payment of money to buy the strata unit;
 - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
 - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate; and
 - (B) where a FFE Fund has been established for the investor no payment or part thereof is used for the replacement, repair or refurbishment of

furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and

- (iii) where a FFE Fund has been established for the investor one or more payments into the Fund where:
 - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and
 - (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;
- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme; and
- (g) the serviced apartment, hotel, motel or resort complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in Schedule D.

SCHEDULE C — CONDITIONS ON OPERATORS AND PROMOTERS

- 1. The operator must ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution must be held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually.
- 2. Where a FFE Fund has been established for an investor, the operator must ensure that:
 - (a) the money comprising the Fund is held on trust for the investor in a trust account and subject to audit as to whether the money has been dealt with in accordance with the terms of the trust by a registered company auditor at least annually; and
 - (b) the balance of the Fund is promptly returned to the investor at the termination of the scheme or upon the investor's withdrawal from the scheme, whichever occurs first.

- 3. Each promoter that is involved in making an offer of interests in the scheme for issue must not engage in any misleading or deceptive conduct or conduct that is likely to mislead or deceive in connection with those offers.
- 4. The operator must comply with the provisions specified in Schedule D which are included in the agreement referred to in paragraph (g) of Schedule B.

SCHEDULE D — PROCEDURES FOR TRANSFERRING MANAGEMENT RIGHTS

1. Transfer of management rights

- (a) If a majority of scheme members advise the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme.
- (b) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice.
- (c) A transfer referred to in paragraphs (a) or (b) must be done as soon as practicable, but if there is a body corporate for the real property to which the scheme relates, there must be a reasonable time for members of the body corporate to consider whether to make a decision referred to in paragraph 2(b) unless the body corporate has consented to the transfer.

2. Consent of body corporate to new care-taking arrangements

- (a) If an operator receives a notice under paragraph 1(b) of this Schedule, the operator must advise all body corporate members of the name of the person to whom the transfer is to be made.
- (b) Unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in paragraph 1(b) of this Schedule if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions.
- (c) If a majority of body corporate members make a decision referred to in paragraph 2(b) of this Schedule, a majority of scheme members may then at any time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with paragraph 1(b) of this Schedule.

(d) This paragraph 2 does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under paragraph 1(b) or 2(c) of this Schedule before that notice is given to the operator.

3. Price payable on transfer

The price scheme members specify in a notice under paragraph 1(b) of this Schedule must be one of the following:

- (a) the average of two valuations of the management rights by independent qualified valuers nominated by the Australian Property Institute (or another relevant independent professional body approved by ASIC); or
- (b) the highest bona fide bid for the management rights (excluding a bid by the operator or its associates) at an auction of which at least 60 days' notice had been given; or
- (c) the highest bona fide amount tendered (excluding any tender by the operator or its associates) for the management rights following reasonable efforts to market the property for at least 60 days.

4. Voting

- (a) In determining if there is a majority of scheme members or body corporate members, the operator and its associates and any person nominated as a replacement operator and associates of that person must not be counted.
- (b) For scheme members, a majority is based on their entitlement to vote at body corporate meetings if there is a body corporate for the property to which the scheme relates, and otherwise each member shall have one vote.
- (c) For body corporate members, a majority is based on their entitlement to vote at body corporate meetings.
- (d) A scheme member or a body corporate member makes a decision by signing a document that sets out the decision

5. Costs

(a) Any member may arrange a valuation or auction of, or may market, the management rights before or after the expiration of the 9 month period referred to in paragraph 1(a) of the Schedule for the purposes of determining a price to be specified in a notice under paragraph 1(b) of this Schedule.

(b) If a member incurs any reasonable valuation, auction or marketing costs under paragraph 5(a) of this Schedule that member is entitled to be reimbursed out of the price payable by any person nominated by the members as transferee of the management rights when the price is paid to the operator.

6. Assistance

The operator must give reasonable assistance to enable the transferee to operate the resort, hotel, motel or serviced apartment complex including making available information concerning any prospective bookings.

7. Definitions

In this Schedule:

scheme members means investors in the scheme excluding the operator and its associates;

management rights means all real or personal property (including contractual rights) held by the operator or any of its associates that facilitates the operation of the scheme; and

transfer in relation to management rights means to assign or transfer the management rights or to cause another person to become the holder of those rights or rights substantially the same as those rights.

Interpretation

In this instrument:

FFE Fund means a fund established for an investor consisting of money paid by the investor and any interest accrued on that money, to be used from time to time in accordance with the written agreement referred to in paragraph (g) of Schedule B for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit made available by the investor for use as part of the scheme; and

offer is to be interpreted in accordance with subsection 1010C(2) of the Act.

successor fund has the same meaning as in the Superannuation Industry (Supervision) Regulations 1994.
