

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 1437(2)(b) – Variation

Under paragraph 1437(2)(b) of the Corporations Act 2001 the Australian Securities and Investments Commission varies ASIC Instrument [04/0313] dated 11 March 2004, as varied by ASIC Instrument [04/0630] on 9 June 2004, by:

- 1. omitting "the period ending 10 September 2004" and substituting "the period ending 10 February 2005"; and
- 2. omitting the Schedule and substituting the following:

"Schedule

While all of the following are satisfied:

- (a) AGML remains subject to a Deed of Company Arrangement; and.
- (b) during the period starting on 11 March 2004 and ending on 10 February 2005 AGML takes all reasonable steps to have, by 10 February 2005, either:
 - (i) obtained an Australian financial services licence covering the provision of financial services in relation to any registered scheme for which it is the responsible entity;
 - (ii) transferred its status as responsible entity for any such registered scheme to another person who holds an Australian financial services licence that covers the provision of financial services in relation to the registered scheme; or
 - (iii) ceased operating any registered scheme for which it is the responsible entity by taking steps to wind up any such registered scheme; and
- (c) AGML does not make any offer to issue or issue any interests in any registered scheme for which it is the responsible entity.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 911A(2)(l) -Exemption

Under paragraph 911A(2)(l) of the *Corporations Act 2001* the Australian Securities and Investments Commission exempts the person specified in Schedule A from the requirement to hold an Australian financial services licence in the case referred to in Schedule B and on the condition set out in Schedule C for so long as it is met.

Schedule A

IPG Finance Pty Ltd (ACN 108 555 031) ("the Company")

Schedule B

- (1) The Company is, and remains at all times, a wholly owned company within IPG; and
- (2) the financial service provided by the Company consists only of either or both of:
 - (A) dealing in derivatives; and
 - (B) dealing in foreign exchange contracts; and
- (3) the financial service does not involve the making of a market for derivatives or foreign exchange contracts; and
- (4) the dealing is entered into by the Company solely for the purpose of an entity within IPG managing a financial risk that arises in the ordinary course of its business; and
- (5) the financial service provided by the Company does not constitute a significant part of IPG's business.

Schedule C

Before entering a derivative or foreign exchange transaction, the Company must notify the counterparty to the transaction that the Company is exempt from the requirement to hold, and does not hold, an Australian financial services licence.

"IPG" means Investa Properties Limited (ABN 54 084 407 241), in its capacity as responsible entity of Investa Property Trust ("IPL") and all entities that are wholly owned, directly or indirectly, by IPL, whether such ownership arises by way of shareholding, interests in one or more trusts or otherwise, and whether such ownership interest arises at law or in equity.

 - (i) in each Product Disclosure Statement for interests in the scheme that is given to a person as a retail client while the constitution does not make such provision; or
 - (ii) where a Product Disclosure Statement is not required to be given, in each information memorandum for interests in the scheme that is given to a person while the constitution does not make such provision.

- (7) The constitution does not have to make adequate provision for:

- (f) the Product Disclosure Statement requires the responsible entity to give all members at least 30 days notice in writing and an opportunity to make a withdrawal from the scheme before it increases the amount of withdrawal fees that must be paid to make a withdrawal from the scheme.

contribution fee means the fee (if any) that must be paid to the responsible entity to acquire an interest in the scheme, which is determined by the responsible entity and does not exceed 5% of the consideration to acquire an interest in the scheme;

information memorandum means a document provided to wholesale clients, as defined in section 761G, in connection with the offer to issue. offer to arrange for the issue or the issue of interests in the scheme;

transaction costs means, in relation to the acquisition of an interest in the scheme or a withdrawal request, the amount that is included in the price at which the interest is acquired or has been deducted from the amount that would otherwise be paid in meeting the request that is reasonably attributable to the expenses associated with the acquisition or disposal of scheme assets merely because the interest has been acquired or the withdrawal request is met; and

withdrawal fee means the fee (if any) that must be paid to the responsible entity make a withdrawal from the scheme, which is determined by the responsible entity and does not exceed 5% of the proceeds payable upon a withdrawal from the scheme. "

 - (f) the document clearly and prominently discloses:
 - (i) the identity of the outside expert and the responsible person;
 - (ii) the nature of the relationship between the outside expert and the responsible person; and

 - (a) replacing the words "change, if any" in paragraph (c) of new subsection 1457(1AA) with the words "any change (other than a change to implement a proposal approved by resolution of holders of interests in the Scheme to authorise stapling interests in the Scheme to interests in another scheme, in accordance with the provisions of subsection 1457(1AB))"; and
 - (b) replacing the words "change, if any" in paragraph (c) of Schedule A with the words "any change (other than a change to implement a proposal approved by resolution of holders of interests in the Scheme, made in or about October or November 2004 to authorise stapling interests in the scheme to interests in another scheme, in accordance with the provisions of subsection 1457(1AB))".
 - (c) inserting immediately after paragraph (c) of new subsection 1457(1AA), new subsections 1457(1AB) and 1457(1AC) as follows:

the Act) applies to interests in The Davey Financial Management Pender Place Shopping Centre Trust established under a deed poll dated 12 October 1995 ("the Scheme"), the undertaking to which the Scheme relates, and to the trustee or representative and management company (being the persons specified in Schedule A) of the Scheme as if:
