Exemptions**

Under paragraphs 601QA(1)(a), 911A(2)(l), 992B(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the “Act”), the Australian Securities and Investments Commission exempts the person specified in Schedule A from:

- (a) section 601ED of the Act in relation to the operation of the managed investment schemes specified in Schedule B;
- (b) section 992AA and Part 7.9 of the Act in relation to:
  - (i) an offer specified in Schedule B;
  - (ii) an issue of an interest in a managed investment scheme resulting from an offer specified in Schedule B; and

- (c) the interest does not relate to any other managed investment scheme.
