Australian Securities and Investments Commission Corporations Act 2001 – Subsection 655A(1) – Declaration

Pursuant to subsection 655A(1) of the Corporations Act 2001 ("Act") the Australian Securities and Investments Commission ("ASIC") declares that Chapter 6 of the Act applies to the persons specified in Schedule A in the case referred to in Schedule B as if the following subsection 650D(2A) were added after subsection 650D(2):

This Licence is the Australian Market Licence (BGC Partners (Australia) Pty Limited) 2006.

2 Commencement

This Licence commences when it is granted.

3 Definitions

In this Licence:

Act means the Corporations Act 2001.

Australian participant means a person in Australia who is a participant.

BGC's senior supervisory staff means BGC staff authorised by BGC to make decisions in relation to supervisory issues that have been identified for the market.

Section 4

debenture means:

- (a) a debenture defined in section 9 of the Act; or
- (b) a chose in action that includes an undertaking by a government to repay as a debt money deposited with or lent to the government; or
- (c) an undertaking to repay money deposited with or lent to a body by a person if:
 - (i) the person deposits or lends the money in the ordinary course of business carried on by the person; and
 - the body receives the money in the ordinary course of carrying on a business that neither comprises nor forms part of a business of borrowing money and providing finance; or
- (d) an undertaking by an Australian ADI to repay money deposited with it, or lent to it, in the ordinary course of its banking business.

government in Australia means:

- (a) the Government of the Commonwealth; or
- (b) the government of a State or Territory; or
- (c) a local government in Australia; or
- (d) a government agency, or semi-government agency, of any of the governments mentioned in paragraph (a), (b) or (c).

market means the market mentioned in section 4 and operated by BGC under this Licence.

participant has the same meaning as in section 761A of the Act.

Note The following terms are defined in section 9 of the Act:

- (a) ASIC
- (b) Australian ADI
- (c) body
- (d) professional investor.

4 Grant of licence

This Licence is granted to BGC Partners (Australia) Pty Limited (BGC) to operate the financial market to be established by BGC:

- (a) in which participants may enter into trades with each other in the classes of financial products mentioned in section 5; and
- (b) using the eSpeedsm electronic trading platform.

5 Classes of financial products

The classes of financial products that can be traded on the market are:

- (a) stocks or bonds issued, or proposed to be issued, by a government in Australia; and
- (b) stocks or bonds issued, or proposed to be issued, by the government of New Zealand; and
- (c) debentures.

Section 6

6 Clearing and settlement arrangements

- (1) After the execution of a transaction on the market, BGC must notify each party to the transaction of the identity of the other party to the transaction.
- (2) BGC must have operating rules for the market that provide for transactions effected through the market to be settled by the parties to the transaction.

7 Participants

- (1) BGC must ensure that each Australian participant:
 - (a) is a professional investor; and
 - (b) is an authorised deposit-taking institution within the meaning of the *Banking Act 1959*; and
 - (c) holds any licence or authorisation required for the participant to make offers on, or enter into transactions on, the market.
- (2) BGC must ensure each participant who is not an Australian participant:
 - (a) is a professional investor; and
 - (b) holds any licence or authorisation required for the participant to make offers on, or enter into transactions on, the market.
- (3) BGC may allow a participant mentioned in this section to trade on the market only if:
 - (a) the participant is acting on the participant's own behalf; or
 - (b) in any other case the participant is acting on behalf of a professional investor.

8 Reporting

- (1) BGC must, within 30 days after the end of each 12 month period that ends within the first 2 years after the Licence is granted, give the following information to ASIC:
 - (a) a statement of cash flows for the period;
 - (b) a statement of financial performance for the period;
 - (c) a statement of financial position at the end of the period.
- (2) BGC must, within 30 days after the end of each 6 month period that ends within the first 2 years after the Licence is granted, give the following information to ASIC:
 - (a) all supervision issues identified by BGC during the period in relation to the market;
 - (b) any supervision issues referred to BGC's senior supervisory staff during the period in relation to the market;
 - (c) the outcome in relation to issues mentioned in paragraph (b), after consideration by BGC's senior supervisory staff.

Section 8

(3) In this section:

12 month period means the period of 12 months ending on 31 December. 6 month period means the period of 6 months ending on:

- (a) 30 June; or
- (b) 31 December.

Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 283GA(1)(a), 601QA(1)(a), 741(1)(a), 911A(2)(1), 992B(1)(a) and 1020F(1)(a) —Revocation and Exemptions

Revocation

1. Under paragraphs 283GA(1)(a), 601QA(1)(a), 741(1)(a), 911A(2)(l) and 1020F(1)(a) of the *Corporations Act 2001* (the "Act"), the Australian Securities and Investments Commission ("ASIC") revokes ASIC Instrument [02/0362] dated 14 March 2002.

First Exemption: disclosure relief

- 2. Under paragraphs 741(1)(a) and 1020F(1)(a) of the Act, ASIC exempts:
 - (a) a person from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the person:
 - (i) makes an eligible offer;
 - (ii) offers to arrange for the issue of financial products under an eligible offer;
 - (iii) issues a financial product under an eligible offer, that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met; and
 - (b) a person (other than a person covered by paragraph (a)) from Part 7.9 where the person makes a recommendation to acquire financial products under an eligible offer that does not involve a contribution plan, except where the person is aware, or ought reasonably to be aware, that any of the conditions set out in the Schedule have not been met.

Second Exemption: licensing and hawking relief

- 3. Under paragraph 911A(2)(1) ASIC exempts a person who is exempt from Part 6D.2 or Part 7.9 because of the First Exemption (other than because the person made a recommendation to acquire financial products) from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer referred to in that exemption (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 4. Under paragraph 911A(2)(1) ASIC exempts:
 - (a) an issuer who is exempt from Part 6D.2 or Part 7.9 because of the First Exemption; and
 - (b) any associate of the issuer, from the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (c) the provision of a custodial or depository service in connection with an eligible offer covered by the First Exemption where the

- provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
- (e) dealing in a financial product in connection with an eligible offer covered by the First Exemption where any acquisition by purchase or disposal of the product (by the issuer or an associate) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products or a dealers licence issued under the old Corporations Act authorising the holder to deal in securities; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 5. Under paragraphs 741(1)(a) and 992B(1)(a) ASIC exempts a person who is exempt from Part 6D.2 or Part 7.9 because of the First Exemption from sections 736, 992A and 992AA in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

Schedule

The following conditions apply:

- 1. the person making the offer must:
 - (a) include that offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- 2. the issuer must comply (or, in the case of an issuer which does not have a registered office in this jurisdiction, cause an associated body corporate which does so have a registered office to comply) with any undertaking required to be made in the offer document by reason of this instrument; and
- 3. in the case where the employee share scheme may involve the issue of shares (including as a result of the exercise of an option or as a component of stapled securities) the issuer must take reasonable steps to ensure that the number of shares the subject of the offer or to be received on exercise of an option when aggregated with:
 - (a) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and options to acquire unissued shares, under an employee share scheme to be accepted or exercised; and

- (b) the number of shares in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the issuer; but disregarding any offer made, or option acquired or share issued by way of or as a result of:
- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act* 1999; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement, must not exceed 5% of the total number of issued shares in that class of the issuer as at the time of the offer.

Interpretation

In this instrument:

- except where otherwise stated, references to provisions are to provisions of the Act:
- an employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
- 3. "associated body corporate" of an issuer means:
 - (a) a body corporate that is a related body corporate of the issuer; or
 - (b) a body corporate that has voting power in the issuer of not less than 20%; or
 - (c) a body corporate in which the issuer has voting power of not less than 20%;
- 4. "Australian dollar equivalent" in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates;
- 5. "contribution plan" means a plan under which a participating eligible employee may save money by regular deductions from wages or salary (including through salary sacrifice arrangements) towards paying for shares offered for issue or sale under an employee share scheme where the terms and conditions of the contribution plan include terms and conditions to the effect that:
 - (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application which is used in respect of the offer, or on a form which is included in or accompanies the offer document;
 - (b) before transferring contributions to acquire shares, any contributions made by an employee as part of the contribution plan must be held by

the issuer in trust for the employee in an account of an Australian ADI which is established and kept by the issuer only for the purpose of depositing contribution moneys and other money paid by employees for the shares on offer under the employee share scheme; and

- (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election is made all money deposited with the Australian ADI in relation to that employee, including any accumulated interest, must be repaid to that employee;
- 6. "current market price" means in relation to a share, the price published by the operator of the principal financial market on which the share is quoted as the final price for the previous day on which the share was traded on that financial market;
- 7. "eligible employee" means, in relation to an issuer, a person who is at the time of an offer under an employee share scheme, a full or part-time employee or director of the issuer or of an associated body corporate of the issuer;
- 8. "eligible offer" means an offer for issue or sale of:
 - (a) fully-paid stapled securities comprising a share in THL, a share in TIL and a unit in THT which:
 - (i) are to be issued by the issuer; and
 - (ii) have been quoted on the financial market operated by
 Australian Stock Exchange Limited or an approved foreign
 market throughout the 12 month period immediately before the
 offer.

on the basis that any period during which stapled securities comprising a share in THL, a share in TL and a unit in THT were quoted on the financial market operated by Australian Stock Exchange Limited without suspension for more than a total of 2 trading days during that period and ending on the day that those stapled securities cease to be quoted on the financial market operated by Australian Stock Exchange Limited shall be taken to be a period during which stapled securities comprising a share in THL, a share in TIL and a unit in THT have been quoted for the purpose of paragraph (ii) to the extent that paragraph (ii) is not satisfied by those stapled securities of the issuer; or

- (b) options for the issue or transfer of stapled securities comprising a share in THL, a share in TIL and a unit in THT referred to in paragraph (a) where each of the options is offered for no more than nominal consideration;
- 9. "financial product advice" has the meaning given by section 766B;
- 10. "general advice" has the meaning given by section 766B;
- 11. "issuer" means THL, TIL and TIML as responsible entity for THT;
- 12. "nominal consideration" means consideration of not more than 1 cent per option;
- 13. "offer" has a meaning affected by sections 700, 702 and 1010C;
- 14. "offer document" means a document setting out an offer under an employee share scheme that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the scheme under which the offer is made; and
 - (b) if a summary (rather than a copy) of the rules of the scheme is given—includes an undertaking that during the period (the "offer period")

during which an eligible employee may acquire the financial products offered or exercise options acquired under the scheme, the issuer (or, in the case of an issuer which does not have a registered office in this jurisdiction, an associated body corporate of the issuer which does so have a registered office) will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the scheme; and

- (c) specifies in respect of the shares, shares subject to the options, units of shares or stapled securities:
 - (i) the acquisition price in Australian dollars;
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
- (d) includes an undertaking, and an explanation of the way in which, the issuer (or in the case of an issuer which does not have a registered office in this jurisdiction, an associated body corporate of the issuer which does so have a registered office) will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of:
 - (A) where the document relates to an offer of shares, options or units shares in the same class as those offered, subject to the options or to which the units relate; or
 - (B) where the document relates to an offer of stapled securities stapled securities of the same class as those offered; and
 - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
- (e) discloses the conditions, obligations and risks associated with any loan
 or financial assistance offered by the issuer or any associated body
 corporate of it for the purpose of acquiring financial products under the
 scheme;
- 15. "stapled security" means two or more financial products (at least one of which is a share) which, under the terms on which each is traded, must be transferred together:
- 16. "THL" means Transurban Holdings Limited ACN 098 143 429;

- 18. "TIL" means Transurban International Limited, a company incorporated in Bermuda with registration number 38875;

Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 655A(1)(a) and 673(1)(a) – Exemptions

Pursuant to paragraphs 655A(1)(a) and 673(1)(a) of the Corporations Act 2001 ("Act") if the Associates have a relevant interest in more than 17% of the Securities, the Australian Securities and Investments Commission ("ASIC") exempts the person mentioned in Schedule A in the case mentioned in Schedule B, to the extent and on the conditions set out below.

First Exemption

The Broker is exempt from section 606 of the Act in relation to the acquisitions mentioned in Schedule B, and the Associates are exempt from section 606 in relation to any voting power conferred on them by interests held by the Broker pursuant to such acquisitions, on the following conditions:

- (a) The Broker disposes of their interest in any Securities acquired in reliance on this exemption within 14 days after acquisition;
- (b) The Broker does not sell a Security to a person if it knows or believes that person would contravene section 606 by acquiring the Security;
- (c) The Broker does not exercise any voting rights attaching to the Securities at any time while holding the Securities, without ASIC's consent;
- (d) The Broker does not at any time have more than 3% of the Securities on issue in reliance on this exemption;
- (e) The Broker uses their best endeavours to obtain as wide a placement of the Securities as practicable; and
- (f) The Broker gives ASIC on or about 8 October 2007:
 - (i) a list, in chronological order, of each acquisition made in reliance on, and disposal effected to comply with this exemption up to and including 29 September 2007, and in relation to each such acquisition or disposal:
 - (A) the date, time and method of acquisition or disposal;
 - (B) the name of the person (if known) from whom the interests were acquired or to whom the interests were disposed of;
 - (C) the number of interests and percentage of the total issued interests acquired or disposed of; and
 - (D) the number of interests and percentage of the total issued interests in which the Broker had a relevant interest immediately before and after the acquisition or disposal; and

(ii) a written report setting out any other matters which, in the view of the Broker, may be of relevance to ASIC in understanding how this exemption has, to the date of the report, assisted the Broker in facilitating the acquisition and disposal of the Securities by its institutional clients.

Second Exemption

The Broker is exempt from Chapter 6C of the Act, and the Associates are exempt from Chapter 6C in relation to any voting power conferred on them by interests held by the Broker in relation to Securities acquired pursuant to this exemption, in relation to:

- the acquisitions mentioned in Schedule B; and
- any Security which is a Sold Security at 9.30 am on the third business day after its acquisition.

This exemption is given on condition that, if at 9.30am on the third business day after that acquisition, the Broker's voting power attached to the Securities is 5% or greater, the Broker then complies with Part 6C of the Act in relation to the voting power arising from that acquisition.

For the purposes of the conditions, treat the Broker as no longer having a relevant interest in a Security (a "Sold Security"), if the Broker has agreed to sell the Security under a contract which is subject to no conditions which would not be implied into an open contract entered into on the financial market operated by the Australian Stock Exchange Limited, other than a condition postponing settlement until completion of the acquisition mentioned in Schedule B.

SCHEDULE B

Acquisitions by the Broker, in the ordinary course of the Broker's business, from the date of this instrument until 29 September 2007, of:

- (a) on or prior to the Final Instalment Payment Date, Instalment Receipts, for the purpose of resale within 14 days; and
- (b) after the Final Instalment Payment Date, Stapled Securities, for the purpose of resale within 14 days.

Interpretation

In this instrument:

"Associates" means Deutsche Bank AG and each of its related bodies corporate, other than the Broker, and Cheung Kong Infrastructure Holdings Limited and each of its related bodies corporate.

"Final Instalment Payment Date" has the meaning given under the Offer Document.

"Instalment Receipts" means the instalment receipts issued by Spark Infrastructure Instalment Limited (ABN 72 115 680 601) pursuant to the Offer Document, each evidencing a beneficial interest in, and payment of the first instalment in respect of, a Stapled Security.

"Offer Document" means the combined prospectus and product disclosure statement lodged with ASIC on 18 November 2005 in respect of the offer of Instalment Receipts.

"Securities" means:

- (a) on or prior to the Final Instalment Payment Date, the Instalment Receipts; or
- (b) after the Final Instalment Payment Date, the Stapled Securities.
