Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 655A(1)(b) – Declaration

Under paragraph 655A(1)(b) of the Corporations Act 2001 ("Act"), the Australian Securities and Investments Commission ("ASIC") declares that Chapter 6 of the Act applies to the person referred to in Schedule A in relation to the securities referred to in Schedule B in the case referred to in Schedule C as if:

- 1. Section 617 of the Act were modified or varied by inserting after subsection 617(2) the following subsection:
 - "(2A) The bid may also extend to all securities that come to be in the bid class during the offer period due to the issue of securities in the bid class pursuant to a dividend reinvestment plan announced by the target prior to the date set by the bidder under subsection 633(2)."; and
- 2. Section 636 of the Act were modified or varied by inserting after paragraph 636(1)(j) the following paragraph:

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 655A(1)(b) – Declaration

Under paragraph 655A(1)(b) of the Corporations Act 2001 (Act), the Australian Securities and Investments Commission (ASIC) declares that Chapter 6 of the Act applies to Macquarie Group Limited ACN 122 169 279 (MGL) in respect of an agreement of the kind referred to in Schedule A and shares in Macquarie Bank Limited ACN 008 583 542 (MBL), as if subsection 609(7) of the Act was omitted and replaced as follows:

"A person does not have a relevant interest in securities merely because of an agreement if the agreement:

- (a) is conditional on:
 - (i) a resolution under item 7 in the table in section 611 being passed; or
 - (ii) ASIC exempting the acquisition under the agreement from the provisions of this Chapter under section 655A; or
 - (iii) a scheme of arrangement approved by the Court under Part 5.1 taking effect; and
- does not confer any control over, or power to substantially influence, the exercise of a voting right attached to the securities; and
- (c) does not restrict disposal of the securities for more than 4 months from the date when the agreement is entered into.

The person acquires a relevant interest in the securities when the condition referred to in paragraph (a) is satisfied."

Australian Securities and Investments Commission Corporations Act 2001—Subsections 601QA(1) and 1020F(1)— Exemption and Declaration

- Under paragraph 601QA(1)(a) of the Corporations Act 2001 (the "Act"), the
 Australian Securities and Investments Commission ("ASIC") exempts
 MacarthurCook Fund Management Limited ACN 004 956 558 ("RE") in its
 capacity as responsible entity of the MacarthurCook Property Securities Fund
 ARSN 111 442 150 ("Fund") from paragraph 601FC(1)(d) of the Act in relation
 to the rights issue referred to in Schedule A and in the case referred to in Schedule
 B to the extent that it would prevent the RE from treating CDP differently to other
 members of the Fund in the way described in Schedule B.
- 2. Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 5C of the Act applies to the RE in relation to the rights issue referred to in Schedule A as if paragraph 601GAA(3)(d) of the Act (as notionally inserted by ASIC Class Order [05/26]) be modified or varied by omitting "same;" and substituting:
 - "same other than to the extent the price of the interests is affected by fluctuations in exchange rates;".
- 3. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies to the RE in relation to the rights issue referred to in Schedule A as if paragraph 9A(2)(c) were modified or varied by omitting "same." and substituting:
 - "same other than differences resulting from the operating rules of the financial markets on which the interests are able to be traded."
- 4. - 2. Under paragraph 601QA(1)(b) of the Act ASIC declares that Chapter 5C of the Act applies to the person referred in Schedule A in the case set out in Schedule B as if Chapter 5C were modified or varied as follows:
- (a) omit paragraph 601FC(1)(c) and substitute:
 - "(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and their interests as holders of one or more other financial products, where interests in the scheme are components of a stapled security), and, if there is a conflict between the members' interests and its own interests, give priority to the members' interests; and"; and
- (b) omit paragraph 601FC(1)(e) and substitute:
 - "(e) not make use of information acquired through being the responsible entity in order to:
 - (i) gain an improper advantage for itself or another person; or
 - (ii) cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and their interests as holders of one or more other financial products, where interests in the scheme are components of a stapled security); and ": and
- (c) omit paragraph 601FD(1)(c), 601FD(1)(d) and 601FD(1)(e) and substitute:
 - "(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and their interests as holders of one or more other financial products, where interests in the scheme are components of a stapled security) and, if there is a conflict between the members' interests and the interests of the responsible entity, give priority to the members' interests; and
 - (d) not make use of information acquired through being an officer of the responsible entity in order to:

- (i) gain an improper advantage for the officer or another person; or
- (ii) cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and their interests as holders of one or more other financial products, where interests in the scheme are components of a stapled security); and
- (e) not make improper use of their position as an officer to gain, directly or indirectly, an advantage for themselves or for any other person or to cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and their interests as holders of one or more other financial products, where interests in the scheme are components of a stapled security); and"; and
- (d) omit paragraphs 601FE(1)(a) and 601FE(1)(b) and substitute:
 - "(a) make use of information acquired through being an employee of the responsible entity in order to:
 - (i) gain an improper advantage for the employee or another person; or
 - (ii) cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and their interests as holders of one or more other financial products, where interests in the scheme are components of a stapled security); or
 - (b) make improper use of their position as an employee to gain, directly or indirectly, an advantage for themselves or for any other person or to cause detriment to the members of the scheme (having regard to their interests as holders of interests in the scheme and their interests as holders of one or more other financial products, where interests in the scheme are components of a stapled security)."; and
- (e) after subsection 601GAA(9) as notionally inserted into Chapter 5C by ASIC Class Order [CO 05/26], insert:
 - "(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
 - (a) the constitution makes provision for the issue price of stapled securities;
 - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;
 - the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the constitution;

- (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution."; and
- (f) insert after subsection 208(2) of the Act as notionally inserted by section 601LC:
 - "(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if:
 - (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme (the *relevant scheme*); or
 - (ii) could endanger the scheme property; and
 - (b) each of the interests in the relevant scheme is a component of a stapled security; and
 - (c) the benefit is given by:
 - (i) the responsible entity of the relevant scheme; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity; and
 - (d) the benefit is given:
 - (i) where the stapled securities of which interests in the relevant scheme form a component include interests in one or more registered managed investment schemes:
 - (A) to the responsible entity of one or more of those other schemes; or
 - (B) to any of those schemes or any wholly owned entity of any of those schemes; or
 - (ii) as a result of a benefit given to one or more of the persons described in paragraph (i) above, to a related party of the responsible entity of the relevant scheme who holds stapled securities (of which interests in the relevant scheme form a component)."; and

(g) insert after section 601PC:

"601PD For the purposes of sections 601FC, 601FD, 601FE and 601LC:

stapled security means two or more financial products including at least one interest in a registered scheme where:

- under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.".

1 Name of Notice

This Notice is the Corporations (Tullett Prebon (Singapore) Limited) Exemption Notice 2007.

2 Commencement

This Notice commences on the day it is published in the Gazette.

3 Definitions

In this Notice:

Act means the Corporations Act 2001.

Australian participant means a person in Australia who is a participant. foreign participant means a participant who is not an Australian participant. Platform means the financial market that is operated by TPSing in respect of foreign exchange contracts that are foreign exchange options.

Section 4

TPSing means Tullett Prebon (Singapore) Limited.

Note Other terms defined or used in the Act have the same meaning in this Notice (see Acts Interpretation Act 1901, section 46). These include:

- ASIC (section 9 of the Act)
- clearing and settlement facility (section 768A of the Act)
- declaration of contravention (section 1317E of the Act)
- financial market (section 761A of the Act)
- foreign exchange contract (section 761A of the Act)
- participant (section 761A of the Act)
- professional investor (section 9 of the Act).

4 Exemption

For section 791C of the Act, and subject to the conditions mentioned in sections 5 to 16 of this Notice, the financial market known as Platform and operated by TPSing is exempt from the operation of Part 7.2 of the Act.

5 Condition — operation of the Platform

- (1) TPSing must operate the Platform in all essential details in the way set out in the application for this exemption by TPSing dated 11 September 2006, and received by ASIC on 13 September 2006.
- (2) TPSing, or an associate of TPSing, must not operate a clearing and settlement facility for the Platform.

6 Condition — participants who may trade on the Platform

TPSing must not admit a participant to, or allow a participant to enter into a trade on, the Platform unless the participant is:

- (a) if the participant is an Australian participant a professional investor that is trading on its own behalf; or
- (b) if the participant is a foreign participant a professional or institutional investor in the jurisdiction in which the participant trades that is trading on its own behalf.

7 Condition — TPSing to maintain approval by the Monetary Authority of Singapore and report certain changes

TPSing must:

- (a) maintain the approval by the Monetary Authority of Singapore for TPSing to conduct money broking business in Singapore; and
- (b) notify ASIC, as soon as practicable and in writing, of the details of:
 - (i) the termination of, or any significant change to:
 - (A) the approval by the Monetary Authority of Singapore for TPSing to conduct money broking business in Singapore; or
 - (B) TPSing's regulatory status in Singapore; and

Section 10

 (ii) any enforcement or disciplinary action taken against TPSing by the Monetary Authority of Singapore or any other overseas regulatory authority.

8 Condition — TPSing to establish and maintain arrangements to manage a conflict of interest

TPSing must establish and maintain adequate arrangements, to the satisfaction of ASIC, for the management of any conflict of interest that may arise in relation to activities undertaken by TPSing in the operation of the Platform.

9 Condition — TPSing to report certain events involving an Australian participant

- (1) If TPSing takes any disciplinary action against an Australian participant of the Platform, TPSing must, as soon as practicable, advise ASIC in writing of:
 - (a) the participant's name; and
 - (b) the reason for, and nature of, the action taken.
- (2) If TPSing has information that would cause a person to believe or suspect, on reasonable grounds, that an Australian participant has committed, is committing or is about to commit, a significant contravention of the Act or the Platform's operating rules TPSing must, as soon as practicable, advise ASIC in writing of:
 - (a) the Australian participant's name; and
 - (b) details of the contravention or impending contravention; and
 - (c) TPSing's reason for that reasonable belief or suspicion.

10 Condition — TPSing to report certain events involving TPSing, or a director or secretary of TPSing

- (1) TPSing must, within 14 days, advise ASIC in writing if TPSing becomes aware that TPSing, or a director or secretary of TPSing:
 - (a) is the subject of a declaration of contravention in relation to a provision of the Act; or
 - (b) has been convicted of an offence under the Act; or
 - (c) has been disqualified from managing a corporation; or
 - (d) has been banned or disqualified from providing financial services.
- (2) TPSing must, within 7 days, advise ASIC in writing, of TPSing ceasing to operate the Platform in Australia.

Section 11

11 Condition — TPSing to submit annual report

- (1) Within three months of the end of its financial year, TPSing must submit an annual report to ASIC that sets out the extent to which TPSing has complied with the conditions of this Notice.
- (2) A report mentioned in subsection (1) must include the following information:
 - (a) a description of the activities that TPSing has undertaken in the financial year in relation to the operation of the Platform;
 - (b) the number, duration, cause and resolution of material system outages that prevented Australian participants from using the Platform;
 - (c) the names and number of Australian participants authorised to access the Platform at the beginning and end of the financial year, respectively;
 - (d) details of the volume of trading on the Platform by Australian participants;
 - (e) the number and nature of significant complaints made to TPSing by Australian participants of the Platform, and the action taken by TPSing in response to each complaint;
 - (f) details of any significant conflicts of interest identified by TPSing in relation to its operation of the Platform, and how these were resolved;
 - (g) details of any significant change to the Singaporean regulatory requirements that affect TPSing's operation of the Platform.

12 Condition — Minister may require TPSing to submit to an audit

- (1) The Minister may, by notice in writing, require TPSing to obtain an audit report on the annual report mentioned in section 11 and on any information or statements accompanying the report.
- (2) The Minister may nominate:
 - (a) ASIC; or
 - (b) a specified person or body that is suitably qualified; to undertake an audit mentioned in subsection (1).

13 Condition — TPSing to give assistance to ASIC

TPSing must, if it receives a reasonable request to do so, give assistance to:

- (a) ASIC; or
- (b) a person authorised by ASIC;

in relation to the performance of ASIC's functions regarding the operation of the Platform.

Section 16

14 Condition — TPSing consents to the disclosure of information or documents

TPSing consents to the disclosure of any information or document relating to TPSing:

- (a) by the Monetary Authority of Singapore to ASIC; or
- (b) by ASIC to the Monetary Authority of Singapore.

15 Condition — TPSing must enter into a written agreement with ASIC

TPSing must enter into a written arrangement with ASIC for cooperation with ASIC in matters to which this Notice relates.

16 Condition — jurisdiction of Australian Courts

It is a condition of this exemption that TPSing submit to the jurisdiction of an Australian Court in an action brought by ASIC in relation to the Platform.

3 Definitions

In this Notice:

Act means the Corporations Act 2001.

Australian participant means a person in Australia who is a participant.

Class Order [CO 03/1099] means ASIC Class Order [CO 03/1099], entitled 'UK FSA regulated financial service providers':

- (a) issued by ASIC on 22 December 2003; and
- (b) notified in the Gazette on 23 December 2003; and
- (c) as in force on the commencement of this Notice.

Section 4

debenture means:

- (a) a debenture as defined in section 9 of the Act; or
- (b) a chose in action that includes an undertaking by a government to repay as a debt money deposited with or lent to the government; or
- (c) an undertaking to repay money deposited with or lent to a body by a person if:
 - (i) the person deposits or lends the money in the ordinary course of a business carried on by the person; and
 - (ii) the body receives the money in the ordinary course of carrying on a business that neither comprises nor forms part of a business of borrowing money and providing finance; or
- (d) an undertaking by a foreign bank to repay money deposited with it, or lent to it, in the ordinary course of its banking business.

foreign bank means a body corporate that:

- (a) is a foreign corporation within the meaning of paragraph 51 (xx) of the Constitution; and
- (b) is authorised to carry on banking business (within the meaning of subsection 5 (1) of the Banking Act 1959) in a foreign country.

foreign participant means a participant who is not an Australian participant.

ISDA Master Agreement means a master agreement issued by the International Swaps and Derivatives Association, Inc.

TradeWeb means TradeWeb Europe Ltd.

TradeWeb System means the financial market mentioned in section 4 that is operated by TradeWeb in respect of the financial products mentioned in section 6.

4 Exemption

- (2) TradeWeb must at all times hold a current Part IV permission from the United Kingdom Financial Services Authority, that covers the provision of the financial services provided by the TradeWeb System.
- (3) TradeWeb must, before commencing to operate the TradeWeb System, notify ASIC that it is complying with Class Order [CO 03/1099], in the form required by Class Order [CO 03/1099].
- (4) TradeWeb must continue to comply with Class Order [CO 03/1099].
- (5) TradeWeb, or an associate of TradeWeb, must not operate a clearing and settlement facility for the TradeWeb System.

6 Condition — financial products that may be traded on the TradeWeb System

TradeWeb must not trade in a financial product on the TradeWeb System, other than:

- (a) a debenture or bond, issued or proposed to be issued by:
 - (i) a government; or
 - (ii) an agency of a government; or
 - (iii) a semi-government agency; or
 - (iv) a body corporate; or
- (b) a derivative of:
 - (i) securities; or
 - (ii) interest rates; or
 - (iii) credit or credit-related indices;

that are typically entered into under the ISDA Master Agreement or another Master Agreement commonly used by counterparties for this purpose.

7 Condition — participants who may trade on the TradeWeb System

TradeWeb must not admit a participant to, or allow a participant to enter into a trade on, the TradeWeb System unless the participant is:

- (a) if the participant is an Australian participant a professional investor who is trading:
 - (i) on its own behalf; or
 - (ii) on behalf of another professional investor; or
- (b) if the participant is a foreign participant a professional or institutional investor in the jurisdiction in which the participant trades, trading:
 - (i) on its own behalf; or
 - (ii) on behalf of another professional investor.

Section 8

8 Condition — TradeWeb to report certain events involving an Australian participant

- (1) If TradeWeb takes any disciplinary action against an Australian participant of the TradeWeb System, TradeWeb must, as soon as practicable, advise ASIC in writing of:
 - (a) the participant's name; and
 - (b) the reason for, and nature of, the action taken.
- (2) If TradeWeb has information that would cause a person to believe or suspect, on reasonable grounds, that an Australian participant has committed, is committing or is about to commit, a significant contravention of the Act or the TradeWeb System's operating rules, TradeWeb must, as soon as practicable, advise ASIC in writing of:
 - (a) the Australian participant's name; and
 - (b) details of the contravention or impending contravention; and
 - (c) TradeWeb's reason for that belief or suspicion.

9 Condition — TradeWeb to report certain events involving TradeWeb or a director or secretary of TradeWeb

- (1) TradeWeb must, within 14 days, advise ASIC in writing if TradeWeb becomes aware that TradeWeb, or a director or secretary of TradeWeb:
 - (a) is the subject of a declaration of contravention in relation to a provision of the Act; or
 - (b) has been convicted of an offence under the Act; or
 - (c) has been disqualified from managing a corporation; or
 - (d) has been banned or disqualified from providing financial services.
- (2) TradeWeb must, within 7 days, advise ASIC in writing of TradeWeb ceasing to operate the TradeWeb System in Australia.

10 Condition — TradeWeb to submit annual report

- (1) Within 3 months of the end of its financial year, TradeWeb must submit an annual report to ASIC that sets out the extent to which TradeWeb has complied with the conditions of this Exemption Notice.
- (2) A report mentioned in subsection (1) must include the following information:
 - (a) a description of the activities that TradeWeb has undertaken in the financial year in relation to the operation of the TradeWeb System;
 - the number, duration, cause and resolution of material system outages that prevented Australian participants from using the TradeWeb System;
 - the names and number of Australian participants authorised to access the TradeWeb System at the beginning and end of the financial year, respectively;

- (d) details of the volume of trading on the TradeWeb System by Australian participants;
- (e) the number and nature of significant complaints made to TradeWeb by Australian participants of the TradeWeb System, and the action taken by TradeWeb in response to each complaint;
- (f) any specific regulatory issues that TradeWeb encountered during the year (including any change in regulatory status in its home jurisdiction), and actions taken to resolve those issues (whether inside or outside Australia);
- (g) details of any significant conflicts of interest identified by TradeWeb in relation to its operation of the TradeWeb System, and how these were resolved.

11 Condition — Minister may require TradeWeb to submit to an audit

- (1) The Minister may, by notice in writing, require TradeWeb to obtain an audit report on the annual report mentioned in section 10 and on any information or statements accompanying the report.
- (2) The Minister may nominate:
 - (a) ASIC; or
 - (b) a specified person or body that is suitably qualified; to undertake an audit mentioned in subsection (1).

12 Condition — TradeWeb to give assistance to ASIC

- (1) TradeWeb must, if it receives a reasonable request to do so, give assistance to:
 - (a) ASIC; or
 - (b) a person authorised by ASIC;
 - in relation to the performance of ASIC's functions regarding the operation of the TradeWeb System.
- (2) Assistance mentioned in subsection (1) may include access to any information, documents or books held by or relating to TradeWeb.

13 Condition — TradeWeb must enter into a written cooperation arrangement with ASIC

TradeWeb must enter into a written cooperation arrangement with ASIC for cooperation with ASIC in matters to which this Notice relates.
