  - (c) SP Australia Networks (Distribution) Ltd ACN 108 788 245 (SP Distribution),

as if Chapter 6D of the Act were modified or varied by omitting paragraph 708A(5)(e) of the Act in respect of an offer for sale of shares in SP Transmission or SP Distribution issued to Singapore Power in the case set out in the Schedule.

- 1. in paragraph 601GAA(2)(b)(ii) as notionally inserted into Chapter 5C by ASIC Class Order CO 05/26, omit "or (12B)" and substitute ", (12B) or (12BA)"; and
- 2. after subsection 601GAA(12B) as notionally inserted into Chapter 5C by ASIC Class Order 05/26, insert:

Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 5C of the Act applies to SP Australia Networks (RE) Ltd ACN 109 977 371 (RE) in its capacity as the responsible entity of SP Australia Networks (Finance) Trust ARSN 116 783 914 (Trust) in the case set out in the Schedule as if Chapter 5C of the Act were modified or varied as follows:
  - (a) omit paragraph 601FC(1)(c) and substitute:
    - "(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and their interests as holders of shares in a company, where the interests and shares are components of a stapled security) and, if there is a conflict between the interests of the members and the interests of the responsible entity, give priority to the members' interests; and"; and
  - (b) omit paragraph 601FD(1)(c) and substitute:
    - "(d) act in the best interests of members (having regard to their interests as holders of interests in the scheme and their interests as holders of shares in a company, where the interests and shares are components of a stapled security) and, if there is a conflict between the interests of the members and the interests of the responsible entity, give priority to the members' interests; and"; and
  - (c) after subsection 601GAA(9) as notionally inserted into Chapter 5C by ASIC Class Order CO 05/26, insert:
    - "(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
      - (a) the constitution makes provision for the issue price of stapled securities; and
      - (b) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the constitution; and
      - (c) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests; and

- (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution."; and
- (d) insert after notional subsection 208(2) of the Act as inserted by section 601LC:
  - "(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if:
    - (a) the benefit either:
      - (i) is given out of the scheme property of a registered scheme (the *scheme*); or
      - (ii) could endanger the scheme property; and
    - (b) each of the interests in the scheme is a component part of a stapled security together with shares in a company or companies; and
    - (c) the benefit is given by:
      - (i) the responsible entity of the scheme; or
      - (ii) an entity that the responsible entity controls; or
      - (iii) an agent of, or person engaged by, the responsible entity; and
    - (d) the benefit is given to:
      - (i) an entity that is wholly owned, whether directly or indirectly, by the scheme; or
