#### Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 655A(1)(b) – Declaration

Under paragraph 655A(1)(b) of the *Corporations Act 2001* (the *Act*), the Australia Securities and Investments Commission (*ASIC*) declares that Chapter 6 of the Act applies to Centric SaleCo Pty Limited ACN 127 001 733 (*SaleCo*), in the case referred to in the Schedule, as if item 7 of section 611 of the Act were modified or varied by deleting paragraph (a) and replacing it with the following paragraph:

"(a) no votes are cast in favour of the resolution by the person proposing to make the acquisition and their associates; and".

      - (b) all of the interests in the scheme together with all the shares in a company are component parts of stapled securities; and

    - (i) the interest and a share in a company must, under the terms on which each are to be traded, only be transferred together; and
    - (ii) there are no financial products in the same class as those financial products which may be transferred separately.";

- (d) after section 601PC insert:
  - "601PD For the purposes of sections 601FC and 601FD, stapled security means two or more financial products including at least one interest in a registered scheme where:
    - (a) under the terms on which each of the products are to be traded, they must be transferred together; and
    - (b) there are no financial products in the same class as those financial products which may be transferred separately."; and
- (e) after subsection 601GAA(9) as notionally inserted into Chapter 5C by ASIC Class Order [CO 05/26] insert:
  - "(9A) The responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
    - (a) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the scheme constitution;
    - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;
    - (c) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution.".
- 2. Under paragraph 741(1)(b) of the Act, ASIC declares that Part 6D.2 of the Act applies to Valad Select Property Limited ACN 124 694 248 (*Company*) in the case set out in Schedule B as if subsection 708(13) were modified by omitting paragraph 708(13)(b) and substituting:

    - (iv) in an issue situation the offer or issue that constitutes the relevant conduct is an offer or issue of interests in a registered managed investment scheme, under a plan for the reinvestment of one or both of:
      - (A) distributions in respect of interests in the scheme;
      - (B) dividends in respect of shares in a body which, on the terms on which they may be traded, must only be transferred together with interests in the scheme.".
- 4. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies to the Company, and VSPML in its capacity as responsible entity of the Trust, in the case referred to in Schedule C as if subsection 1017E(2) of the Act were modified or varied as follows:
  - (a) at the beginning of paragraph 1017E(2)(b) of the Act insert "subject to paragraph (ba),"; and
  - (b) after paragraph 1017E(2)(b) insert:

    - "In this Division, a reference to acquiring securities, when used in relation to non-transferable securities, includes securing binding commitments from holders to the surrender or forfeiture of the rights attached to those securities and the cancellation of those securities";
  - (b) Subsection 666B(1) of the Act were modified or varied by adding the words ", in the case of securities that are capable of being transferred," before the word "the" where first appearing; and

- "(1) Under this section, in the case of securities that are not capable of being transferred, the person acquiring the securities must:
  - (a) give the company that issued the securities a copy of the compulsory acquisition notice under section 661B or 664C together with a deed poll providing for the surrender or forfeiture of the rights attached to those securities and the cancellation of those securities by someone appointed by the person acquiring the securities; and
  - (b) pay, issue or transfer the consideration for the surrender or forfeiture of the rights attached to those securities and the cancellation of those securities to the company that issued the securities.

The person appointed under paragraph (a) has authority to sign the deed poll on behalf of the holder of the securities.

- (2) If the person acquiring the securities complies with subsection (1), the company that issued the securities must:
  - (a) cancel the securities; and
  - (b) hold the consideration received under subsection (1) in trust for the person who held the securities immediately before the surrender or forfeiture of the rights attached to those securities and the cancellation of those securities; and
  - (c) give written notice to the person referred to in paragraph (b) as soon as practicable that the consideration has been received and is being held by the company pending their instructions as to how it is to be dealt with.
- (3) If the consideration held under subsection (2) consists of, or includes, money, that money must be paid into a bank account opened and maintained for that purpose only."
