## Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 601QA(1)(b) – Declaration 0 8 - 0 4 6 0

Under paragraph 601QA(1)(b) of the *Corporations Act 2001 (Act*), the Australian Securities and Investments Commission declares that Chapter 5C of the Act applies to the person referred to in the Schedule as if section 601GAB as notionally inserted into the Act by ASIC Class Order [CO 05/26] were further modified or varied as follows:

- in subsection (1), omit "subsection (2)", and substitute "subsections (2) or (2A)"; and
- 2. after subsection (2), insert the following subsection:
  - "(2A) The constitution may provide an alternative formula or method when the interests of the scheme are quoted on a financial market where:
    - (a) the formula or method is based on the value of scheme property less any liabilities that under the constitution may be met from that property divided by the number of interests on issue and may make allowance for the expenses that are associated with acquiring scheme property; and
    - (b) the constitution contains a provision to the effect that if the issue price is set in accordance with a formula or method that is covered by paragraph (a), the issue price must be greater than or equal to the issue price that is determined by using a formula or method under subsection (2)."; and
- 3. in subsection (13), omit "Subsections (2) and (5)", and substitute "Subsections (2), (2A) and (5)".

- 7. inserting after the words "(see subsection (4))" in subparagraph 1016E(1)(b)(i) the following:
  - "or within 7 days after the date of issue of the product"; and
- 8. inserting after the words "the relevant date" in subparagraph 1016E(1)(b)(ii) the following:

" or the date of issue of the product".

  - (a) omit Note 2 in section 916D, substitute:
    - "Note 2: There are exceptions to this rule in sections 916E and 916EA"; and
  - (b) in subsection 916D(2B) omit "section 916E.", substitute "sections 916E or 916EA."; and
  - (c) in subsection 916E(1) omit "insurer.", substitute "insurer or provides general advice in relation to risk insurance products that are within the scope of the binder."; and
  - (d) in subsection 916E(2) omit "the binder:", substitute "the binder or provides general advice in relation to risk insurance products that are within the scope of the binder:"; and
  - (e) after section 916E insert:

## "916EA Licensees acting under authority other than binder

- (1) Despite section 916D, a financial services licensee (the *authorised licensee*) may be the authorised representative of another financial services licensee who is an insurer, if the authorised licensee acts under a written agreement (*written agreement*) which authorises the authorised licensee to deal in, and provide general advice in relation to, risk insurance products on behalf of the insurer.
- (2) For all purposes connected with contracts that are risk insurance products, or with claims against the insurer, in respect of which the authorised licensee acts under the written agreement:
  - (a) the authorised licensee is taken to act on behalf of the insurer and not the insured; and
  - (b) if the insured in fact relied in good faith on the conduct of the authorised licensee, the authorised licensee is taken to act on behalf of the insurer regardless of the

fact that the authorised licensee did not act within the scope of the authorisation.

- (3) This section does not apply where the licence of the authorised licensee covers the provision of any financial services in relation to any risk insurance products.".
- 2. Under paragraph 951B(1)(c) of the Act, ASIC declares that Part 7.7 of the Act applies to the persons specified in Schedule B in the case set out in Schedule C as if the following provisions were omitted, modified or varied:
  - (a) in section 940A omit "section 916E", substitute "sections 916E or 916EA."; and
  - (b) after subparagraph 942C(2)(j)(iii) insert:
    - "(iv) the providing entity is taken to act on behalf of the authorising licensee and not the client for any general advice given by the providing entity in relation to risk insurance products that are within the scope of the binder; and
    - (v) the authorising licensee is responsible, as between the authorising licensee and the client, for any general advice given by the providing entity in relation to risk insurance products that are within the scope of the binder; and"; and
  - (c) after paragraph 942C(2)(j) insert:
    - "(ja) if the providing entity is an authorised licensee acting under a written agreement under section 916EA in providing any of the authorised services—a statement that:
      - (i) identifies the services provided under the written agreement; and
      - (ii) states that they are provided under the written agreement; and
      - (iii) explains the significance of the services being provided under the written agreement; and
      - (iv) the providing entity is taken to act on behalf of the authorising licensee and not the client; and
      - (v) the authorising licensee is responsible, as between the authorising licensee and the client for the conduct of the providing entity; and".

"must either:

- (b) propose a related body corporate to be the new responsible entity in accordance with subsection (1A).";

  - "(1A) The requirements for proposing a related body corporate to be the new responsible entity are as follows:
    - (a) the responsible entity must give members notice of a proposal to choose a company (the *proposed responsible entity*), which is a wholly-owned subsidiary of the responsible entity's holding company, to be the scheme's new responsible entity.
    - (b) the notice to members must:
      - (i) set out:
        - (A) the responsible entity's reasons for wanting to retire; and
        - (B) such information as can reasonably be expected to be material to a member in forming a view as to the choice of the proposed responsible entity; and
      - (ii) state prominently that if:
        - (A) members who together hold at least 5% of the total value of the interests held by members; or

## (B) 100 members,

who would be entitled to vote if the proposal were put as a proposed resolution to a meeting of members under paragraph (1)(a), ask for a vote on the choice of the proposed responsible entity by giving written notice received by the responsible entity within 21 days from the date the notice is sent, the responsible entity will either arrange a postal vote or convene a meeting to vote on a resolution for the choice of the proposed responsible entity; and

- (iii) be accompanied by a form which can be ticked to ask for a vote; and
- (iv) state prominently a reply paid address of the responsible entity to which the form may be sent.
- (c) if sufficient members ask for a vote in accordance with the notice, the responsible entity must arrange for a postal vote or, if the responsible entity chooses, convene a meeting in accordance with Part 2G.4 to vote on the choice of the proposed responsible entity as soon as possible.
- (d) if there is a postal vote:
  - (i) a voting paper must be sent to each member stating a reply paid address of the responsible entity to which the voting paper may be sent; and
  - (ii) the responsible entity must notify the members in, or in a document accompanying, the voting paper that:
    - (A) the proposed responsible entity will be chosen as the new responsible entity if at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the choice; and
    - (B) only votes received by the responsible entity within 28 days after the issue of the voting paper will be counted.
- (e) if a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed."; and
- 3. inserting after subsection (2), the following subsections:
  - "(2A) If a postal vote is arranged under paragraph (1A)(c) and at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the proposed responsible entity, that entity is taken for the purposes of

subsection (2) to have been chosen by a resolution of members on the last day on which postal votes may be received in order to be counted.

#### (2B) If:

- (a) a related body corporate is proposed to be the new responsible entity in accordance with subsection (1A); and
- (b) sufficient members do not ask for a vote to choose the entity in accordance with the notice referred to in paragraph (1A)(b); and
- (c) the entity has consented in writing to becoming the scheme's responsible entity,

then:

- (d) as soon as practicable and in any event within 2 business days after the end of the period in which a member may ask for such a vote, the current responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme's registration to name the proposed responsible entity as the scheme's responsible entity; and
- (e) the notice must be accompanied by a certificate from the current responsible entity that it reasonably considers that the appointment of the proposed responsible entity would be in the best interests of members with a summary of the responsible entity's reasons as to why this is the case; and
