Australian Securities and Investments Commission Corporations Act 2001 – Subsection 741(1) – Exemption

Under subsection 741(1) of the Corporations Act 2001 (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A (*issuer*), in the case referred to in Schedule B, from Parts 6D.2 and 6D.3 of the Act (other than sections 736 and 738).

SCHEDULE B

A written offer for the issue of shares in the issuer where the following requirements are met at the time that the offer is made.

- (a) The shares are in a class which is quoted on the financial market operated by ASX Limited (the *class*) and trading in the class is not suspended.
- (b) None of the following provisions of the Act have been contravened in relation to the issuer of the shares in the previous 12 months:
 - (i) a provision of Chapter 2M;
 - (ii) section 674 or 675;
 - (iii) section 724;

 - (iii) the issue price is less than the market price during a specified period in the 30 days prior to either the date of the offer or the date of the issue;

- (iv) no registered holder may be issued with shares with an application price totalling more than \$10,000 in any consecutive 12 month period; and
- a registered holder must provide the issuer on application for the shares with a certification to the effect that the aggregate of the application price for:
 - (A) the shares the subject of the application; and
 - (B) any other shares in the class applied for by the holder under the arrangement or any similar arrangement in the 12 months prior to the application,

does not exceed \$10,000.

- (d) The written offer document contains the following information:
 - (i) the method used to calculate the issue price and the time when this price will be determined:
 - (ii) a statement describing the relationship between the issue price and the market price; and
 - (iii) disclosure of the risk that the market price may change between the date of the offer and the date when the shares are issued to an applicant under the arrangement, and the effect this would have on the price or value of the shares which the applicant would receive.

Interpretation

For the purposes of this instrument:

- registered holder means, subject to paragraphs 2 and 3, a person recorded in the register of members of a company as a member of that company;
- if 2 or more persons are recorded in the register of members as jointly holding shares in the company they are taken to be a single registered holder and a certification by any of them for the purposes of paragraph (c)(v) of Schedule B is taken to be a certification by all of them;
- 3. if a trustee or nominee is expressly noted on the register of members as holding shares on account of another person (a *beneficiary*):
 - the beneficiary is taken to be the registered holder in regard to those shares; and

- any application for the issue of shares or certification for the purposes of paragraph (c)(v) of Schedule B by, and any issue of shares to, the trustee or nominee, is taken to be an application or certification by, or an issue to, the beneficiary; and
- 4. references to an issuer offering shares include the issuer inviting applications for the issue of the shares.
