- (1) The responsible entity of a registered scheme may allow a member to withdraw from the scheme in accordance with a provision of the scheme's constitution that provides for the member to have a right to withdraw when the responsible entity is satisfied that the member has experienced hardship or is likely to experience hardship or, where the member is an operator, a person who has asked the operator to exercise a right to withdraw has experienced hardship or is likely to experience hardship if the member is not allowed to withdraw (a *hardship withdrawal*).
- (1A) In this section an *operator* means a person who is a member of the scheme in its capacity as responsible entity or custodian of a registered scheme, trustee of a trust, trustee or custodian of a superannuation entity within the meaning of the *Superannuation Industry (Supervision) Act 1993*, trustee of a self-managed superannuation fund within the meaning of the *Superannuation Industry (Supervision) Act 1993* or provider or acquirer in relation to a custodial arrangement as defined in section 10121A.
- (2) The responsible entity may only allow one hardship withdrawal because of the hardship of a person, and must not allow a hardship withdrawal unless the responsible entity is satisfied that:
  - (a) following that withdrawal the scheme property would include sufficient liquid assets for the day to day operation of the scheme; and

- (b) satisfying the hardship withdrawal request would not breach the person's hardship withdrawal cap; and
- (c) any amount paid on withdrawal to an operator will be paid to the person who asked the operator to make a hardship withdrawal request after deduction of any fees and charges payable to the operator.

Note: In making any payment to a person on whose behalf a request for hardship withdrawal has been made, an operator must comply with any obligations under the terms of the relevant trust or arrangement under which it acts and other applicable laws. For example the responsible entity of a registered scheme must comply with Part 5C.6 as modified by any relief applicable to that scheme and the trustee of a superannuation entity or self managed superannuation fund must comply with requirements under the Superannuation Industry (Supervision) Act 1993.

- (3) For the purposes of this section the *hardship withdrawal cap* for a person is the lesser of:
  - (a) the specific amount the subject of a hardship withdrawal request in respect of hardship of the person; and
  - (b) \$20,000 plus 50% of the balance of the person's interest in the scheme, however held.
- (4) If a constitution includes a provision permitting the responsible entity to exercise a discretion in relation to a hardship withdrawal the responsible entity must comply with subsections (5) to (7).

Exercise of discretion must be reasonable

(5) The responsible entity or its nominee must act reasonably in exercising a discretion covered by subsection (4).

Note: The responsible entity is also subject to its general duties under section 601FC including the duty to act in the best interests of the members of the scheme.

Documentation of exercise of discretion

(6) The responsible entity must ensure that the records which it keeps under section 988A document how and why a decision to permit or refuse a hardship withdrawal was made.

Access to and retention of documents

(7) The responsible entity must retain the documents covered by subsection (6) for 7 years after they cease to be current."

# Corporations Act Section 657A Declaration of Unacceptable Circumstances

#### In the matter of MYOB Limited

#### **WHEREAS**

- 1. MYOB Limited (MYOB) is the subject of an off-market takeover bid by Manhattan Software Bidco Pty Limited (Manhattan)
- 2. In its initial announcement of the takeover bid, and in the bidder's statement, Manhattan disclosed that each of Guinness Peat Group Australia, Colonial First State Global Asset Management Australian Equities, Growth Team, Octavian Special Master Fund LP and Schroders Investment Management (collectively, the investors) had indicated an unqualified intention to accept the takeover bid as soon as it opened
- 3. These statements by Manhattan to which the investors consented evidenced an understanding between Manhattan and each investor. The understanding was also evidenced by discussions and correspondence between the parties before the bid was announced
- 4. The understanding gave Manhattan a relevant interest in approximately 34% of the issued shares in MYOB held by the investors prior to the bid,

(collectively, the circumstances).

- 5. It appears to the Panel that the circumstances are unacceptable:
  - (a) having regard to the effect that the Panel is satisfied that the circumstances have had, are having, or are likely to have, on the control or potential control of MYOB
  - (b) having regard to the purposes of Chapter 6 set out in section 602 of the *Corporations Act* 2001 (Cth) (the **Act**) or
  - (c) because they constituted or constitute, or gave or give rise to a contravention of section 606 of the Act.
- The Panel considers that it is not against the public interest to make a declaration of unacceptable circumstances in relation to the circumstances and the affairs of MYOB Limited.
- 7. The Panel has had regard to the matters in section 657A(3) of the Act.

# **DECLARATION**

Under section 657A, the Panel declares that the circumstances constitute unacceptable circumstances in relation to the affairs of MYOB Limited.

If a superior proposal for the acquisition of all the shares in MYOB is announced prior to 9 December 2008, each investor must accept (or, if a scheme, vote in favour of) that superior proposal in respect of all of their MYOB shares in the absence of a further superior proposal (which may include an improved offer by Manhattan).
- 4. Manhattan, MYOB or any investor may apply to the Panel, after having given 24 hours notice in advance to each party, seeking a variation of these orders including an order adapting paragraph 3 in respect of non-cash consideration, conditions and proposed or actual transactions other than a takeover offer open for acceptance.
- 5. From the date of these orders, each investor must not lodge an acceptance into an institutional acceptance facility established for the purposes of the bid (*IAF*) prior to 9 December 2008. If an investor lodged an acceptance into an IAF before the date of these orders, that acceptance must be withdrawn forthwith. Each investor and Manhattan must take any action required to effect that withdrawal.

6. Manhattan must forthwith prepare and lodge a supplementary bidder's statement which explains these orders. The explanation must be in a form approved by the Panel.

# Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 601QA(1)(a), 926A(2)(b), 992B(1)(b) and 1020F(1)(b) — Exemption

# Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 601QA(1)(a), 926A(2)(b), 992B(1)(b) and 1020F(1)(b) of the *Corporations Act 2001* (the *Act*).

#### Exemption

- 2. Universal Self Storage Pty Ltd ACN 116 432 565 as trustee for the AGJ Dean Family Trust (*operator*) who operates the service strata scheme (*serviced strata scheme*) which involves an owner (*investor*) of real property (*strata unit*), in the investor's discretion, making their strata unit available for use by the operator as part of storage complex described as Lot 466 on SP 121181 located at 32 Campbell Street, Slade Point in the State of Queensland developed in accordance with an approval from the Mackay City Council that was provided to ASIC on 3 November 2008 and in relation to which, on 1 March 2000, there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme does not have to comply with section 601ED of the Act.
- 3. An interest in the serviced strata scheme is exempt from the following provisions of the Act:
  - (a) Part 7.6 (other than Divisions 4 and 8); and
  - (b) section 992AA; and
  - (c) section 1017F.

# Where exemption applies

- 4. The exemption in paragraphs 2 and 3 only applies where all of the following requirements are satisfied:
  - (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;

- (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:
  - (i) by a person other than the operator or an associate of the operator; and
  - (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;
- (c) each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
- (d) the operator is licensed in relation to the conduct of the letting services under the law of a State or Territory or is a financial services licensee;
- (e) no payment is liable to be made by an investor to participate in the scheme other than:
  - (i) payment of money to buy the strata unit; and
  - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate;
- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme;
- (g) the storage complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in paragraph 5;
- (h) the operator takes reasonable steps to ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution is held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
- (i) each person that is involved in making an offer of interests in the scheme for issue does not engage in any misleading or deceptive conduct or conduct that is likely to mislead or deceive in connection with those offers;
- (j) the operator complies with the provisions specified in paragraph 5 which are included in the agreement referred to in subparagraph (g).

### Terms of agreement between investor and operator

- 5. The agreement specified in subparagraph 4(g) is to contain provisions to the following effect:
  - (a) Transfer of management rights
    - (i) If a majority of scheme members advise the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme; and
    - (ii) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice; and
    - (iii) A transfer referred to in subparagraph (i) or (ii) must be done as soon as practicable, but if there is a body corporate for the real property to which the scheme relates, there must be a reasonable time for members of the body corporate to consider whether to make a decision referred to in subparagraph (b)(ii) unless the body corporate has consented to the transfer; and
  - (b) Consent of body corporate to new care-taking arrangements
    - (i) If an operator receives a notice under subparagraph (a)(i), the operator must advise all body corporate members of the name of the person to whom the transfer is to be made; and
    - (ii) Unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in subparagraph (a)(ii) if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions; and
    - (iii) If a majority of body corporate members make a decision referred to in subparagraph (b)(ii), a majority of scheme members may then at any time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with subparagraph (a)(ii); and

- (iv) This subparagraph does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under subparagraph (a)(ii) or (b)(iii) before that notice is given to the operator; and
- (c) Price payable on transfer

The price scheme members specify in a notice under subparagraph (b)(ii) must be one of the following:

- (i) the average of two valuations of the management rights by independent qualified valuers nominated by the Australian Property Institute (or another relevant independent professional body approved by ASIC); or
- (ii) the highest bona fide bid for the management rights (excluding a bid by the operator or its associates) at an auction of which at least 60 days' notice had been given; or
- (iii) the highest bona fide amount tendered (excluding any tender by the operator or its associates) for the management rights following reasonable efforts to market the property for at least 60 days; and

# (d) Voting

- (i) In determining if there is a majority of scheme members or body corporate members, the operator and its associates and any person nominated as a replacement operator and associates of that person must not be counted; and
- (ii) For scheme members, a majority is based on their entitlement to vote at body corporate meetings if there is a body corporate for the property to which the scheme relates, and otherwise each member shall have one vote; and
- (iii) For body corporate members, a majority is based on their entitlement to vote at body corporate meetings; and
- (iv) A scheme member or a body corporate member makes a decision by signing a document that sets out the decision; and

### (e) Costs

(i) Any member may arrange a valuation or auction of, or may market, the management rights before or after the expiration of the 9 month period referred to in subparagraph (a)(i) for the purposes of determining a price to be specified in a notice under subparagraph (a)(ii); and

(ii) If a member incurs any reasonable valuation, auction or marketing costs under subparagraph (i) that member is entitled to be reimbursed out of the price payable by any person nominated by the members as transferee of the management rights when the price is paid to the operator; and

#### (f) Assistance

The operator must give reasonable assistance to enable the transferee to operate the storage complex including making available information concerning any prospective bookings; and

# (g) Definitions

In this paragraph:

scheme members means investors in the scheme excluding the operator and its associates.

*management rights* means all real or personal property (including contractual rights) held by the operator or any of its associates that facilitates the operation of the scheme.

*transfer* in relation to management rights means to assign or transfer the management rights or to cause another person to become the holder of those rights or rights substantially the same as those rights.
