NOTICE OF DECISION

At a hearing held pursuant to section 1294
Corporations Act 2001 (the Act) on 1 February 2022,
a Panel of the Companies Auditors Disciplinary
Board (Panel) decided that it was satisfied, on an
application by the Australian Securities and
Investments Commission (ASIC) that Mr Jakin
Leong LOKE, a registered company auditor has
failed to carry out or perform adequately and
properly the duties of an auditor within the meaning
of sub-section 1292(1)(d)(i) of the Act.

On 03 March 2022, the Panel decided to exercise its powers under sub-sections 1292(1) and 1292(9)(b) of the Act by ordering that:

- 1. The registration of Mr Jakin Leong Loke as a company auditor be suspended for a period of twelve (12) months. This order to come into effect from the end of the day on 3 March 2022, being the day on which Mr Loke was provided with this Notice of Decision pursuant to ss1296(1)(a) of the Act.
- 2. Mr Loke provide undertakings to ASIC, as set out in Schedule A to the Board's Final Decision and Reasons. This order to come into effect within seven (7) days of the date of this order, being 03 March 2022.

The Panel further ordered, pursuant to section 223 of the ASIC Act that Mr Loke pay the Applicant's costs in the fixed sum of \$95,000 within twenty-eight (28) days of the date of this order, being 03 March 2022.

A copy of the written decision and reasons dated 03 March 2022 accompanies and forms part of this Notice.
