The Australian Securities and Investments Commission (ASIC) collects personal information for the purposes of administering the Financial Accountability Regime (FAR) jointly with the Australian Prudential Regulation Authority (APRA).

Authority and Purpose for collection	We are required or authorised to collect information in relation to accountable entities, significant related entities, and accountable persons ¹ for the purposes of administering the <i>Financial Accountability Regime Act 2023</i> (Cth) (the FAR Act) and the <i>Financial Accountability Regime (Consequential Amendments) Act 2023</i> (the FAR Consequential Amendments Act).
	We collect personal information, ² which may include sensitive information, ³ for the purpose of our regulatory functions under the FAR Act and the FAR Consequential Amendments Act which include:
	 maintaining a register of accountable persons for all entities which are subject to the FAR understanding the accountability obligations of an accountable person performing supervisory activities in connection with the administration of the FAR, and any associated investigation or enforcement activity, and handling and responding to queries and requests received in relation to the FAR.
How we collect information	Under the FAR, we will obtain information about accountable entities, significant related entities and accountable persons through the registration process, lodgements, notification obligations and requests for information.
	Where ASIC has obligations under the FAR, ASIC mainly obtains relevant personal information from APRA that APRA has collected through APRA Connect.
	ASIC may also collect personal information through other communications for the purposes of the FAR.ASIC collects personal information directly from individuals or their authorised representatives. We only collect personal information from third parties where:
	 the individual has consented to the third party providing their personal information to ASIC we are required or authorised to collect the personal information from third parties by law, or

What information is collected? 	 accountable individuals, accountability statements and maps, and 5. information associated with contraventions of the FAR Act including breaches and disqualifications. ASIC will only generally collect personal information in respect of entities that hold an Australian financial services licence or an Australian credit licence.
Consequences of not providing your personal information	If ASIC does not collect this personal information, the failure to provide the information to ASIC may amount to a breach of reporting and notification obligations imposed by the FAR Act on accountable entities, significant related entities and accountable persons. In some circumstances, an accountable entity that fails to comply with obligations under Part 6 of the FAR Act to notify ASIC and/or APRA of matters relating to accountable persons and their responsibilities would be liable to a civil penalty.
	Failure by an accountable person to comply with accountability obligations under Part 3 of the FAR Act which includes dealing with ASIC and/or APRA in an open, constructive and cooperative way ⁵ may lead to reduction of their variable remuneration or disqualification by ASIC and/or APRA.
Disclosure to other bodies or persons	The FAR permits ASIC and APRA to make information from the FAR register publicly available. We will disclose accountable person disqualifications made under the FAR to facilitate industry governance of accountable persons. Further information on the entities, bodies or persons, or the types of entities, bodies or persons, to which we may disclose personal information, is available in the <u>ASIC Privacy Policy</u> . We are unlikely to disclose your personal information overseas. We will not disclose personal information outside of Australia without an individual's express or implied consent, or we will disclose as otherwise permitted by APP 8 – Cross-border disclosure of personal information.
Access, correction and complaints	 The <u>ASIC Privacy Policy</u> contains information about how you can: seek access to or correct your personal information make a complaint about our handling of your personal information. Additionally, certain personal information can be accessed by logging onto APRA Connect. Requests to correct personal information of an individual on APRA Connect can be made by submitting a notification return by the FAR administrator of the relevant individual's employer or another representative or employee authorised to carry out FAR related
