**1. Name**

This is the *Australian Market Licence (ICE Endex Markets B.V.) 2022*.

**2. Commencement**

This Licence commences when it is granted.

**3. Definitions**

In this Licence unless the contrary intention appears, terms defined in the Act have the same meaning in this Licence and:

*Act* means the *Corporations Act 2001*.

*ASIC* means the Australian Securities and Investments Commission.

*Australian client* means, in relation to a participant in the Market, a person in this jurisdiction on whose behalf the participant deals on the Market.

*Australian participant* means:

- (a) an Australian entity that is a participant in the Market;
- (b) a foreign branch or office of an Australian entity where:
  - (i) the foreign branch or office of the Australian entity is a participant in the Market; or
  - (ii) the Australian entity is a participant in the Market.
- (c) an Australian branch or office of a foreign entity where:
  - (i) the Australian branch or office is a participant in the Market; or
  - (ii) the foreign entity is a participant in the Market.

*foreign participant* means a participant in the Market who is not an Australian participant.

*Licensee* means ICE Endex Markets B.V. ARBN 654146577.

*Market* means the financial market the Licensee is authorised to operate under this Licence.

*reporting period* means each period of 3 months, or part thereof, during which the Market is operated in Australia, ending on 31 March, 30 June, 30 September, or 31 December.

**4. Grant of Licence**

- (1) The Licensee is granted a licence to operate a financial market through which participants may make or accept offers to acquire or dispose of derivatives.

**5. Participants**

- (1) It is a condition of this Licence that the Licensee must ensure that each Australian participant:
- (a) is a professional investor, or is a branch or office of an entity that is a professional investor; and
  - (b) only deals on the Market on their own behalf or on behalf of a person who is a professional investor.

**6. Clearing and settlement arrangements**

- (1) It is a condition of this Licence that the Licensee must:
- (a) clearly inform participants of the Market of their respective responsibilities in relation to the clearing and/or settlement of trades entered into on the Market; and
  - (b) have in place adequate arrangements to facilitate the efficient clearing and/or settlement of trades entered into on the Market, which must be arrangements of one or more of the following types:
    - (i) arrangements for the clearing and settlement of the trades with a clearing and settlement facility; or
    - (ii) arrangements to:
      - a. notify each party to a trade entered into on the Market of the identity of the other party to the trade; or
      - b. otherwise be satisfied that each party to a trade entered into on the Market knows the identity of the other party to the trade,
- so that the parties to the trade can settle the trade in accordance with arrangements agreed between them.

**7. Periodic trade reporting**

- (1) It is a condition of this Licence that the Licensee must give to ASIC, in a machine-readable format, at least the following information within 30 days after the end of each reporting period, for each product specified in the following table:

- (a) the total number of trades and their total value, in AUD-equivalent terms, of trades during the reporting period by all participants; and
- (b) the total number of trades and their total value, in AUD-equivalent terms, of trades during the reporting period by each Australian participant, identifying each Australian participant by their registered name and, if applicable, their branch name and, if available, their Legal Entity Identifier; and
- (c) the total number of trades and their total value, in AUD-equivalent terms, of trades during the reporting period by each foreign participant but only in relation to the trades that the Licensee believes to be trades on behalf of one or more Australian clients, identifying each foreign participant by their registered name and, if applicable, their branch name and, if available, their Legal Entity Identifier; and
- (d) the total number of trades and their total value, in AUD-equivalent terms, of the trades that are included in the information in (b) and (c) above and which are trades between any two participants listed in (b) and (c) above.

## 8. Market ceases to operate

- (1) It is a condition of this Licence where the Licensee intends to cease operating the Market in this jurisdiction, the Licensee must:
  - (a) establish, document and implement adequate arrangements for ensuring, as applicable, the orderly cessation of the Market;
  - (b) notify ASIC:
    - (i) that the Licensee intends to cease operating the Market in this jurisdiction, as soon as reasonably practicable;
    - (ii) of the arrangements referred to in paragraph (a), as soon as reasonably practicable before ceasing to operate the Market in this jurisdiction; and
    - (iii) of any changes to the arrangements referred to in paragraph (a) following the notification in subparagraph (ii), as soon as reasonably practicable after making those changes.

**Australian Securities and Investments Commission  
Corporations Act 2001 (Cth) – Paragraphs 926A(2)(a), 992B(1)(a) and 1020F(1)(a)  
– Exemptions**

**Enabling legislation**

1. The Australian Securities and Investments Commission makes this instrument under:
  - (a) paragraph 926A(2)(a) of the *Corporations Act 2001 (Cth)* (*the Corporations Act*);
  - (b) paragraph 992B(1)(a) of the Corporations Act; and
  - (c) paragraph 1020F(1)(a) of the Corporations Act.

**Title**

2. This instrument is ASIC Instrument 22-0992.

**Commencement**

3. This instrument commences on the date it is signed.

**Exemptions**

4. Lextech Pty Ltd (ACN 626 621 789) (*Lextech*) does not have to comply with:
  - (a) Part 7.6 of the Corporations Act (other than Division 4 and Division 8);
  - (b) Part 7.8 of the Corporations Act; and
  - (c) Part 7.9 of the Corporations Act.

**Where exemptions apply**

5. The exemptions in paragraph 4 apply where each of the following is satisfied:
  - (a) Lextech is the Electronic Lodgment Network Operator of the Lextech Electronic Lodgment Network;
  - (b) Lextech provides a financial service only by dealing in, or providing general advice in relation to, a facility through which, or through the acquisition of which, a person makes non-cash payments;
  - (c) the non-cash payment facility is provided in connection with the use of the Lextech Electronic Lodgment Network to enable the payment or completion of an associated financial transaction;

- (d) Lextech has internal dispute resolution procedures of the kind referred to in paragraph 912A(2)(a) that cover any financial services provided to a person who makes non-cash payments through the Lextech Electronic Lodgment Network;
- (e) Lextech's agreement with Subscribers provides that:
  - (i) where a person reports a payment has, or may have, been made to the wrong recipient through the Lextech Electronic Lodgment Network, Lextech must take all reasonable steps to as soon as practicable, and at most within 3 business days of the report being made:
    - (A) determine whether the payment has been made to an incorrect recipient;
    - (B) contact the financial institution that has received the incorrect payment to request it to take reasonable actions to assist to remedy the payment error, including requesting return of the funds as appropriate; and
  - (ii) where the payment has been made to a wrong recipient and that recipient is a Subscriber, the recipient must take all reasonable steps to assist to recover, remedy or resolve the incorrectly received payment, including by returning the funds to an account nominated by the Subscriber who made the payment instruction within the Lextech Electronic Lodgment Network that resulted in the payment being made to the wrong recipient; and
- (f) prior to providing the financial service referred to in paragraph 5(b) Lextech has obtained independent review and sign-off from a person with appropriate skills and qualifications, on the components of the Lextech Electronic Lodgment Network required to complete financial settlement to ensure that such system components are fit for purpose, including:
  - (i) management of risks and liabilities involved with incorrect payments;
  - (ii) management of risks and liabilities involved with fraudulent payments;
  - (iii) management of risks and liabilities involved with information technology and cybersecurity systems; and
  - (iv) policies and procedures and systems to comply with any requirements created by ARNECC or any new governance body or regulator for Electronic Lodgment Network Operators, as they relate to non-cash payments.

**Conditions**

6. If Lextech relies on the exemption in paragraph 4, Lextech must:

- (a) obtain annual independent review and sign-off from a person with appropriate skills and qualifications, on the components of the Lextech Electronic Lodgment Network required to complete financial settlement to ensure such system components are fit for purpose, as described in paragraph 5(f);
- (b) if the reviewer identifies or recommends changes or improvements to the components referred to in subparagraph (a), obtain sign off from the reviewer on the completion of any subsequent changes or improvements within a reasonable time after completion of the review; and
- (c) include a warning pop-up message on the Lextech Electronic Lodgment Network that reminds Subscribers to check the recipient's details that are entered into the Lextech Electronic Lodgment Network for the transaction, prior to approving the payment, to minimise risk of payments being made to the wrong recipient due to incorrect entry of recipient details.

### Interpretation

In this instrument:

**ARNECC** means the Australian Registrars' National Electronic Conveyancing Council as established under the Intergovernmental Agreement for an Electronic Conveyancing National Law.

**associated financial transaction** has the meaning given in the *Electronic Conveyancing (Adoption of National Law) Act 2012* of New South Wales as at the date of this instrument.

**Electronic Lodgment Network** has the meaning given in the *Electronic Conveyancing (Adoption of National Law) Act 2012* of New South Wales as at the date of this instrument.

**Electronic Lodgment Network Operator** has the meaning given in the *Electronic Conveyancing (Adoption of National Law) Act 2012* of New South Wales as at the date of this instrument.

**general advice** has the meaning given in subsection 766B(4) of the Act.

**non-cash payment** has the meaning given in section 763D of the Act.

**settlement** means the transaction of payment for property purchase and transfer of ownership.

**Subscribers** means persons who will be authorised to undertake conveyancing transactions through the Lextech Electronic Lodgment Network.



**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 741(1)(b) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 22-1047.

**Commencement**

3. This instrument commences on the date it is signed.

**Declarations**

4. Chapter 6D of the Act applies to NOHC as if the definition of "continuously quoted securities" in section 9 of the Act were omitted and replaced with the following:

*"continuously quoted securities* are securities:

- (a) that are in a class of securities that are quoted ED securities where:
  - (i) securities in the class were first issued following the implementation of a Part 5.1 arrangement between a company (the *subsidiary*) and its members under which the subsidiary became a wholly-owned subsidiary of the issuer (the *issuer*); and
  - (ii) securities in the class were not quoted ED securities at all times in the 3 months before the date of the prospectus or Product Disclosure Statement (as applicable); and
  - (iii) the subsidiary's securities transferred to the issuer pursuant to the Part 5.1 arrangement referred in subparagraph (a)(i) were in a class of securities that were quoted ED securities at all times in the 3 months before implementation of the Part 5.1 arrangement; and
- (b) in relation to which the following subparagraphs are satisfied by both the issuer and the subsidiary:
  - (i) no exemption under section 111AS or 111AT, or modification under section 111AV, covered the issuer or subsidiary, or any person as director or auditor of the issuer or subsidiary; and
  - (ii) no exemption under paragraph 741(1)(a), or declaration under paragraph 741(1)(b), relating to a provision that is a disclosing entity provision for the purposes of Division 4 of Part 1.2A covered the issuer or subsidiary, or any person as director or auditor of the issuer or subsidiary; and

- (iii) other than a technical relief instrument, no order under section 340 or 341 covered the issuer or subsidiary, or any person as director or auditor of the issuer or subsidiary;

during the following periods:

- (iv) in the case of the issuer - the shorter of the period during which the class of securities were quoted, and the period of 12 months before the date of the prospectus or Product Disclosure Statement (as applicable); or

  - (b) for the sale of ordinary shares in the issuer which have been issued as a result of a conversion or exchange of regulatory capital securities (as defined in section 9 of the Act as notionally inserted by *ASIC Corporations (Regulatory Capital Securities) Instrument 2016/71*) and the sale is made in accordance with section 708A (as modified by *ASIC Corporations (Regulatory Capital Securities) Instrument 2016/71*) of the Act.

#### Interpretation

**ANZBGL** means Australia and New Zealand Banking Group Limited ACN 005 357 522

**ANZBGL Scheme of Arrangement** means the arrangement under Part 5.1 of the Act between ANZBGL and its members pursuant to which all of the ordinary shares in ANZBGL are to be transferred to NOHC in consideration for the issue of NOHC in respect of which an explanatory statement was registered by ASIC on or around 26 October 2022.

**NOHC** means ANZ Group Holdings Limited ACN 659 510 791, which will become the parent entity of ANZBGL upon implementation of the ANZBGL Scheme of Arrangement.

**NOHC Share** means a fully paid ordinary share in NOHC.

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under s926A(2)(a) of the *Corporations Act 2001* (**Act**).

**Title**

2. This instrument is ASIC Instrument 22-1051.

**Commencement**

3. This instrument commences on the day it is signed.

**Cessation**

4. The exemption in paragraph 5 ceases to have effect on the earlier of:
  - (a) sub-paragraph 1(1) of Sch 2 of the ASIC Corporations (Repeal and Transitional) Instrument 2016/396 ceasing to have effect in relation to the relief that was provided under ASIC Class Order [CO 03/1100] US SEC regulated financial service providers; or
  - (b) CMD Global Partners LLC, a limited partnership formed under the laws of the state of Delaware and registered with the US Securities and Exchange Commission under number 8-70432 (the **body**), not complying with any written notice given by ASIC directing the body to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial service business operated by the body in this jurisdiction.

**Exemption**

5. ASIC exempts the body from the requirement to hold an Australian financial services (AFS) licence in the case referred to in Schedule A.

**Schedule A**

1. Where all of the following apply:
  - (a) The body is:
    - (i) a registered broker dealer that is a member of the Securities Investor Protection Corporation established under the Securities Investor Protection Act 1970 (US) and that is a member of FINRA and FINRA is the body's examining authority; or
    - (ii) a registered broker dealer that is an OTC derivatives dealer within the meaning of Rule 3b-12 promulgated under the Exchange Act who is affiliated within the meaning of that Rule with a registered broker dealer who is a member of FINRA; or
    - (iii) a registered investment adviser;
  - (b) the body is either:
    - (i) a body corporate incorporated in the US or a State of the US; or
    - (ii) a partnership formed in the US or State of the US;
  - (c) the body:
    - (i) is registered under Division 2 of Part 5B.2 of the Act; or
    - (ii) has an Agent at the time the body first purports to rely on this instrument and, from that time, has not failed to have an Agent for any consecutive period of 10 business days;
  - (d) the body's primary business is the provision of financial services;
  - (e) neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument;
  - (f) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule B;
    - (i) 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
    - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
  - (g) the body has not notified ASIC that it will not rely on this instrument.
2. Where the body provides any of the following financial services (the financial services) in this jurisdiction to wholesale clients (and the body is authorised under US regulatory requirements to provide the financial service in the US):
  - (a) providing financial product advice;

in respect of any of the following financial products (that the body is authorised under US regulatory requirements to provide the financial services on in the US):

(a) securities;

3. Where the body has provided ASIC with all of the following:

(a) evidence and submissions that paragraph 1(a) of Schedule A is satisfied;

(b) a notice that it will provide financial services in this jurisdiction in reliance on this instrument;

(c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in s659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which provides that:

(i) the deed is irrevocable except with the prior written consent of ASIC; and

(ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under s50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise; and

(iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services; and

(iv) if the body is not registered under Div 2 of Pt 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the agent; and

(v) the body covenants that, on written request of either the SEC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the SEC to disclose to ASIC and ASIC to disclose to the SEC any information or document that the SEC or ASIC has that relates to the body;

(d) written consents to the disclosure by the SEC to ASIC and ASIC to the SEC of any information or document that the SEC or ASIC has that relates to the body (being consents in such form (if any) as ASIC specifies in writing).

**Schedule B**

The body must:

1. provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the US regulatory requirements if the financial service were provided in the US in like circumstances; and
2. notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:
  - (a) each significant change to, including the termination of, the registration as a registered investment adviser applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and
  - (b) each significant particular exemption or other relief which the body obtains from the US regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
  - (c) each action or investigation of the following kinds taken by the SEC or other overseas regulatory authority against the body in a foreign jurisdiction in relation to financial services provided in the foreign jurisdiction:
    - i. significant enforcement action;
    - ii. significant disciplinary action;
