**Australian Securities and Investments Commission

Enabling provision

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 741(1)(b) of the *Corporations Act 2001 (Act)*.

Title

2. This instrument is ASIC Instrument 14-1329.

Commencement

3. This instrument commences on 23 December 2014.

Declarations

4. Part 6D.2 of the Act applies to iSentric Ltd ACN 091 192 871 (*Company*) as if section 708AA of the Act were modified or varied by inserting after subsection 708AA(2):

"(2A) For the purposes of subparagraph (2)(c)(i), the period during which the class of securities is quoted is the period commencing 23 September 2014."

5. Chapter 6D of the Act applies to an offer for sale of ordinary shares in the Company as if paragraph 708A(5)(b) of the Act were modified by deleting the words "12 months" and substituting the words "3 months."

Where this instrument applies

6. The modification in paragraph 5 applies to an offer for sale of ordinary shares in the Company where:
 - (a) the ordinary shares were subject to shareholder approval on or about 28 January 2015 and were issued on or after 28 January 2015:
 - (i) to sophisticated and professional investors under an offer which did not require disclosure under Part 6D.2 of the Act because of subsection 708(8) or subsection 708(11) of the Act; or
 - (ii) under an offer made through a financial services licensee which did not require disclosure under Part 6D.2 of the Act because of subsection 708(10) of the Act; and

- (b) the Company has given ASX Limited ACN 008 624 691 a notice under paragraph 708A(5)(e) of the Act which complies with subsection 708A(6) of the Act.

**Australian Securities and Investments Commission

Declaration**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 741(1)(a) and 741(1)(b) of the *Corporations Act 2001 (Act)*.

Title

2. This instrument is ASIC Instrument [14-1335].

Commencement

3. This instrument commences on 23 December 2014.

Exemption

4. Voztec Investments Pty Ltd ACN 160 778 567 (*Company*) does not have to comply with Parts 6D.2 and 6D.3 of the Act.

Declaration

5. Chapter 6D of the Act applies to shareholders of Voztec Limited ACN 086 431 521 (*Voztec*) as if section 707 of the Act were modified or varied by omitting subsections 707(3) and (4) and substituting:

“(3) An offer of a body’s securities for sale within 12 months after their issue needs disclosure to investors under this Part if the body issued the securities:

(a) without disclosure to investors under this Part; and

(b) with the purpose of the person to whom they were issued:

(i) selling or transferring them; or

(ii) granting, issuing or transferring interests in, or options or warrants over, them;

and section 708 or 708A does not say otherwise.

- (4) Unless the contrary is proved, a body is taken to issue securities with the purpose referred to in paragraph 3(b) if any of the securities are subsequently sold, or offered for sale, within 12 months after their issue.”

6. The exemption in paragraph 4 applies to an offer by the Company to transfer to its shareholders shares in Voztec by way of an *in specie* distribution pursuant to the Share Buy Back, as described in the notice of meeting material that:

 - (b) includes a statement:
 - (i) describing the need for, and effect of, the relief contained in this instrument as it applies to shareholders; and
 - (ii) confirming that subparagraph (a) of paragraph 6 of this instrument has been satisfied.
7. The declaration in paragraph 5 applies to an offer for sale of shares in Voztec where the shares were:

Share Buy Back means the proposed selective share buy-back under s257D of the Act as described in the draft notice of meeting material.

Commencement

3. This instrument commences on 24 December 2014.

Declaration

4. Chapter 6D of the Act applies to Tinho Union Group (Australia) Limited ACN166 080 128 (the *Issuer*) as if Part 6D.2 were modified or varied as follows:
 - (a) omit paragraph 723(3)(b), substitute:
 - “(b) the securities are not admitted to quotation within 3 months after the later of:
 - (i) the date of the disclosure document; and
 - (ii) the date of the latest supplementary disclosure document for the offer lodged with ASIC which:
 - (A) discloses that the securities are not admitted to quotation; and
 - (B) gives applicants 1 month to withdraw their application and be repaid”;
 - (b) in paragraph 724(1)(a), omit the words “and that condition is not satisfied within 4 months after the date of the disclosure document”, substitute:
 - “and that condition is not satisfied within 4 months after the later of:
 - (iii) the date of the disclosure document; and
 - (iv) the date of the latest supplementary disclosure document for the offer lodged with ASIC which:



- (A) discloses that the condition has not been satisfied; and
 - (B) gives applicants 1 month to withdraw their application and be repaid”;
- (c) omit subparagraph 724(1)(b)(ii), substitute:
- “(ii) the securities are not admitted to quotation within 3 months after the later of:
 - (A) the date of the disclosure document; and
 - (B) the date of the latest supplementary disclosure document for the offer lodged with ASIC that discloses that the securities are not admitted to quotation and gives applicants 1 month to withdraw their application and be repaid”; and
- (d) after subsection 724(1A), insert:
- “(1B) Where a supplementary disclosure document of the kind referred to in subparagraphs (1)(a)(iv) or (1)(b)(ii)(B) is lodged with ASIC, the person offering the securities must give the applicants:
 - (i) that supplementary disclosure document; and
 - (ii) 1 month to withdraw their application and be repaid.”

Shares means all the issued ordinary shares in Nexus.




