- ASIC Connect is the online system used to manage your business name.
- You can transfer a business name to a new holder from your ASIC Connect account.
- Check your business email address is up to date before starting this transaction. If this is incorrect or an email address has not been provided, you can update your business name address details.
- You must give the transfer number to the new business name owner. They will need this to register the business name in their name.
