	ASIC will advise the auditor and the licensee in writing of the	e result of the application.	
	If ASIC's consent has been given, the auditor is then required by s990G(1) to give written notice of their resignation to the licensee. This notice cannot be given to the licensee until after ASIC's consent has been received. Within 14 days after the resignation takes effect, the licensee must appoint another auditor if this has not already occurred and lodge written notice specifying the name of the person or firm appointed and the date of their appointment. Form FS06 <i>Appointment of an auditor of an Australian financial services licensee</i> is the approved form for this purpose; it can be lodged online through the AFS licensee portal at www.asic.gov.au.
