**Australian Securities and Investments Commission
Corporations Act 2001 –Paragraph 926A(2)(a) - Exemption**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 926A(2)(a) of the *Corporations Act 2001 (Act)*.

Title

2. This instrument is ASIC Instrument 25-517.

Commencement

3. This instrument commences on the day it is signed.

Exemption

4. ASIC exempts Cortina Capital Asset Management Limited (the *body*), a company incorporated under the laws of Hong Kong BRN 2853004 and licensed by the Securities and Futures Commission of Hong Kong with registration number BOZ862, from the requirement to hold an Australian financial services (*AFS*) licence.

Cessation

5. The exemption in paragraph 4 ceases to have effect on the earlier of:
 - (a) sub-paragraph 1(3) of Schedule 2 of the *ASIC Corporations (Repeal and Transitional) Instrument 2016/396* ceasing to have effect in relation to the relief that was provided under ASIC Class Order [CO 03/1103] *Hong Kong SFC regulated financial service providers*; or
 - (b) the body failing to comply with any written notice given by ASIC directing the body to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial services business operated by the body in this jurisdiction; or
 - (c) the body being notified in writing by ASIC that it is excluded from relying on this instrument.

Schedule A

1. The exemption in paragraph 4 applies where all of the following apply:
 - (a) the body holds a current licence or certificate of registration granted by the Securities and Futures Commission of Hong Kong (*SFC*);
 - (b) the body is a body corporate incorporated in Hong Kong;
 - (c) the body is registered under Div 2 of Pt 5B.2 of the Act;
 - (d) the body's primary business is the provision of financial services;

- (e) neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument;
 - (f) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule B:
 - (i) 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
 - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
 - (g) the body has not notified ASIC that it will not rely on this instrument.
2. Where the body provides any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients (and the body is authorised under Hong Kong regulatory requirements to provide the financial services in Hong Kong):
- (a) providing financial product advice;
 - (b) dealing in a financial product;
- in respect of any of the following financial products:
- (c) securities; or
 - (d) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act.
3. Where the body has provided ASIC with all of the following:
- (a) evidence that paragraph 1(a) of Schedule A is satisfied;
 - (b) a notice that it will provide the financial services in this jurisdiction in reliance on this instrument;
 - (c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in s659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which provides that:
 - (i) the deed is irrevocable except with the prior written consent of ASIC; and
 - (ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under s50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise; and

- (iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
- (iv) If the body is not registered under Div 2 of Pt 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
- (v) the body covenants that, on written request of either the SFC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the SFC to disclose to ASIC and ASIC to disclose to the SFC any information or document that the SFC or ASIC has that relates to the body; and
- (d) written consents to the disclosure by the SFC to ASIC and ASIC to the SFC of any information or document that the SFC or ASIC has that relates to the body, being consents that must be in such form (if any) as ASIC specifies in writing.

Schedule B

1. The body must:

- (a) provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the Hong Kong regulatory requirements if the financial service were provided in Hong Kong in like circumstances;
- (b) notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:
 - (i) each significant change to, including the termination of, the licence or registration applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (ii) each significant particular exemption or other relief which the body obtains from the Hong Kong regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (iii) each action or investigation of the following kinds taken by the SFC or other overseas regulatory authority against the body in a foreign jurisdiction in relation to the financial services provided in the foreign jurisdiction:
 - (A) significant enforcement action;
 - (B) significant disciplinary action;
 - (C) significant investigation (unless, after having taken reasonable steps to enable notification to be given to ASIC, the body is prohibited by law

from giving such notification but only to the extent of the prohibition);
and

- (c) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
 - (i) the body is exempt from the requirement to hold an AFS licence under the Act in respect of the financial services; and
 - (ii) the body is regulated by the SFC under Hong Kong laws, which differ from Australian laws; and
- (d) if ASIC gives the body a written notice directing the body to lodge with ASIC, within the time specified in the notice, a written statement containing specified information about any financial service provided by the body in this jurisdiction — comply with the notice.

Interpretation

In this instrument:

address in relation to a company, means the address of the registered office of the company;

Agent means a natural person resident in this jurisdiction or a company, whose name and address were last notified to ASIC by the body for the purposes of this instrument, and who is authorised to accept on the body's behalf, service of process from ASIC and, in relation to proceedings relating to a financial services law, from any person referred to in s659B(1) of the Act;

ASIC Act means the *Australian Securities and Investments Commission Act 2001*;

certificate of registration means the certificate of registration granted to authorised financial institutions under section 119 of the SFO;

financial product advice has the meaning given by section 766B of the Act;

financial services law has the meaning given by section 761A of the Act;

Hong Kong regulatory requirements means the rules that apply in relation to the financial services including:

- (a) any applicable legislation;
- (b) any instruments made under that legislation; and
- (c) any relevant policies or other documents (however described) issued by the SFC.

licence means a licence granted under section 116 of the SFO or deemed to be granted under sections 22 or 25(b) of Schedule 10 to the SFO;

notice and **notified** mean, respectively, written notice and notified in writing;

overseas regulatory authority means a foreign regulatory authority (other than the SFC which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

SFC means the Securities and Futures Commission of Hong Kong; and

SFO means the *Securities and Futures Ordinance 2002* of Hong Kong.

**Australian Securities and Investments Commission

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 1020F(1)(c) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 25-0591.

Commencement

3. This instrument commences on the day it is signed.

Declaration

4. Part 7.9 of the Act applies to Centuria, the Issuer and holders of interests in the Trust as if the following provisions of section 1012DA (as notionally inserted under *ASIC Corporations (Sale Offers: Securities issued on Conversion of Convertible Notes) Instrument 2016/82* were modified or varied as follows:

(a) omit paragraph (12C)(a), substitute “(12C)(a) the relevant product was issued by an issuer of financial products by reason of the conversion of convertible notes issued by another body; and”;

(b) omit paragraph (12C)(e), substitute “(12C)(e) the issuer of the relevant product gave the relevant market operator for the issuer a notice that complied with subsection (12D) on the same day as, or within 2 business days before, the first day on which the convertible notes were issued.”;

(c) omit subparagraph (12D)(a)(i), substitute “(12D)(a)(i) the effect of the offer of the convertible notes on the body that issued the convertible notes and the issuer of the relevant product; and”;

(d) omit subsections (12E) and (12F), substitute:

- (b) the number of financial products in the class of relevant products into which the convertible notes will convert;
 - (c) the price (if any) to be paid on conversion;
 - (d) the circumstances in which conversion may occur;
 - (e) the remaining liability of the body issuing the convertible notes or issuer of the relevant products to make payments under convertible notes in that class as at the end of the financial year;
 - (f) the average conversion price (if any) paid for any convertible notes in that class that were converted during the financial year and the number of financial products in the class of relevant products into which they converted; and
 - (g) any other matters relating to the convertible notes that holders of ED securities of the issuer of the relevant product would reasonably require to make an informed assessment of the financial position of the issuer (or if the issuer is the responsible entity of a registered scheme, the registered scheme) and its prospects for future financial years.
- (12F) The financial report and directors' report may omit material that would otherwise be required to be included under paragraph (12E)(g) if it is likely to result in unreasonable prejudice to:
- (a) the issuer of the relevant product (or, if the issuer is the responsible entity of a registered scheme, the registered scheme); or
 - (b) if consolidated financial statements are required – the consolidated entity or any entity (including the issuer of the relevant product or, if the issuer is the responsible entity of a registered scheme, the registered scheme) that is part of the consolidated entity.

If material is omitted, the report must say so.”.
