

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under s926A(2)(a) of the Act.

**Title**

2. This instrument is ASIC Instrument 26/452 .

**Commencement**

3. This instrument commences on the day it is signed.

**Exemption**

4. UBS Financial Services Inc (**UBS FSI**), a corporation registered in Delaware, United States (SEC File no. 8-16267) and regulated by the Securities and Exchange Commission, is exempt from the requirement to hold an Australian financial services licence under s911A(1) of the Act subject to paragraphs 5 and 6 of this instrument.

**Where this instrument applies**

5. The exemption in paragraph 4 applies to the following financial services provided to ESS participants during the course of UBS FSI managing and administering employee share schemes on behalf of the Corporate Client:
  - (a) general financial product advice under section 766B of the Act, where:
    - (i) the information provided by UBS FSI to ESS participants of a Corporate Client is limited to information in connection with the management and administration of an employee share scheme by UBS FSI in respect of the ESS participant receiving ESS interest offers under an employee share scheme from the Corporate Client;
    - (ii) in the context of UBS FSI providing this information it does not reasonably intend to influence a prospective or onboarded ESS participant into making a decision on whether to hold or sell an ESS interest connected with an employee share scheme and only provides information intended to be informational and factual; and
    - (iii) UBS FSI has provided the disclaimer required under paragraph 6(i)(ii);

(b) dealing under subsection 766C(2) of the Act, where:

- (i) UBS FSI arranges for an ESS participant to acquire or dispose of an ESS interest received or offered from a Corporate Client to the ESS participant or acquired on the market in the context of the ESS participant's employee share scheme; and
- (ii) the execution of the arrangement is arranged or performed by UBS FSI at the initiation of the ESS participant;

(c) custodial or depository services under section 766E of the Act, where:

- (i) the custodial services are limited to an ESS interest issued to an ESS participant by the relevant Corporate Client or acquired on the market in the context of its employee share scheme;
- (ii) UBS FSI maintains the sub-accounting and individual customer records of ESS interests held under custody, but does not hold the legal title to the underlying ESS interest;
- (iii) ESS participants are not charged a custody fee; and
- (iv) UBS FSI, as securities intermediary, has an arrangement with a securities depository, who are authorised under US regulatory requirements or other applicable regulatory requirements in the relevant jurisdiction of the ESS interest, to provide custodial or depository services.

#### **Conditions of the Exemption**

6. The exemption in paragraph 4 is subject to the following conditions:

- (a) UBS FSI remains a registered broker dealer that is a member of the Securities Investor Protection Corporation established under the Securities Investor Protection Act of 1970 of the US and that is a member of FINRA and FINRA is the body's examining authority;
- (b) UBS FSI is a body corporate incorporated in Delaware, the United States of America;
- (c) the financial services provided under this instrument by UBS FSI to ESS participants complies with the US regulatory requirements;
- (d) the total percentage of ESS participants when calculated across all participants of Corporate Clients for which UBS FSI provides its services for does not increase beyond 5%;

- (e) UBS FSI has an Agent at the time it purports to rely on this instrument, and, from that time, has not failed to have an Agent for any consecutive period of 10 business days;
- (f) UBS FSI does not fail to comply with any written notice given by ASIC directing UBS FSI to give to ASIC, within the time specified in the notice, a written statement containing specified information about the services under this instrument by UBS FSI, as they relate to ESS participants;
- (g) UBS FSI maintains an appropriate and transparent complaints management framework, that complies with US regulatory requirements which is documented and implemented;
- (h) fees charged to ESS participants for the services, and any significant fees paid to any third parties that are passed on to ESS participants (if applicable), are disclosed to ESS participants and are reasonable to the scope of services;
- (i) UBS FSI provides the following disclosure to ESS participants when the account becomes accessible by the the ESS participant (where the account will be accessible for the first time after the commencement of this instrument) and within 120 days after the commencement of this instrument for all active accounts (where the account was accessible by the ESS participant prior to the commencement of this instrument):
  - (i) an overview of the financial services covered by this instrument that UBS FSI may provide to the ESS participant, noting that UBS FSI does not hold an Australian financial services licence and provides the services under a licensing exemption;
  - (ii) a statement to the effect that while any information that it provides concerning its services relating to the employment share scheme may constitute general financial product advice under Australian law, and for which it has an exemption, UBS FSI does not generally provide financial product advice to ESS participants and that the ESS participant should consider obtaining independent advice before making any financial decisions;
  - (iii) a summary of the commission or other payments generally received by UBS FSI in relation to the sale of ESS interests facilitated for ESS participants;
  - (iv) information regarding any quarterly statements that each ESS participant will receive relating to the ESS interests that UBS FSI has arranged to be held on behalf of each ESS participant; and

- (v) information on the various ways an ESS participant can raise a complaint, both internally and externally with SEC and FINRA in relation to the financial services provided by UBS FSI;
- (j) UBS FSI complies with US regulatory requirements in respect of money held for an ESS participant as a result of the sale or purchase of an ESS interest;
- (k) UBS FSI does not market its services to Corporate Clients listed or incorporated in this jurisdiction or intentionally induce persons in this jurisdiction to use the services covered under this instrument, beyond the services contemplated under its arrangement with the Corporate Client;
- (l) UBS FSI obtains, from each Corporate Client whose employee share scheme has ESS participants resident or domiciled in this jurisdiction, a representation and warranty substantively to the effect that its employee share scheme and the offerings of ESS interest therein comply with all applicable laws and regulations, including applicable securities laws and regulations at the residence and/or domicile of the ESS participants. This condition only applies in respect of any agreement between UBS FSI and a Corporate Client for the management and administration of the Corporate Client's employee share scheme entered into on or after the commencement of this instrument.

#### **Cessation**

7. The exemption in paragraph 4 ceases to have effect on the earlier of:

- (a) UBS FSI failing to comply with any written notice given by ASIC directing it to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial service business operated by UBS FSI in this jurisdiction;
- (b) UBS FSI being notified in writing by ASIC that it is excluded from relying on this instrument; or
- (c) UBS FSI has notified ASIC that it does not rely on this instrument.
