**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsection 601QA(1)(b) of the Corporations Act 2001 (the *Act*).

**Title**

2. This instrument is ASIC Instrument 23-0457.

**Commencement**

3. This instrument commences on the day it is signed.

**Declaration**

4. Chapter 5C of the Act applies to Vanguard Investments Australia Ltd (ACN 072 881 086) (*Vanguard*) in its capacity as responsible entity of each of the registered schemes set out in Schedule A of this instrument (collectively, the *Wholesale Funds*) as if paragraph 601GC(1)(c) (as notionally inserted by ASIC Corporations (Attribution Managed Investment Trusts) Instrument 2016/489) of the Act were modified or varied as follows:

- (a) omit “601GCA.” and substitute “601GCA; or”; and
- (b) after paragraph (c), insert:

“(d) by special resolution of the members of a class(es) of the scheme, where the responsible entity reasonably considers the change will not adversely affect members’ rights of those members in any other class(es) of the scheme and is not contrary to the best interests of all members of the scheme.”

**Wholesale Class** means a class of units in the Wholesale Funds (except for the Vanguard Ethically Conscious Global Aggregate Bond Index Fund (Hedged) ARSN 618 349 090) known as the “wholesale class” of units.

**Wholesale Fund Arrangements** means the arrangements described in the Explanatory Memorandum under which it is proposed that the Impacted Classes of members will transfer their units in the Impacted Classes to Vanguard as operator of the Vanguard Personal Investor, to be held in an account in the name of the member, where the Wholesale Fund Arrangements are approved by resolutions passed at meetings of members of the Impacted Classes of each of the Wholesale Funds.

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)*.

**Title**

2. This instrument is ASIC Instrument 23-0570.

**Commencement**

3. This instrument commences on the date it is signed.

**Exemption**

4. Vanguard Investments Australia Ltd (ACN 072 881 086) (*Vanguard*) in its capacity as responsible entity of each of the registered schemes as set out in Schedule A to this instrument (collectively the *Wholesale Funds*) does not have to comply with paragraph 601FC(1)(d) of the Act, to the extent that it requires the responsible entity of a registered scheme to treat members who hold interests of the same class equally.

**Where this instrument applies**

5. The Wholesale Fund Arrangements are implemented on terms that allow Vanguard to determine that Ineligible Foreign Unitholders are not eligible to be issued with a Vanguard Personal Investor Account and to have their interests in the Wholesale Fund transferred to Vanguard as operator of the Vanguard Personal Investor to be held in a Vanguard Personal Investor Account and will be excluded from participating in the Wholesale Fund Arrangements in accordance with the terms of the Wholesale Fund Arrangements as described in the Explanatory Memorandum.
6. Vanguard reasonably concludes and documents its conclusions in writing that:
  - (a) it would be unlawful (under the laws of the relevant foreign jurisdictions) for Ineligible Foreign Unitholders to be issued with a Vanguard Personal Investor Account; or
  - (b) it would be unduly onerous on Vanguard for Ineligible Foreign Unitholders to participate in the Wholesale Fund Arrangements having regard to:
    - (i) the number of holders of interests in the Wholesale Funds in that jurisdiction;
    - (ii) the number and value of interests in the Wholesale Funds held by Ineligible Foreign Unitholders in that jurisdiction; and

- (b) in respect of the other Wholesale Funds, holders of interests in the Impacted Class in the Wholesale Funds.

**Exemption**

4. Vanguard Investments Australia Ltd (ACN 072 881 086) (*Vanguard*) in its capacity as responsible entity of each of the registered schemes set out in column A of Schedule A of this instrument (collectively the *Retail Funds*) is exempt from complying with Division 5A of Part 7.9 of the Act.

**Where this instrument applies**

5. The exemption in paragraph 4 applies in relation to the unsolicited offer or invitation made to the members of each of the Retail Funds by Vanguard in relation to the Retail Fund Arrangements as described in the Explanatory Memorandum.

**Interpretation**

6. In this instrument:

**Where this instrument applies**

5.
