Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 601QA(1)(a) – Exemption

Enabling legislation

 The Australian Securities and Investments Commission makes this instrument under paragraph 601QA(1)(a) of the Corporations Act 2001 (the Act).

This instrument is ASIC Instrument 17-0101.

Commencement

3. This instrument commences on the day it is signed.

Exemption

The Trust Company (RE Services) Limited ACN 003 279 831 (The Trust Company) in its capacity as responsible entity of PaperlinX SPS Trust ARSN 123 839 814 (SPS Trust) does not have to comply with paragraph 601FC(1)(d) of the Act to the extent that it requires the responsible entity of a registered scheme to treat members who hold interests of the same class equally.

Where this exemption applies

- This exemption applies where:

New Spicers Shares has the same meaning as in the Explanatory Materials.

Record Date has the same meaning as in the Explanatory Materials.

Proposal means the arrangement under which Spicers proposes to acquire all of the interests in SPS Trust it does not already hold, where the acquisition is approved by resolutions passed at a meeting of the SPS Trust members convened in accordance with the Explanatory Materials.
