**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraph 741(1) – Declaration**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 741(1) of the *Corporations Act 2001 (Act)*.

Title

2. This instrument is ASIC instrument 17-0726.

Commencement

3. This instrument commences on the date it is signed.

Declaration

4. Chapter 6D of the Act applies to Namoi Cotton Co-operative Ltd ARBN 010 485 588 (*Namoi Cotton*) as if subsections 711(6) and 723(1) of the Act were omitted.
5. Chapter 6D of the Act applies to Namoi Cotton as if subparagraph 734(5)(b)(iii) and paragraph 734(6)(e) of the Act were omitted.

Where this instrument applies

6. The declaration in paragraph 4 applies in relation to an offer of ordinary shares and Residual Capital Stock in Namoi Cotton under a prospectus lodged with ASIC in substantially the form provided to ASIC on 2 August 2017 where:
 - a) the offer is made to holders of existing Grower Shares and Namoi Capital Stock in Namoi Cotton as part of the Proposal;
 - b) the prospectus contains a statement that no ordinary shares and Residual Capital Stock will be issued on the basis of the prospectus after the completion of the Proposal; and
 - c) the prospectus is contained within the Explanatory Memorandum in substantially the form provided to ASIC on 2 August 2017 in respect of the Proposal.
7. The declaration in paragraph 5 applies in relation to an advertisement or publication that directly or indirectly refers to an offer or proposed offer of ordinary shares and Residual Capital Stock in Namoi Cotton as part of the Proposal where a prospectus is lodged or will be lodged in relation to the offer.

Interpretation

8. In this instrument:

Co-operatives National Law means the Co-operatives National Law (NSW), set out as the appendix to the *Co-operatives (Adoption of National Law) Act 2012 (NSW)*.

Explanatory Memorandum means the disclosure statement and explanatory statement (including prospectus) and notices of meeting and notices of postal ballots sent to holders of Grower Shares and Namoi Capital Stock in Namoi Cotton in relation to the Proposal.

Grower Shares means a fully paid ordinary share in Namoi Cotton, having the rights conferred on Grower Shares by the rules of Namoi Cotton.

Namoi Capital Stock means a co-operative capital unit (referred to as a CCU in the Co-operatives National Law) in the capital of Namoi Cotton, having the rights conferred on Namoi Capital Stock by the rules of Namoi Cotton.

Proposal means the arrangement under which Namoi Cotton proposes to restructure its corporate and capital structure involving, among other things, the variation of Grower Shares and Namoi Capital Stock rights and schemes of arrangement under the Co-operatives National Law, where the arrangement is approved by resolutions passed by postal ballots of holders of Grower Shares and at meetings of the holders of Namoi Capital Stock, respectively.

Residual Capital Stock means an interest in the capital (but not the share capital) of Namoi Cotton following the implementation of the Proposal having the rights set out in the constitution of Namoi Cotton, as described in the Explanatory Memorandum.

Declaration

4. Chapter 6 of the Act applies to NEXTDC Limited ACN 143 582 521 (**Bidder**) as if section 636 were modified or varied by omitting paragraph 636(1)(k)(ii) and substituting it with:
 - "(ii) the number of securities in the class that the bidder had a relevant interest in within 3 trading days before the first offer is sent (expressed as a number of securities or as a percentage of the total number of securities in the class);"

Where this declaration applies

5. This declaration applies to an off-market takeover bid made by the Bidder for all of the stapled securities in the Asia Pacific Data Centre Group (**Target**) that the Bidder does not already own where the Bidder sends a bidder's statement and offer document to holders of securities in the Target under item 6 of the table in subsection 633(1) of the Act that includes the information required by subsection 636(1)(k)(ii) as at a date that is no more than 3 trading days prior to the date of the offer.
