Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 1020F(1)(b) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 18-0170.

Commencement

3. This instrument commences on 26 March 2018.

Exemption

4. An ordinary share in Evans Dixon Limited ACN 609 913 457 (*Company*) is exempt from subsection 1020B(2) of the Act:

Where the exemption applies

5. The exemption applies to an offer by SaleCo to sell Shares to Applicants where all the following are satisfied:
 - a) a Shareholder has, before the time of any sale offer made by SaleCo, offered to sell Shares to SaleCo, or as directed by SaleCo, under an Irrevocable Offer Deed;
 - b) SaleCo offers to sell the Shares to Applicants conditional on Listing; and

Shares means fully paid ordinary shares in the Company.

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 655A(1)(b) and 673(1)(b) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 18-0192.

Commencement

3. This instrument commences on 26 March 2018.

Declarations

4. Chapters 6 and 6C of the Act apply to Evans Dixon Limited ACN 609 913 457 (*Company*) as if section 609 were modified or varied by, after subsection (13) (as notionally inserted by ASIC Class Order [CO 13/520]), inserting:

"(13A) A body corporate does not have a relevant interest in its own securities merely because, under an escrow arrangement entered into by the body corporate, the body corporate applies restrictions on the disposal of the securities by the holder."
5. Chapters 6 and 6C of the Act apply to the Company as if section 9 were modified or varied by, after subparagraph (a)(ii)(C) in the definition of *substantial holding* (as notionally inserted by ASIC Class Order [CO 13/520]), inserting:

"or
(D) subsection 609(13A) (securities subject to escrow arrangements);"
6. Chapter 6C of the Act applies to the Company as if section 671B were modified or varied by omitting "." in paragraph (7)(c) (as notionally inserted by ASIC Class Order [CO 13/520]), and substituting:

7. This instrument applies in relation to relevant interests the Company has in securities of the Company (*Escrowed Securities*) merely because the Company has entered

into one or more escrow agreements or deeds (each an *Escrow Arrangement*) with each Security Holder in connection with the proposed admission of the Company's securities to the official list of the ASX where each Escrow Arrangement:
