- CHIML in its capacity as the responsible entity of CPIF does not have to comply with section 601FCAB of the Act (as notionally inserted by ASIC Class Order [CO 13/1409]).

#### Where this exemption applies

  - (c) Unibail-Rodamco SE, a European Company (Societas Europaea) incorporated in accordance with the laws of France (*Unibail*); and

(together, the Relevant Persons),

do not have to comply with:

- (e) subsection 601ED(5) of the Act in relation to the Sale Facility;
