3. This instrument commences on 18 October 2018.

Declaration

4. Part 7.11 of the Act applies to shares of Dragon Mining Limited ACN 009 450 051 (*Dragon*) as if provisions of that Part were modified or varied, by after subsection 1071B(1), inserting:
 - “(1A) This section does not apply to a transfer of shares in a company in any of the following circumstances:
 - (a) the shares of the company are transferred to Hong Kong Securities Clearing Company Limited (*HKSCC*) in connection with the deposit of the shares into the Hong Kong Central Clearing and Settlement System (*CCASS*); or
 - (b) the shares of the company are transferred from HKSCC in connection with the withdrawal of the shares from the CCASS; or
 - (c) the transfer is an off-market transfer using a transfer form that the company reasonably believes is the standard transfer form prescribed from time to time by the operator of the Hong Kong Stock Exchange.”

5. This instrument applies in relation to the listing of Dragon on the financial market operated by the Stock Exchange of Hong Kong Limited.
