- (i) that supplementary or replacement disclosure document; and
 - (ii) 1 month to withdraw their application and be repaid.”.





Corporations Act 2001 – Paragraphs 601QA(1)(a), 741(1)(a), 911A(2)(l),
992B(1)(a) and 1020F(1)(a) – Exemption

1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001 (the Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts the following persons:
 - (a) the Issuer; and
 - (b) the Plan Trustee,from Parts 6D.2 and 6D.3 (except section 736), and Part 7.9 of the Act where the person:
 - (c) makes an eligible offer; or
 - (d) offers to arrange for the issue of financial products under an eligible offer; or
 - (e) issues a financial product under an eligible offer,on the conditions set out in the Schedule and for so long as the conditions are met.
2. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the Issuer or the Plan Trustee) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably be aware, that any of the conditions set out in the Schedule have not been met.
3. Under paragraph 911A(2)(l) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
4. Under paragraph 911(A)(2)(l) of the Act, ASIC exempts:
 - (a) the Issuer; and

- (b) an associated body corporate of the Issuer

from the requirement to hold an financial services licence for the provision of the following financial services:

- (c) the provision of a custodial or depository service in connection with an eligible offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
 - (d) dealing in a financial product in the course of providing a custodial or depositor service covered by paragraph (c); and
 - (e) dealing in a financial product in connection with an eligible offer covered by paragraph 1 of this instrument where any acquisition by purchase or disposal of the product (by the Issuer or an associated body corporate) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
5. Under paragraphs 992B(1)(a) and 741(1)(a) of the Act, ASIC exempts the Issuer from sections 992A and 992AA of the Act and 736 of the Act in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.
6. Under paragraph 601QA(1)(a) of the Act, ASIC exempts a person who operates a managed investment scheme relating to an eligible offer from section 601ED of the Act in relation to the operation of that managed investment scheme.

Schedule

The following conditions apply:

1. the Issuer must ensure that the eligible offer is substantially on the terms set out in the draft terms of the Plan provided to ASIC as an attachment to an electronic mail dated 22 December 2010; and
2. the Issuer must:
 - (a) include the offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and

- (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- 3. the Issuer must comply (or, in the case of an issuer which does not have a registered office in this jurisdiction, cause an associated body corporate which does have a registered office to comply) with any undertaking required to be made in the offer document by reason of this instrument; and
- 4. the Issuer must take reasonable steps to ensure that the number of securities to be issued when aggregated with:
 - (a) the number of securities in the same class which would be issued where:
 - (i) each outstanding offer with respect to securities, units of securities and options to acquire unissued securities under any other employee incentive scheme to be accepted or exercised; and
 - (ii) each outstanding offer with respect to securities, units of securities and options to acquire unissued securities under any other employee incentive scheme to be accepted or exercised; and.
 - (b) the number of securities in the same class issued during the previous 5 years under any other employee incentive scheme extended only to eligible employees;but disregarding any offer made, or option acquired or security issued by way of or as a result of:
 - (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
 - (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
 - (e) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
 - (f) an offer made under a disclosure document or Product Disclosure Statement,does not exceed 5% of the total number of issued securities in that class as at the time of the offer; and
- 5. in the case where an offer of securities is made through a trust:

- (a) the Plan Trustee must hold the securities on trust for each person (a **beneficiary**) who acquires equitable interests in securities under an eligible offer; and
- (b) the Plan Trustee must cause proper written financial records to be maintained in respect of the activities of the trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the Plan Trustee or a place of business of the Issuer during normal business hours or such other time as is agreed with beneficiaries; and
- (c) the Plan Trustee must ensure that each security in relation to which a beneficiary holds an equitable interest is identified in the written financial records as being held on account of that beneficiary; and
- (d) the Plan Trustee must not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and
- (e) except as expressly provided by the trust deed, a beneficiary must have the capacity to authorise the Plan Trustee to sell at or above the current market price the securities to which he or she is entitled to under the deed; and
- (f) the Plan Trustee must provide a copy of the trust deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and
- (g) the Issuer must ensure that the trust deed contains covenants binding the Plan Trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the securities in which they hold an equitable interest as if they were the legal owner of the securities, including the right to:
 - (i) direct the Plan Trustees how the voting rights attaching to the securities shall be exercised, either generally or in any particular case; and
 - (ii) receive the income deriving from the securities, including dividends and distributions declared by the Issuer in respect of those securities.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the Act; and
2. the Plan or any other employee incentive scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee; and
3. **associated body corporate** of the Issuer means:
 - (a) a body corporate that is a related body corporate of the Issuer; or
 - (b) a body corporate that has voting power in the Issuer of not less than 20%; or
 - (c) a body corporate in which the Issuer has voting power of not less than 20%; and
4. **Australian dollar equivalent** in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which the price relates; and
5. **current market price** means, in relation to a security, the price published by the operator of the principal financial market on which the security is quoted as the final price for the previous day on which the security was traded on that financial market; and
6. **eligible employee** means a person who is, at the time of an eligible offer, a full or part-time employee or director of the Issuer or of an associated body corporate of the Issuer; and
7. **eligible offer** means an offer for issue of units of securities:
 - (a) in the same class as securities which have been quoted on the Toronto Stock Exchange throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period; or
 - (b) in the same class as securities which are issued on a conversion or reorganisation of the securities mentioned in paragraph (a) above in the manner contemplated by the Offering Circular,

made under the Plan extended only to eligible employees;
8. **financial product advice** has the meaning given by section 766B of the Act; and

9. *general advice* has the meaning given by section 766B of the Act; and
10. *Issuer* means Altus Group Limited, a corporation established under the laws of the province of Ontario, Canada; and
11. *offer* has a meaning affected by section 1010C of the Act; and
12. *offer document* means a document setting out an offer under the Plan that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and
 - (b) if a summary (rather than a copy) of the rules of the Plan is given - includes an undertaking that during the period (the *offer period*) during which an eligible employee may acquire the financial products offered under the Plan, the Issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
 - (c) specifies in respect of the securities:
 - (i) the acquisition price in Australian dollars; or
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the Issuer will (or in the case of an issuer which does not have a registered office in this jurisdiction, an associated body corporate of the issuer which does so have a registered office) will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of securities in the same class as those to which the units relate; and
 - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
 - (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the Issuer or any associated body corporate of the Issuer for the purpose of acquiring financial products under the Plan; and

13. **Offering Circular** means the Notice of Meeting and Management Information Circular dated 8 November 2010, which is substantially in the form provided to ASIC as an attachment to an electronic mail dated 14 December 2010; and
14. **Plan** means an employee share scheme that is known as at the date of this instrument as the Altus Asia Pacific Executive Plan where:
- (a) the scheme is extended only to eligible employees; and
 - (b) the terms of the scheme are substantially on the terms set out in the draft terms of the Plan, provided to ASIC as an attachment to an electronic mail dated 26 October 2009 (as amended to reflect the corporatisation referred to in part (b) of the definition of eligible offer); and
15. **Plan Trustee** means the trustee of the trust established for the purposes of the Plan as defined in the rules of the Plan, initially to be Altus Group Asia Pacific Pty Limited ACN 138 541 278; and
16. **rules of the Plan** means the written terms of the Plan as at the date of this instrument that are substantially on the terms set out in the draft terms of the Plan, provided to ASIC as an attachment to an electronic mail dated 26 October 2009 (as amended to reflect the corporatisation referred to in part (b) of the definition of eligible offer); and
17. **security** means an interest in the Issuer; and
18. **unit** means a legal or equitable right or interest in the security.

and Exemption**

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)* the Australian Securities and Investments Commission (**ASIC**) revokes ASIC Instrument 01/0426.
2. Under paragraph 601QA(1)(a) of the Act ASIC exempts Capri Waters Country Club Limited ACN 003 238 051 (**the Operator**) in the case specified in Schedule A from section 601ED of the Act on the conditions set out in Schedule B for so long as those conditions are met.
3. Under paragraph 911A(2)(l) of the Act ASIC exempts the Operator in the case specified in Schedule A from section 911A of the Act on the conditions set out in Schedule C for so long as those conditions are met.

Schedule A

1. The operation of the time-sharing scheme known as the Capri Waters Country Club at Melbourne Street Mulwala NSW 2647 Australia (**the Scheme**), where:
 - (a) at least 90% of the votes that may be cast on a resolution by members of the Operator are held by members that are not, and are not associated in relation to the Scheme with, any operator, manager, promoter or developer in relation to the Scheme, other than where held by members solely in their capacity as an associate of the Operator;
 - (b) at least 90% by value or number of all the interests in the Scheme that can be issued have been issued and are held by persons who are not, and are not associated in relation to the Scheme with, any operator, manager, promoter or developer in relation to the Scheme, other than where held by members solely in their capacity as an associate of the Operator;
 - (c) the Operator has control over management of the property that members of the Scheme have a right to use, occupy or possess as part of the Scheme (**the Property**) to the exclusion of any responsible entity of the Scheme;
 - (d) no promoter of the Scheme nor any developer in relation to the Property has failed to perform any contractual obligation to any member in relation to the Scheme that is likely to adversely affect the member's interests;
 - (e) no responsible entity or former responsible entity of the Scheme operates any scheme under which there is pooling of income received for the use of rights to occupy any part of the Property; and

- (f) all decisions in relation to the operation of the Scheme that materially affect the interests of members may be made only by the Operator or the Operator has a right of veto in relation to such decisions.

Schedule B

1. In relation to each building that was to be built under the terms of any prospectus in relation to the Scheme the Operator:
 - (a) ensures that the building is substantially completed to the extent that members will not be materially affected if no further construction occurs; or
 - (b) gives ASIC a notice in writing stating that the building will not be substantially completed and that the members of the Scheme will not be materially affected by its not being substantially completed;
2. Where any offers of interests in the Scheme for issue or sale are made by the Operator or by any other operator, manager, promoter or developer in relation to the Scheme, and the Scheme is not registered, the Operator ensures that:
 - (a) Chapter 6D of the Law is complied with as far as practicable;
 - (b) the offeror holds a Australian financial services licence that contains conditions relating to sales of interests in time-sharing schemes; and
 - (c) the offeror complies with the conditions of the licence, as if the Scheme were a registered scheme;other than an offer of interests referred to in Schedule C.
3. The Operator must ensure that either:
 - (a) the Property is held on trust for the members; or
 - (b) members hold title to the Property, and all members:
 - (i) have received their share or membership certificates in the Operator; and
 - (ii) fall into one or more of the following categories:

- (A) they have received a certificate of title showing the member as holding title in a portion of the Property in accordance with their entitlement (and where there is no certificate of title issued by the relevant titles registry, a copy of a registration confirmation statement or other evidence of title issued by the relevant titles registry); or
 - (B) they have received a copy of the certificate of title certified as a true copy by a Justice of the Peace or a lawyer, where the Operator has acknowledged that it is holding such a certificate in safe custody to be dealt with in accordance with provisions in the Operator's constitution that provide for the certificate to be used only to facilitate a transfer authorised by the member, or on forfeiture of the interest; or
 - (C) they became members as a result of an offer made before 6 December 1999 that was consequent upon the forfeiture of an interest by a former member;
4. The Operator must ensure that any management agreement for the Scheme or relating to the Property provides for the dismissal of the manager without any additional payment when members of the Operator pass a resolution to that effect in at least one of the following cases:
- (a) more than 50% of all members vote for dismissal;
 - (b) members holding more than 50% by value of the interests vote for dismissal;
 - (c) 75% of members voting (whether in person or by proxy) vote for dismissal where at least 25% of members eligible to vote do so; or
 - (d) members holding 75% by value of the interests that are held by members voting (whether in person or by proxy) vote for dismissal where members holding at least 25% by value of the interests eligible to vote do so,
- unless:
- (e) the management agreement was in force on 6 December 1999;
 - (f) there has not since that date been any lawful means for the Operator to terminate the agreement;

- (g) members are given at least 21 days' written notice that the Operator seeks to rely on the exception contained in these paragraphs (e) to (n) and that the management agreement does not meet the usual requirements of ASIC policy concerning how a management agreement may be terminated;
- (h) the notice sent to members allows the member to requisition a vote by ticking a form accompanying the notice;
- (i) the notice contains a summary of all material information that is relevant to a member's decision whether to requisition a vote;
- (j) the notice states prominently a reply paid address to which the form requisitioning a vote may be sent;
- (k) the notice states prominently that if:
 - (i) members who together hold at least 5% of the total value of the interests;
or
 - (ii) at least 100 members,requisition a vote by giving written notice to the reply paid address within 21 days from the date that the notice may reasonably be expected to be received by them, a postal vote will be held on whether the Operator should be able to rely on this exception or should be required to comply with the usual ASIC policy concerning how a management agreement may be terminated;
- (l) a postal vote is conducted if requisitioned in accordance with the notice as soon as practicable;
- (m) if there is a postal vote:
 - (i) a voting paper must be sent to each member which states a reply paid address to which the voting paper may be sent;
 - (ii) members must be notified in, or in a document accompanying, the voting paper that only votes received at the reply paid address within 28 days after the issue of the voting paper will be counted and that the vote will be taken as passed if supported by either a majority by value or by number of votes cast (as specified in the notice); and

and Exemption**

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)* the Australian Securities and Investments Commission (**ASIC**) revokes ASIC Instrument 01/0427.
2. Under paragraph 601QA(1)(a) of the Act ASIC exempts Seashells Limited ACN 001 722 5412 (**the Operator**) in the case specified in Schedule A from section 601ED of the Act on the conditions set out in Schedule B for so long as those conditions are met.
3. Under paragraph 911A(2)(l) of the Act ASIC exempts the Operator from the requirement to hold an Australian financial services licence for the provision of financial services, in the case specified in Schedule A on the conditions set out in Schedule C for so long as those conditions are met.

Schedule A

1. The operation of the time-sharing scheme known as Seashells at 363 Diamond Beach Road, Diamond Beach North, NSW 2430 (**the Scheme**), where:
 - (a) at least 90% of the votes that may be cast on a resolution by members of the Operator are held by members that are not, and are not associated in relation to the Scheme with, any operator, manager, promoter or developer in relation to the Scheme, other than where held by members solely in their capacity as an associate of the Operator;

Enabling Powers

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 926A(2)(c) and 951B(1)(c) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument [11/0003].

Declaration

3. ASIC declares that Part 7.6 (other than Divisions 4 and 8) of the Act applies in relation to Allianz Australia Insurance Limited ACN 000 122 850 (*Allianz*) and Allianz Australia Life Insurance Limited ACN 076 033 782 (*Allianz Life*) as if the following provisions were omitted, modified or varied:
 - (a) omit Note 2 in section 916D, substitute:

“**Note 2:** There are exceptions to this rule in sections 916E and 916EA”;
 - (b) in subsection 916D(2B) omit “section 916E.”, substitute “section 916E or 916EA.”;
 - (c) in subsection 916E(1) omit “insurer.”, substitute “insurer or provides general advice in relation to risk insurance products that are within the scope of the binder.”;
 - (d) in subsection 916E(2) omit “the binder:”, substitute “the binder or provides general advice in relation to risk insurance products that are within the scope of the binder:”;
 - (e) after section 916E insert:

“916EA Licensees acting under authority other than binder

- (1) Despite section 916D, a financial services licensee (the *authorised licensee*) may be the authorised representative of another financial services licensee who is an insurer, if the authorised licensee acts under a written agreement (*written agreement*) which authorises the authorised licensee to provide one or more of the following financial services on behalf of the insurer in relation to risk insurance products:
 - (a) deal in the products;
 - (b) provide general advice in relation to the products.


- (2) For all purposes connected with contracts that are risk insurance products, or with claims against the insurer, in respect of which the authorised licensee acts under the written agreement:
- (a) the authorised licensee is taken to act on behalf of the insurer and not the insured; and
 - (b) if the insured in fact relied in good faith on the conduct of the authorised licensee, the authorised licensee is taken to act on behalf of the insurer regardless of the fact that the authorised licensee did not act within the scope of the authorisation.
- (3) This section does not apply to the extent the licence of the authorised licensee covers the provision of a financial service of the kind mentioned in subsection (1) in relation to a risk insurance product”.
4. ASIC declares that Part 7.7 of the Act applies in relation to Allianz and Allianz Life as if the following provisions were omitted, modified or varied:
- (a) in section 940A omit “(see section 916E),”, substitute “(see sections 916E and 916EA),”;
 - (b) after subparagraph 942C(2)(j)(iii) insert:
 - “(iv) the providing entity is taken to act on behalf of the authorising licensee and not the client for any general advice given by the providing entity in relation to risk insurance products that are within the scope of the binder; and
 - (v) the authorising licensee is responsible, as between the authorising licensee and the client, for any general advice given by the providing entity in relation to risk insurance products that are within the scope of the binder; and”;
 - (c) after paragraph 942C(2)(j) insert:
 - “(ja) if the providing entity is an authorised licensee acting under a written agreement under section 916EA in providing any of the authorised services—a statement that:
 - (i) identifies the services provided under the written agreement; and
 - (ii) states that they are provided under the written agreement; and
 - (iii) explains the significance of the services being provided under the written agreement; and
 - (iv) the providing entity is taken to act on behalf of the authorising licensee and not the client; and

— Exemption**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 926A(2)(b), 992B(1)(b) and 1020F(1)(b) of the *Corporations Act 2001* (the *Act*).

Exemption

2. This exemption applies to an interest in a managed investment scheme (*serviced strata scheme*) which involves an owner (*investor*) of real property (*strata unit*), in the investor's discretion, making their strata unit available for use by a person (*Operator*) as part of a serviced apartment, hotel, motel or resort complex located at 533 Bussell Highway, Busselton, Western Australia, Strata Plan 37864, developed in accordance with approval of a local government organisation that has been given to ASIC and in relation to which, on 1 March 2000, there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme.
3. An interest in the serviced strata scheme is exempt from the following provisions of the Act:
 - (a) Part 7.6 (other than Divisions 4 and 8); and
 - (b) Section 992AA; and
 - (c) Section 1017F.

Where exemption applies

4. The exemption in paragraph 3 only applies where all of the following requirements are satisfied:
 - (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;
 - (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:

- (i) by a person other than the operator or an associate of the operator; and
 - (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;
- (c) each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
- (d) the operator is licensed in relation to the conduct of the letting services under the law of a State or Territory or is a financial services licensee;
- (e) no payment is liable to be made by an investor to participate in the scheme other than:
 - (i) payment of money to buy the strata unit; and
 - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
 - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate; and
 - (B) where a FFE Fund has been established for the investor — no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and
 - (iii) where a FFE Fund has been established for the investor — one or more payments into the Fund where:
 - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and

- (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;
- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme;
- (g) the serviced apartment, hotel, motel or resort complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in paragraph 5;
- (h) the operator takes reasonable steps to ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution is held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
- (i) where a FFE Fund has been established for an investor, the operator takes reasonable steps to ensure that:
 - (A) the money comprising the Fund is held on trust for the investor in a trust account and subject to audit as to whether the money has been dealt with in accordance with the terms of the trust by a registered company auditor at least annually; and
 - (B) the balance of the Fund is promptly returned to the investor at the termination of the scheme or upon the investor's withdrawal from the scheme, whichever occurs first;
- (j) each person that is involved in making an offer of interests in the scheme for issue does not engage in any misleading or deceptive conduct or conduct that is likely to mislead or deceive in connection with those offers;
- (k) the operator complies with the provisions specified in paragraph 5 which are included in the agreement referred to in subparagraph (g).

Terms of agreement between investor and operator

5. The agreement specified in subparagraph 4(g) is to contain provisions to the following effect:
-

(a) *Transfer of management rights*

- (i) If a majority of scheme members advises the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme; and
- (ii) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice; and
- (iii) A transfer referred to in subparagraph (i) or (ii) must be done as soon as practicable, but if there is a body corporate for the real property to which the scheme relates, there must be a reasonable time for members of the body corporate to consider whether to make a decision referred to in subparagraph (b)(ii) unless the body corporate has consented to the transfer; and

(b) *Consent of body corporate to new care-taking arrangements*

- (i) If an operator receives a notice under subparagraph (a)(i), the operator must advise all body corporate members of the name of the person to whom the transfer is to be made; and
- (ii) unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in subparagraph (a)(ii) if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions; and
- (iii) if a majority of body corporate members make a decision referred to in subparagraph (b)(ii), a majority of scheme members may then at any time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with subparagraph (a)(ii); and

- (iv) this subparagraph does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under subparagraph (a)(ii) or (b)(iii) before that notice is given to the operator; and

(c) *Price payable on transfer*

The price scheme members specify in a notice under subparagraph (a)(ii) must be one of the following:

- (i) the average of two valuations of the management rights by independent qualified valuers nominated by the Australian Property Institute (or another relevant independent professional body approved by ASIC); or
- (ii) the highest bona fide bid for the management rights (excluding a bid by the operator or its associates) at an auction of which at least 60 days' notice had been given; or

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 926A(2)(b), 992B(1)(b) and 1020F(1)(b) of the *Corporations Act 2001* (the *Act*).

Exemption

2. This exemption applies to an interest in a managed investment scheme (*serviced strata scheme*) which involves an owner (*investor*) of real property (*strata unit*), in the investor's discretion, making their strata unit available for use by a person (*operator*) as part of a serviced apartment, hotel, motel or resort complex located at Lot 11 DP 126086, Lots 2 and 3 DP 16946, Lot B DP 397190 and Lot D DP 397189, being the whole of the land located at 204-208 Beach Road, Batemans Bay NSW 2536, developed in accordance with an approval of a local government organisation that was been given to ASIC and in relation to which, on 1 March 2000, there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme.
3. An interest in the serviced strata scheme is exempt from the following provisions of the Act:
 - (a) Part 7.6 (other than Divisions 4 and 8); and
 - (b) section 992AA; and
 - (c) section 1017F.

Where exemption applies

4. The exemption in paragraph 3 only applies where all of the following requirements are satisfied:
 - (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;
 - (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:

- (e) no payment is liable to be made by an investor to participate in the scheme other than:
 - (i) payment money to buy the strata unit; and
 - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
 - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate; and
 - (B) where a FFE Fund has been established for the investor — no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and
- (iii) where a FFE Fund has been established for the investor — one or more payments into the Fund where:
 - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation a period and does not exceed 3% of the gross rent attributable to the investor for the period; and
 - (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;

- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme;
 - (g) each investor who is a member of the serviced strata scheme prior to the date of this instrument has, on or before 28 February 2011, been given:
 - (i) notice in writing that they may immediately withdraw from participation in the serviced strata scheme in their discretion and without penalty, by giving the operator notice in writing;
 - (ii) notice in writing that they may, in their discretion, continue to utilise the services of the operator by entering into a new written agreement for making their strata unit available for use as part of the serviced strata scheme which agreement includes provisions as specified in paragraph 5; and
 - (iii) if a Product Disclosure Statement is required to be provided under the Act, a Product Disclosure Statement.
 - (h) the serviced apartment, hotel, motel or resort complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in paragraph 5;
 - (i) the operator takes reasonable steps to ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution is held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
 - (j) where a FFE Fund has been established for an investor, the operator takes reasonable steps to ensure that:
 - (A) the money comprising the Fund is held on trust for the investor in a trust account and subject to audit as to whether the money has been dealt with in accordance with the terms of the trust by a registered company auditor at least annually; and
 - (B) the balance of the Fund is promptly returned to the investor at the termination of the scheme or upon the investor's withdrawal from the scheme, whichever occurs first;
 - (k) each person that is involved in making an offer of interests in the scheme for issue does not engage in any misleading or deceptive conduct or conduct that is likely to mislead or deceive in connection with those offers;

- (l) the operator complies with the provisions specified in paragraph 5 which are included in the agreement referred to in subparagraph (g).

Terms of agreement between investor and operator

- 5. The agreement specified in subparagraph 4(h) is to contain provisions to the following effect:

- (a) *Transfer of management rights*

- (i) If a majority of scheme members advise the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme; and
- (ii) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice; and
- (iii) A transfer referred to in subparagraph (i) or (ii) must be done as soon as practicable, but if there is a body corporate for the real property to which the scheme relates, there must be a reasonable time for members of the body corporate to consider whether to make a decision referred to in subparagraph (b)(ii) unless the body corporate has consented to the transfer; and

- (b) *Consent of body corporate to new care-taking arrangements*

- (i) If an operator receives a notice under subparagraph (a)(i), the operator must advise all body corporate members of the name of the person to whom the transfer is to be made; and
- (ii) Unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in subparagraph (a)(ii) if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions; and
