**Australian Securities and Investments Commission  
Corporations Act 2001 – Paragraphs 601QA(1)(a) and 601QA(1)(b) – Exemption  
and declaration**

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from paragraph 601FC(1)(d) of the Act to the extent that it requires the responsible entity of a registered scheme to treat members who hold interests of the same class equally in the case set out in Schedule B.
2. Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if Chapter 5C of the Act were modified or varied as follows:
  - (a) after subsection 601KA(3), insert:

"(3AB) Subsection (3) does not apply to a withdrawal in accordance with section 601KEB."; and

- (b) after section 601KE, insert:

**"601KEB Withdrawals following member approved withdrawal offer**

The responsible entity of a registered scheme may allow a member to withdraw from the scheme:

- (a) where:

- (i) the registered scheme holds interests in another registered scheme (*underlying fund*);
- (ii) the responsible entity of the underlying fund makes a withdrawal offer, opportunity or facility under which interests in the underlying fund may be withdrawn (*underlying fund withdrawal offer*);
- (iii) the responsible entity of the registered scheme withdraws interests in the underlying fund under the terms of the underlying fund withdrawal offer; and
- (iv) the responsible entity of the registered scheme makes a withdrawal offer, opportunity or facility (*fund withdrawal offer*) under which interests in the registered scheme may be withdrawn on substantially the same terms as the underlying fund withdrawal offer; and

- (b) under the terms of the fund withdrawal offer."

  - (i) members may elect to withdraw their interests in the Retail Fund in response to a withdrawal offer made by CMIL as responsible entity of the Retail Fund; and
  - (ii) the facility under which Small Balance Members in the Retail Fund in priority to withdrawals of other members may elect to withdraw all of their interests in the Retail Fund on or before 31 December 2010 in response to a withdrawal offer made by CMIL as responsible entity of the Retail Fund; and
- (b) subsequent withdrawal facilities for the Retail Fund under which members may elect to withdraw interests in the Retail Fund up to a maximum aggregate limit determined by CMIL from 1 January 2011; and

- (c) subsequent facilities under which Small Balance Members in the Retail Fund may elect to withdraw all of their interests in the Retail Fund from 1 January 2011.

**Small Balance** means a number of interests in the Retail Fund equal to or less than the threshold determined by CMIL in respect of the Retail Fund in the manner described in a communication to existing members of the Retail Fund before the Redemption Scheme commences.

**Small Balance Member** means a member of the Retail Fund who holds a Small Balance in the Retail Fund or is an Indirect Small Balance Member.





**Australian Securities and Investments Commission  
Corporations Act 2001 - Paragraphs 741(1)(a), 911A(2)(1), 992B(1)(a),  
1020F(1)(a) and 1020F(1)(b) – Exemptions**

**First Exemption: disclosure relief for offers not involving a contribution plan**

1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts:
  - (a) the Issuer from Parts 6D.2, 6D.3 (except section 736) and Part 7.9 where the Issuer:
    - (i) makes an eligible offer;
    - (ii) offers to arrange for the issue of financial products under an eligible offer;
    - (iii) issues a financial product under an eligible offer; or
    - (iv) issues a financial product on the vesting or exercise of a Performance Right that was issued under an eligible offer;that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met.
2. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
  - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
  - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.

**Second Exemption: licensing and hawking relief**

3. Under paragraph 911A(2)(1) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.

4. Under paragraph 911A(2)(1) of the Act, ASIC exempts:
- (a) the Issuer; and
  - (b) any related body corporate of the Issuer,
- from the requirement to hold an Australian financial services licence for the provision of the following financial services:
- (c) the provision of a custodial or depository service in connection with an eligible offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
  - (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
  - (e) dealing in a financial product in connection with an eligible offer covered by paragraph 1 of this instrument where any acquisition by purchase or disposal of the product (by the Issuer or an associate) occurs either:
    - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
    - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts the Issuer from sections 736, 992A and 992AA of the Act in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

#### Schedule

The following conditions apply:

1. the Issuer must ensure that the eligible offer is substantially on the terms set out in the draft terms of the Plan provided to ASIC as an attachment to a letter dated 24 November 2010;
2. when making the offer the Issuer must:
  - (a) include the offer in an offer document; and

- (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
  - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee;
3. the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and
4. the Issuer must take reasonable steps to ensure that the number of stapled securities to be issued on the vesting or exercise of a Performance Right, when aggregated with:
- (a) the number of stapled securities in the same class which would be issued were:
    - (i) each outstanding offer with respect to Performance Rights made under the Plan accepted and the Performance Rights vested or exercised; and
    - (ii) each outstanding offer with respect to stapled securities, units of stapled securities and options to acquire unissued stapled securities under any other employee incentive scheme to be accepted or, if relevant, exercised; and
  - (b) the number of stapled securities in the same class issued during the previous 5 years under:
    - (i) the Plan where the Performance Rights issued under the Plan have vested or been exercised; and
    - (ii) any other employee incentive scheme extended only to eligible employees,

but disregarding any offer made, or Performance Right acquired or stapled security issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
- (e) an offer that did not need disclosure to investors because of section 708 of the Act; or

- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D of the Act; or
- (g) an offer made under a disclosure document or Product Disclosure Statement, does not exceed 5% of the total number of issued stapled securities in that class as at the time of the offer.

*Note:* where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

### Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the Act;
2. the Plan or any other employee incentive scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
3. *Australian dollar equivalent* in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates;
4. *contribution plan* means a plan under which a participating eligible employee may save money by regular deductions from wages or salary (including through salary sacrifice arrangements) towards paying for shares offered for issue or sale under the Plan where the terms and conditions of the contribution plan include terms and conditions to the effect that:
  - (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application which is used in respect of the offer, or on a form which is included in or accompanies the offer document;
  - (b) before transferring contributions to acquire shares, any contributions made by an employee as part of the contribution plan must be held by the Issuer in trust for the employee in an account of an Australian ADI which is established and kept by the Issuer only for the purpose of depositing contribution moneys and other money paid by employees for the shares on offer under the employee share scheme; and
  - (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election is made all money deposited with the Australian ADI in relation to that

employee, including any accumulated interest, must be repaid to that employee;

5. **current market price** means, in relation to a stapled security, the price published by the operator of the principal financial market on which the stapled security is quoted as the final price for the previous day on which the stapled security was traded on that financial market;
6. **eligible employee** means, in relation to the Issuer, a person who is, at the time of an eligible offer:
  - (a) a full or part-time employee of the Issuer or of a related body corporate of the Issuer; or
  - (b) a director of the Issuer, or of a related body corporate of the Issuer, who holds a salaried employment or office in the Issuer or in a related body corporate;
7. **eligible offer** means an offer for the issue of a Performance Right under the Plan extended only to eligible employees of the Issuer;
8. **financial product advice** has the meaning given by section 766B of the Act;
9. **general advice** has the meaning given by section 766B of the Act;
10. **Issuer** means Aspen Group Limited ACN 004 160 927, and Aspen Funds Management Limited ACN 104 322 278 as the responsible entity of the Aspen Property Trust ARSN 104 807 767;
11. **offer** has a meaning affected by sections 700, 702 and 1010C of the Act;
12. **offer document** means a document setting out an offer under the Plan that:
  - (a) includes or is accompanied by a copy, or a summary, of the Plan Rules; and
  - (b) if a summary (rather than a copy) of the Plan Rules is given - includes an undertaking that during the period (the **offer period**) during which an eligible employee may acquire the financial products offered under the Plan, the Issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Plan Rules; and
  - (c) specifies in respect of the stapled securities that may be acquired on the vesting or exercise of a Performance Right:
    - (i) the acquisition price (if any) in Australian dollars; or

- (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
  - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
- (d) includes an undertaking, and an explanation of the way in which, the Issuer will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
- (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of stapled securities that will be acquired by the eligible employee when the Performance Right offered to the eligible employee vests or is exercised; and
  - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
- (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the Issuer or any related body corporate of the Issuer for the purpose of acquiring financial products under the Plan;
13. **Plan** means an employee incentive scheme that is known as at the date of this instrument as the Aspen Group Performance Rights Plan where:
- (a) the scheme is extended only to eligible employees; and
  - (b) the terms of the scheme are substantially on the terms set out in the draft Plan Rules provided to ASIC as an attachment to a letter dated 24 November 2010;
14. **Plan Rules** means the written terms of the Plan as at the date of this instrument that are substantially on the terms set out in the draft terms of the Plan provided to ASIC as an attachment to a letter dated 24 November 2010;
15. **Performance Right** means:
- (a) an unsecured right to acquire, by way of issue or transfer, a fully-paid stapled security in accordance with the Plan Rules; or
  - (b) where the right referred to in paragraph (a) has vested or has been exercised in accordance with the Plan Rules, but the fully-paid stapled security to which the right relates has not been issued or transferred to the eligible employee, an equitable interest in a fully-paid stapled security,
- where:

- (c) each Performance Right is offered for nil consideration; and
