

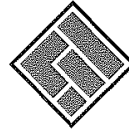



1. Under paragraph 1020F(1)(a) of the *Corporations Act 2001* (the Act), the Australian Securities and Investments Commission ("ASIC") exempts the Issuer from Part 7.9 of the Act where the Issuer:


