**Australian Securities and Investments Commission
Corporations Act 2001 - Subsection 655A(1) – Declaration**

Under subsection 655A(1) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) declares that Chapter 6 of the Act applies to the person specified in Schedule A, in the case specified in Schedule B, as if section 618 were modified or varied as follows:

- (a) in subsection (2), omit “If”, substitute “Subject to subsections (2A) and (2B), if”; and
- (b) after subsection (2), insert:

“(2A) Subsection (2) does not apply in relation to a holding that:

- (a) has come into existence; or
- (b) has increased in size;

because of a transaction entered into after the bid is publicly proposed.

(2B) If under paragraph 653B(1)(b) a person (the *holder*) may accept as if a separate offer had been made to the person for a parcel of bid class securities within the person’s holding held on account of another person or held in the person’s own right:

- (a) subsection (2) does not apply in relation to the parcel unless the holder has given a notice complying with subsection (2C) to the bidder in relation to the parcel before, or at the same time as, an acceptance of the offer extended under subsection (2); and
- (b) subsection (2A) applies in relation to the parcel as if the reference to “a holding” were a reference to the parcel.

(2C) A notice complies with this subsection in relation to a parcel of securities if the notice is signed by the holder of the securities and states:

- (a) either:
 - (i) that the holder holds the parcel in their own right; or
 - (ii) the name and address of the other person (the *beneficiary*) for, or on whose account, the parcel is held; and
- (b) if the securities are held on account of the beneficiary:
 - (i) the date the beneficiary acquired an equitable interest in the parcel or, if that date is not known, the date the beneficiary is reasonably believed to have acquired an equitable interest in the parcel; and

- (ii) where the date the beneficiary acquired an equitable interest in the parcel is the same date as the date the off-market bid is publicly proposed – whether the equitable interest was acquired before the bid was publicly proposed; and
- (c) if the holder holds the parcel in their own right:
 - (i) the date of the transaction by which the holder acquired a legal interest in the parcel; and
 - (ii) where the date of the transaction by which the holder acquired a legal interest in the parcel is the same date as the date the off-market bid is publicly proposed – whether the transaction occurred before the bid was publicly proposed.”.



- (a) subsection 605(2) of the Act were modified or varied by:
 - (i) deleting “or” at the end of paragraph (a);
 - (ii) deleting “.” at the end of paragraph (b) and replacing it with “; or”; and
 - (iii) inserting the following new paragraph after paragraph (b):
 - “(c) they are options which have different exercise prices and exercise dates.”;
- (b) subsection 618(1) were modified or varied by inserting the words “or compensate the holders of such securities for the cancellation, surrender or forfeiture of” after the word “buy” were it first appears in that subsection;



1. **Australian Securities and Investments Commission
Corporations Act 2001 – Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a),
1020F(1)(a) and 1020F(1)(b) – Exemptions**

1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts the following persons:
 - (a) the Issuer; and
 - (b) the Plan Trustee,

from Parts 6D.2 and 6D.3 (except section 736) and Part 7.9 of the Act where the person:
 - (c) makes an eligible offer; or
 - (d) offers to arrange for the issue of financial products under an eligible offer; or
 - (e) issues a financial product under an eligible offer; or
 - (f) issues a financial product on exercise of a DSU or PSU that was issued under an eligible offer,
on the conditions set out in the Schedule and for so long as the conditions are met.
2. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the Issuer or the Plan Trustee) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably be aware, that any of the conditions set out in the Schedule have not been met.
3. Under paragraph 911A(2)(l) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.

- from the requirement to hold an Australian financial services licence for the provision of the following financial services:
- (c) the provision of a custodial or depository service in connection with an eligible offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
 - (d) dealing in a financial product in the course of providing a custodial or depository service covered by paragraph (c); and
 - (e) dealing in a financial product in connection with an eligible offer covered by paragraph 1 of this instrument where any acquisition by purchase or disposal of the product (by the Issuer or an associate) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
5. Under paragraphs 741(1)(a) and 992B(1)(a) of the Act, ASIC exempts the Issuer from sections 736, 992A and 992AA of the Act in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

Schedule

The following conditions apply:

 - (b) where the right referred to in paragraph (a) has vested and has been exercised, but the share to which the right relates to has not been issued or transferred to the eligible employee, an equitable interest in a fully-paid share in the Issuer,

where the share to which the right or interest relates is in the same class as shares that have been quoted on the financial market operated by ASX Limited ACN 008 624 691 throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period; and
7. **eligible employee** means a person who is, at the time of an eligible offer, a full or part-time employee or director of the Issuer or of an associated body corporate of the Issuer; and
8. **eligible offer** means:
 - (a) an offer for the issue of DSUs or PSUs (where the PSUs are structured as DSUs) and the acquisition of a share either directly or under the Macquarie Group Employee Retained Equity Plan Trust that is made under the Plan; and
 - (b) an offer made to a person situated at the time of receipt of the offer outside of this jurisdiction of RSUs, DSUs or PSUs which upon vesting gives the holder the right to be issued, at the discretion of the Issuer, cash consideration equivalent to the current market price of the shares; and
9. **financial product advice** has the meaning given by section 766B; and
10. **general advice** has the meaning given by section 766B; and



11. **Issuer** means Macquarie Group Limited ACN 122 169 279; and
12. **Macquarie Group Employee Retained Equity Plan Trust** means a trust established by the Issuer under the Macquarie Group Employee Retained Equity Plan Trust Deed where the terms of the trust are substantially in the terms set out in the draft general terms of the Macquarie Group Employee Retained Equity Plan provided to ASIC as an attachment to an electronic mail dated 14 January 2010; and
13. **offer** has the meaning affected by sections 700, 702 and 1010C; and
14. **offer document** means a document setting out an offer under the Plan that:
- (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and

Schedule

Where:

1. an offer to sell a share is made; and
2. the share issued to the Plan Trustee and subsequently transferred by the Plan Trustee to a full or part-time employee (a *relevant employee*) or director (a *relevant director*) of the Company, or of an associated body corporate of the Company, in accordance with the rules of the Plan; and
3. the share was issued without disclosure under Part 6D.2 of the Act, in circumstances where no disclosure document was required to be given; and
4. the Company did not issue the share with the purpose of the relevant employee or the relevant director selling or transferring the share or the interest, or granting, issuing or transferring interests in, or options or warrants over, the share or the interest.


