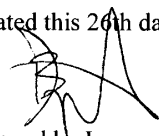

**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraphs 601QA(1)(b),
926A(2)(a) and (c) and 1020F(1)(b) – Declaration and Exemptions**

1. Under paragraph 601QA(1)(b) of the Act, ASIC declares that, until 30 June 2010, Chapter 5C of the Act applies to the persons referred to in Schedule A in the case referred to in Schedule B as if, in section 9, in the definition of *managed investment scheme*, after paragraph (ma), the following paragraph were inserted:

“(maa) a scheme for participating in, conducting and funding legal proceedings;”.
2. For the avoidance of doubt, the declaration in paragraph 1 of this instrument does not have effect for the purposes of section 601MB of the Act in relation to a contract entered into, before the date of this instrument, by a person to subscribe for an interest in a scheme for participating in, conducting and funding the legal proceedings referred to in Schedule B (the *litigation funding scheme*).
3. Under paragraph 926A(2)(a) of the Act, ASIC exempts, until 30 June 2010 the persons referred to in Schedule A from subsection 911A(1) of the Act for the provision of a financial service in relation to an interest in the litigation funding scheme.
4. Under paragraph 926A(2)(c) of the Act, ASIC declares that, until 30 June 2010, Part 7.6 of the Act (other than Divisions 4 and 8) applies in relation to the persons referred to in Schedule A in the case referred to in Schedule B as if paragraph 911B(1)(e) were omitted and the following paragraph substituted:

“(e) if the principal (rather than the provider) provided the service, the principal would not need an Australian financial services licence because:
 - (i) the provision of the service would be exempt under subsection 911A(2); or
 - (ii) the principal would be exempt from subsection 911A(1) in relation to the service as a result of an exemption under subsection 926A(2).”.
5. Under paragraph 1020F(1)(b) of the Act, ASIC exempts, until 30 June 2010, an interest in the litigation funding scheme from Part 7.9 of the Act.

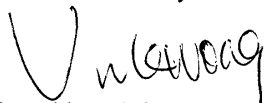

**Australian Securities and Investments Commission
Corporations Act 2001 - Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a),
1020F(1)(a) and 1020F(1)(b) – Exemption**

1. Under paragraphs 741(1)(a) and 1020F(1)(a), ASIC exempts the Issuer from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the Issuer:
 - (a) makes a Plan Offer;
 - (b) offers to arrange for the issue of financial products under a Plan Offer;
 - (c) issues a financial product under a Plan Offer,that does not involve a contribution plan, on the conditions set out in the Schedule and for as long as the conditions are met.
2. Under paragraph 1020F(1)(b), ASIC exempts a financial product that is the subject of a Plan Offer covered by paragraph 1 of this instrument from Part 7.9 where:
 - (a) a recommendation is made that a person to whom a Plan Offer has been made, acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
3. Under paragraph 911A(2)(l) ASIC exempts the Issuer and any related body corporate of the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with a Plan Offer covered by paragraph 1 of this instrument where the Plan Offer Document includes a statement to the effect that any advice given by the Issuer or any related body corporate of the Issuer in connection with a Plan Offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
4. Under paragraph 911A(2)(l), ASIC exempts:
 - (a) the Issuer; and
 - (b) a related body corporate of the Issuer,from the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (c) the provision of a custodial or depositary service in connection with a Plan Offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
 - (d) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph (c); and
 - (e) dealing in a financial product in connection with a Plan Offer covered by paragraph 1 of this instrument, where any acquisition by purchase or disposal of the product (by the Issuer or a related body corporate) occurs

either:

- (i) through a person who holds an Australian financial services license authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
5. Under paragraphs 741(1)(a) and 992B(1)(a), ASIC exempts the Issuer and any related body corporate of the Issuer from sections 736, 992A and 992AA in relation to a Plan Offer covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

Schedule

The following conditions apply:

1. the Issuer must ensure that the Plan Offer is substantially on the terms set out in the rules of the Plan provided to ASIC on 21 January 2010;
2. the Issuer must:
 - (a) include the Plan Offer in a Plan Offer Document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the Plan Offer is made is given a copy of the Plan Offer Document; and
 - (c) provide to ASIC a copy of the Plan Offer Document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee;
3. the Issuer must comply (or cause a related body corporate which has a registered office in this jurisdiction to comply) with any undertaking required to be made in the Plan Offer Document by reason of this instrument;
4. the Issuer must take reasonable steps to ensure that the number of Shares to be issued under the Plan Offer when aggregated with:
 - (a) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and rights and options to acquire unissued shares, under an employee share scheme (including the Plan) to be accepted or exercised; and
 - (b) the number of shares in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme (including the Plan) extended only to eligible employees of the Issuer,

but disregarding any offer made, or option or right acquired or share issued by

way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the Act.
2. the Plan shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee.
3. **Australian dollar equivalent** in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which the price relates.
4. **contribution plan** means a plan under which a participating eligible employee may save money by regular deductions from wages or salary (including through salary sacrifice arrangements) towards paying for shares offered for issue or sale under an employee share scheme where the terms and conditions of the contribution plan include terms and conditions to the effect that:
 - (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application which is used in respect of the offer, or on a form which is included in or accompanies the offer document;
 - (b) before transferring contributions to acquire shares, any contributions made by an employee as part of the contribution plan must be held by the Issuer in trust for the employee in an account of an Australian ADI which is established and kept by the Issuer only for the purpose of depositing contribution moneys and other money paid by employees for the shares on offer under the employee share scheme; and
 - (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election

is made all money deposited in the account referred to in paragraph (b) above in relation to that employee, including any accumulated interest, must be repaid to that employee.

5. **current market price** means in relation to a Share, the price published on the New York Stock Exchange on which the Share is quoted as the final price for the previous day on which the Share was traded on the New York Stock Exchange.
6. **eligible employee** means a person who is at the time of a Plan Offer, a full or part-time employee or director of the Issuer or of a related body corporate of the Issuer.
7. **financial product advice** has the meaning given by section 766B.
8. **general advice** has the meaning given by section 766B.
9. **Issuer** means Kellogg Company, a body corporate incorporated under the laws of the State of Delaware.
10. **Offer** has a meaning affected by sections 700, 702 and 1010C.
11. **Plan** means the employee incentive scheme known at the date of this instrument as the Kellogg Company 2009 Long-Term Incentive Plan which is extended only to eligible employees.
12. **Plan Offer** means the offer of a restricted share unit under the Plan, which upon vesting gives the holder the right to be issued, at the discretion of the Issuer, either:
 - (a) Shares on a one-to-one basis subject to adjustment in accordance with the Plan rules; or
 - (b) cash consideration equivalent to the value at the time of vesting of the Shares referred to in paragraph (a) calculated in accordance with the rules of the Plan; or
 - (c) a combination of the Shares referred to in paragraph (a) and the cash consideration referred to in paragraph (b)for nil consideration where the conditions of the Plan have been satisfied or waived in accordance with the rules of the Plan.
13. **Plan Offer Document** means a document setting out a Plan Offer under the Plan that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and
 - (b) if a summary (rather than a copy) of the rules of the Plan is given - includes an undertaking that during the period (the **offer period**) in which an eligible employee may acquire the financial products offered or exercise options acquired under the scheme, the Issuer will, within a

reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and

- (c) specifies the circumstances in which the Issuer may settle entitlements under the Plan Offer in cash rather than Shares and how the cash consideration payable under the Plan Offer will be calculated; and
- (d) specifies the vesting date and vesting conditions of the Plan Offer; and
- (e) specifies in respect of the Shares:
 - (i) the acquisition price in Australian dollars;
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the Plan Offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the Plan Offer; and
- (f) includes an undertaking, and an explanation of the way in which, the Issuer or a related body corporate of the Issuer which has a registered office in this jurisdiction will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of Shares; and
 - (ii) where subparagraph (e)(ii) or (iii) applies, the information referred to in that subparagraph as updated to that date.

14. **Share** means a share of Common Stock in the Issuer.

15. **unit** in relation to a share means a legal or equitable right or interest in the share.

Corporations Act 2001 – Paragraph 655A(1)(b) – Declaration

Under paragraph 655A(1)(b) of the *Corporations Act 2001* (**Act**), the Australian Securities and Investments Commission (**ASIC**) declares that Chapter 6 of the Act applies to the persons referred to in Schedule A in the case specified in Schedule B as if Part 6.2 of the Act were modified or varied by inserting the following after item 10 of section 611:

"Shortfall issues

10AA An acquisition that results from an issue of securities that satisfies all of the following conditions:

- (a) a company offers to issue securities in a particular class;
- (b) offers are made on condition that the securities to which the offers relate may only be issued where an offer of the securities has first been made to, but not accepted by, a holder of securities in that class (or their assignee) under an offer referred to in item 10 (*item 10 offer*);
- (c) offers are made to every person to whom the item 10 offers are made and are not made to any other person;
Note: the item 10 offers need not be made to every person who holds securities in the class: see section 615.
- (d) all of those persons have a reasonable opportunity to accept the offers made to them;
- (e) agreements to issue are not entered into until a specified time for acceptances of offers has closed;
- (f) the terms of all the offers are the same; and
- (g) the securities are offered at the same price per security as the securities offered under the item 10 offers."

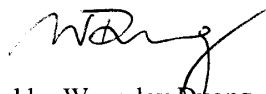

**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 911A(2)(l) – Exemption**

Under paragraph 911A(2)(l) of the Corporations Act 2001 (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts the person referred to in Schedule A from the requirement to hold an Australian financial services licence in the case referred to Schedule B.

Schedule A

The Toronto-Dominion Bank (the body) to which all of the following apply:

- (a) the body has a current banking licence; and
- (aa) the body is a body corporate incorporated in the Province of Ontario, Canada (pursuant to the issuance of letters patent in accordance with the *Bank Act, S.C. 1991* (Canada)) and
- (b) the body:
 - (a) is registered under Division 2 of Part 5B.2 of the Act; or
 - (b) has not failed for more than the last 10 business days to have an Agent; and
- (c) the body's primary business is the provision of financial services; and
- (d) neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument; and
- (e) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule C:
 - (i) 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
 - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
- (f) the body has not notified ASIC that it will not rely on this instrument.

Schedule B

Where

1. the body provides any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients:
 - (a) providing financial product advice;
 - (b) dealing in a financial product;
 - (c) making a market for a financial product; or
 - (d) providing a custodial or depository service;in respect of any of the following financial products:
 - (e) derivatives;
 - (f) foreign exchange contracts;
 - (g) securities;
 - (h) debentures, stocks or bonds issued by a government;
 - (i) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act;
 - (j) managed investment products; or
 - (k) deposit-taking facilities that are not deposit products; and
 2. the financial services are only provided by the Singapore branch of the body as part of its operations in Singapore; and
 3. the body has provided ASIC with:
 - (a) a copy of the banking licence granted to it by MAS; and
 - (b) a notice that it will provide financial services in this jurisdiction in reliance on this instrument; and
 - (c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - (i) the deed is irrevocable except with the prior written consent of ASIC; and
-

- (ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise; and
 - (iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services; and
 - (iv) if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B (1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
 - (v) the body covenants that, on written request of either the MAS or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the MAS to disclose to ASIC and ASIC to disclose to the MAS any information or document that the MAS or ASIC has that relates to the body; and
- (d) written consents to the disclosure by the MAS to ASIC and ASIC to the MAS of any information or document that the MAS or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

Schedule C

1. The body must provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the Singaporean regulatory requirements if the financial service were provided in Singapore in like circumstances.
2. The body must:
 - (a) notify ASIC, as soon as practicable and in such form if any as ASIC may from time to time specify in writing, of the details of:
 - (i) each significant change to, including the termination of, the banking licence applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and

- (ii) each significant particular exemption or other relief which the body obtains from the Singaporean regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
- (b) notify ASIC by 31 March and 30 September of each year in such form if any as ASIC may from time to time specify in writing:
 - (i) either:
 - (A) of the details of each significant change (a **notifiable regulatory change**) to the Singaporean regulatory requirements (including in the power or authority of the MAS to supervise, monitor or procure compliance by the body with the Singaporean regulatory requirements with respect to the provision of the financial services) in the 6 months (the **notification period**) ending on the 15th day of the month by the end of which the notification is required that is relevant to the financial services the body provides or intends to provide in this jurisdiction and is not a change that ASIC has stated in writing is not required to be notified for the purpose of this instrument; or
 - (B) where there have been no notifiable regulatory changes — that there have been no notifiable regulatory changes; and
 - (ii) either:
 - (A) of the details of each enforcement or disciplinary action (a **notifiable regulatory action**) taken by MAS or any other overseas regulatory authority against the body during the notification period; or
 - (B) where there have been no notifiable regulatory actions — that there have been no notifiable regulatory actions; and
- (c) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction in reliance on this instrument (before the financial services are provided) containing prominent statements to the following effect:
 - (i) the body is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services provided by the Singapore branch of the body as part of its operations in Singapore; and

- (ii) the body is regulated by the MAS under Singaporean laws, which differ from Australian laws.

Interpretation

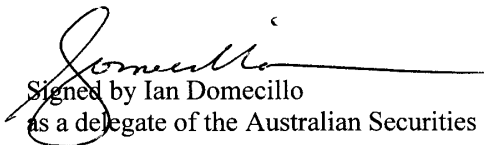

**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraph 911A(2)(l) — Exemption**

Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the person referred to in Schedule A from the requirement to hold an Australian financial services licence in the case referred to in Schedule B.

Schedule A

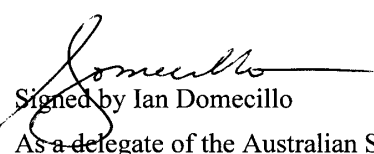

1 Name of Notice

This Notice is the *Corporations (ICAP Europe Limited) Exemption Notice 2010*.

2 Commencement

This Notice commences on the day of its publication in the *Gazette*.

3 Definitions

In this Notice:

Act means the *Corporations Act 2001*.

ASIC Class Order [CO 03/1099] means the document with that number and titled 'UK FSA regulated financial service providers' that was:

- (a) issued by ASIC on 22 December 2003; and
- (b) notified in the *Gazette* on 23 December 2003; and
- (c) in force on the commencement of this Notice.

Australian participant means a person in Australia who is a participant.

foreign participant means a participant who is not an Australian participant.

ICAP Europe means the corporation known as ICAP Europe Limited.

Section 6

i-forwards market means the financial market in foreign exchange contracts that are foreign exchange forwards operated by ICAP Europe in Australia.

Note The following expressions used in this Notice are defined in the Act:

- ASIC (section 9)
- associate (section 9)
- Australian financial services licence (section 761A)
- clearing and settlement facility (section 768A)
- corporation (section 57A)
- declaration of contravention (section 1317E)
- financial market (section 761A)
- financial product (section 761A)
- financial service (section 761A)
- financial services licensee (section 761A)
- financial year (section 323D)
- operating rules (section 761A)
- participant (section 761A)
- professional investor (section 9).

4 Exemption

For section 791C of the Act, and subject to the conditions mentioned in sections 5 to 15, the *i-forwards market* is exempt from the operation of Part 7.2 of the Act.

5 Operation of *i-forwards market*

- (1) ICAP Europe must operate the *i-forwards market* in all essential details in the way set out in its application to ASIC for an exemption from the operation of Part 7.2 of the Act dated 12 July 2007.
- (2) ICAP Europe must at all times comply with ASIC Class Order [CO 03/1099].
- (3) ICAP Europe, or an associate of ICAP Europe, must not operate a clearing and settlement facility for the *i-forwards market*.

6 Participants who may trade on *i-forwards market*

- (1) ICAP Europe must not admit an Australian participant to the *i-forwards market*, or allow an Australian participant to enter into a trade on the *i-forwards market*, unless the Australian participant is a professional investor who is trading on its own behalf or on behalf of another professional investor.
- (2) ICAP Europe must not admit a foreign participant to the *i-forwards market*, or allow a foreign participant to enter into a trade on the *i-forwards market*, unless the foreign participant:
 - (a) is a professional or institutional investor in the jurisdiction in which the participant trades; and

- (b) is trading on its own behalf or on behalf of another professional or institutional investor.
- (3) ICAP Europe must not trade on the i-forwards market on its own behalf or on behalf of another investor.

7 Arrangements to manage conflicts of interest

- (1) ICAP Europe must establish and maintain arrangements to manage any conflicts of interest that arise in relation to activities undertaken by ICAP Europe in the operation of the i-forwards market.
- (2) The arrangements must be to the satisfaction of ASIC.

8 Annual report

Within 3 months after the end of each financial year for ICAP Europe, ICAP Europe must give an annual report to ASIC that sets out information about the extent to which ICAP Europe has complied with the conditions of this Notice during the financial year, including the following:

- (a) a description of the activities in relation to the operation of the i-forwards market that ICAP Europe undertook during the financial year;
- (b) if any material system outages occurred during the financial year that prevented Australian participants from using the i-forwards market:
 - (i) the number of outages; and
 - (ii) the duration of each outage; and
 - (iii) the cause of each outage; and
 - (iv) a description of the means by which each outage was resolved;
- (c) the names and number of Australian participants authorised to access the i-forwards market on the first and last days of the financial year;
- (d) details of the volume of trading on the i-forwards market by Australian participants throughout the financial year;
- (e) the number and nature of significant complaints made to ICAP Europe by Australian participants who used the i-forwards market during the financial year, and the action taken by ICAP Europe in response to each complaint;
- (f) any specific regulatory issues that ICAP Europe encountered during the financial year and actions taken to resolve those issues (whether inside or outside Australia);
- (g) details of any significant conflicts of interest identified by ICAP Europe in relation to its operation of the i-forwards market during the financial year, and how each conflict of interest was resolved.

Section 11

9 Minister may require ICAP Europe to obtain audit about annual report

- (1) The Minister may, by written notice given to ICAP Europe, require ICAP Europe to obtain an audit report about:
 - (a) the annual report mentioned in section 8; and
 - (b) any information or statements accompanying the annual report.
- (2) The Minister may, in the notice, nominate either of the following to carry out the audit and prepare an audit report:
 - (a) ASIC;
 - (b) a specified person or body that is suitably qualified to carry out the audit.
- (3) ICAP Europe must comply with a notice given to it under this section.

10 Reporting of certain events involving Australian participant

- (1) If ICAP Europe takes any disciplinary action against an Australian participant in the i-forwards market, ICAP Europe must, as soon as practicable after the action is taken, advise ASIC in writing of:

 - (c) when the action was taken.
- (2) If ICAP Europe has reason to suspect that an Australian participant has committed, is committing, or is about to commit, a significant contravention of the Act or the i-forwards market's operating rules, ICAP Europe must, as soon as practicable, advise ASIC in writing of:
 - (a) the participant's name; and
 - (b) details of the contravention; and
 - (c) ICAP Europe's reasons for that suspicion.

11 Reporting of certain events involving ICAP Europe, its director or secretary

- (1) ICAP Europe must, within 14 days of becoming aware of a matter mentioned in subsection (2), advise ASIC in writing of the matter.
- (2) For subsection (1), the matters are that ICAP Europe, or a director or secretary of ICAP Europe:
 - (a) is the subject of a declaration of contravention in relation to a provision of the Act; or
 - (b) has been convicted of an offence under the Act; or
 - (c) has been disqualified from managing a corporation; or
 - (d) has been banned or disqualified from providing financial services.

Section 12**12 Notice if ICAP Europe ceases to operate i-forwards market**

ICAP Europe must, within 7 days of ceasing to operate the i-forwards market, advise ASIC in writing of that fact.

13 Requirement to assist ASIC

- (1) If ICAP Europe receives a reasonable request in writing to do so, ICAP Europe must give assistance to ASIC, or a person authorised by ASIC, in the performance of ASIC's functions in relation to the operation of the i-forwards market.
- (2) The assistance may include giving access to any information, document or books held by ICAP Europe.

14 Requirement to enter written arrangement with ASIC

ICAP Europe must enter into a written arrangement with ASIC for cooperation with ASIC in matters about this Notice.

15 Transaction recording

- (1) ICAP Europe must ensure that arrangements are made for recording information about orders placed and transactions effected on the i-forwards market.
- (2) The arrangements must be to the satisfaction of ASIC.
- (3) To comply with subsection (1), the records must be kept in sufficient detail to show the following particulars:
 - (a) the date and time that an order was received;
 - (b) the identity of the participant placing the order;
 - (c) the name and quantity of the financial product to which the order applies;
 - (d) the designation of the order as a buy or a sell order;
 - (e) any limit or stop price prescribed by the order;
 - (f) the date and time on which the order expires;
 - (g) details of any modification or cancellation of the order;
 - (h) the price and quantity, and the date and time of execution, of the order;
 - (i) the identities of the counterparties to the transaction.
- (4) ICAP Europe must keep the records for at least 7 years from the time they are made.
- (5) On request by ASIC, ICAP Europe must make the records available to ASIC.

Corporations Act 2001 – Paragraphs 601QA(1)(b),

1. “(e) if the principal (rather than the provider) provided the service, the principal would not need an Australian financial services licence because:

 - (ii) the principal would be exempt from subsection 911A(1) in relation to the service as a result of an exemption under subsection 926A(2).”.

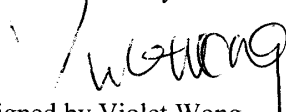

Exemptions

1. Under paragraph 1020F(1)(a) of the Corporations Act 2001 (*the Act*), the Australian Securities & Investments Commission (*ASIC*) exempts the Issuer from Part 7.9 where the Issuer:
 - (a) makes a Plan Offer;
 - (b) offers to arrange for the issue of financial products under a Plan Offer;
 - (c) issues a financial product under a Plan Offer,that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met.
 2. Under paragraph 1020F(1)(b), ASIC exempts a financial product that is the subject of a Plan Offer covered by paragraph 1 of this instrument from Part 7.9 where:
 - (a) a recommendation is made that a person to whom a Plan Offer has been made, acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
 3. Under paragraph 911A(2)(l), ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with a Plan Offer (including any general advice given in the offer document) where the offer document for the Plan Offer includes a statement to the effect that any advice given by the person in connection with the Plan Offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
 4. Under paragraph 911A(2)(l), ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (a) the provision of a custodial or depositary service in connection with a Plan Offer covered by paragraph 1 of this instrument where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
-

- (b) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph (c); and
 - (c) dealing in a financial product in connection with a Plan Offer covered by paragraph 1 of this instrument, where any acquisition by purchase or disposal of the product (by the Issuer) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
5. Under paragraph 992B(1)(a), ASIC exempts the Issuer from section 992A in relation to Plan Offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

Schedule

The following conditions apply:

1. The Issuer must ensure that the Plan Offer is substantially on the terms set out in the rules of the Plan provided to ASIC on 1 February 2010; and
2. The Issuer must:
 - (a) include the Plan Offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the Plan Offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain any details of the Plan Offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
3. The Issuer must comply (or cause a related body corporate which has a registered office in the jurisdiction to comply) with any undertaking required to be made in the offer document by reason of this instrument.

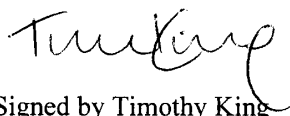

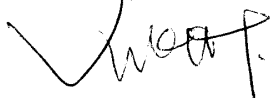
