**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 601QA(1)(b) – Declaration**

**Australian Securities and Investments Commission

Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the person referred to in Schedule A from the requirement to hold an Australian financial services licence in the case referred to in Schedule B.

Schedule A

Harding Loevner LP (the *body*) where all of the following apply:

- (a) the body is a registered investment adviser; and
- (aa) the body is a partnership established in the State of Delaware in the US; and
- (b) the body:
 - (i) is registered under Division 2 of Part 5B.2 of the Act; or
 - (ii) has not failed for more than the last 10 business days to have an Agent; and
- (c) the body's primary business is the provision of financial services; and
- (d) neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument; and
- (e) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule C:
 - (i) 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
 - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
- (f) the body has not notified ASIC that it will not rely on this instrument.

 - (c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - (i) the deed is irrevocable except with the prior written consent of ASIC; and
 - (ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise; and
 - (iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services; and
 - (iv) if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in

relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and

- (v) the body covenants that, on written request of either the SEC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the SEC to disclose to ASIC and ASIC to disclose to the SEC any information or document that the SEC or ASIC has that relates to the body; and

 - (B) where there have been no notifiable regulatory actions — that there have been no notifiable regulatory actions; and
- (b) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
 - (i) the body is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
 - (ii) the body is regulated by the SEC under US laws, which differ from Australian laws.

Agent means a natural person resident in this jurisdiction or a company, whose name and address were last notified to ASIC by the body for the purposes of this instrument, and who is authorised to accept on the body's behalf, service of process from ASIC and, in relation to proceedings relating to a financial services law, from any person referred to in subsection 659B(1) of the Act.

ASIC Act means the Australian Securities and Investments Commission Act 2001 (Cth).

custodial or depository service has the meaning given by section 766E of the Act.

derivative has the meaning given by section 761D of the Act.

financial product advice has the meaning given by section 766B of the Act.

financial services law has the meaning given by section 761A of the Act.

foreign exchange contract has the meaning given by section 761A of the Act.

making a market has the meaning given by section 766D of the Act.

managed investment products has the meaning given by section 764A(1)(b) of the Act.

notice and *notified* mean, respectively, written notice and notified in writing.

overseas regulatory authority means a foreign regulatory authority (other than the SEC) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body.

registered investment adviser means a partnership established in the US or a State of the US or a body corporate registered under section 203(c) of the Investment Advisers Act of 1940 of the US.

SEC means the Securities and Exchange Commission of the US.

securities has the meaning given by section 761A of the Act.

US means the United States of America.







1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsection 601QA(1) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 10-00245.

Exemption

3. ASIC exempts Perpetual Investment Management Limited ACN 000 866 535 (*Perpetual*) in its capacity as the responsible entity of Perpetual's Term Fund ARSN 092 387 874 (the *Scheme*) from paragraph 601FC(1)(d) of the Act in relation to allowing Perpetual to pay some or all of the net proceeds of the winding up of the Scheme to members in the case specified in Schedule A on the conditions specified in Schedule B.

Revocation

4. ASIC Instrument 08-00935 is revoked.

Schedule A

1. The constitution of the Scheme allows Perpetual to pay some or all of the net proceeds of winding up of the Scheme to a member in priority to other members where Perpetual is satisfied that:
 - (a) the member has experienced hardship or is likely to experience hardship if the member is not paid their entitlement to the net winding up proceeds on a preferential basis; or
 - (b) where the member is an operator—a person (*instructor*) who has asked the operator to request Perpetual to pay the instructor's entitlement to the net winding up proceeds on a preferential basis has experienced hardship or is likely to experience hardship if the payment is not made on a preferential basis; or
 - (c) where the member is dead—a beneficiary of the estate has experienced hardship or is likely to experience hardship if the executor or administrator of the estate is not allowed to receive the payment of the entitlement to the net winding up proceeds on a preferential basis.

2. A decision by Perpetual to allow a hardship payment is based on the following criteria and conditions:

	<u>Hardship Withdrawal Criteria</u>	<u>Condition</u>
1	Severe Financial Hardship	The amount requested is needed to enable the person to meet reasonable and immediate living expenses for themselves and/or their dependants.
2	Unemployment	For the avoidance of doubt, where the person has not been in gainful employment for a period of at least 3 months and has no other means of financial support (except government assistance, such as unemployment benefits).
3	Compassionate Grounds	<p>The amount requested is needed by the person (and/or the person's dependant):</p> <p>(a) to help pay for medical costs (and transport costs) required to treat a life-threatening illness or injury, to alleviate acute or chronic pain, or to alleviate an acute or chronic mental disturbance where 2 registered medical practitioners (at least one of whom must be a specialist) have provided certified statements confirming the medical condition to this effect;</p> <p>(b) to fund specific modifications (to a principal place of residence or vehicle) that are necessary to accommodate special needs arising from a severe disability;</p> <p>(c) to assist with funeral and other expenses related to the death of the person or the person's dependants;</p> <p>(d) to enable the person to provide care for another person who is dying from a terminal illness, including home care;</p> <p>(e) to prevent the person's mortgagee (lender) from selling the person's principal place of residence;</p> <p>(f) to meet a binding financial obligation entered into by the person prior to Perpetual's decision to terminate the Scheme; or</p> <p>(g) to meet expenses in other cases consistent with grounds mentioned in paragraphs (a) to (f),</p>

		where the person does not otherwise have the financial capacity to meet the expense.
4	Permanent Incapacity	Where the person has ceased gainful employment by reason of mental or physical ill-health and the responsible entity is satisfied that the person is unlikely ever again to engage in gainful employment of the type for which the person is reasonably qualified by education, training or experience.

Schedule B

1. Perpetual must not allow a hardship payment to be made unless Perpetual is satisfied that:
 - (a) following that payment, the scheme property would include sufficient liquid assets to enable Perpetual to satisfy its obligations under the constitution of the Scheme in relation to the winding up of the Scheme; and
 - (b) satisfying the request for a hardship payment:
 - (i) would not result in more than 4 hardship payments for any member, instructor or beneficiary (as applicable) in any calendar year; and
 - (ii) would not result in the total amount of hardship payments for any member, instructor or beneficiary (as applicable) in any calendar year exceeding \$100,000; and
 - (c) any hardship payment would not exceed the specific amount the subject of the request for payment in respect of the hardship of the member, instructor or beneficiary (as applicable); and
 - (d) where paragraph (1)(b) applies—any hardship payment to an operator will be paid to the instructor after deduction of any fees and charges payable to the operator; and
 - (e) where paragraph (1)(c) applies—any hardship payment to an executor or administrator of the estate will be paid to the beneficiary after deduction of any fees and charges payable to the executor or administrator.
2. If a constitution includes a provision permitting the responsible entity to exercise a discretion in relation to a hardship payment, Perpetual must comply with paragraphs (3) to (5).
3. Perpetual or its nominee must act reasonably in exercising a discretion covered by paragraph (2).

4. The responsible entity must ensure that the records which it keeps under section 988A document how and why a decision to permit or refuse a request for a hardship payment.
5. The responsible entity must retain the documents covered by paragraph (4) for 7 years after they cease to be current.

Interpretation

In this instrument:

another person, when used in paragraph (d) of item 3 in the table in paragraph (2) of Schedule A, means any natural person;

hardship payment means a payment by Perpetual of some or all of the net proceeds of winding up the Scheme to a person in priority to other members of the Scheme where Perpetual is satisfied that one of subparagraphs (a), (b) or (c) of paragraph 1 of Schedule A of this instrument applies;

operator means a person who is a member of the Scheme in its capacity as responsible entity or custodian of a registered scheme, a life company, trustee of a trust, trustee or custodian of a superannuation entity within the meaning of the *Superannuation Industry (Supervision) Act 1993*, trustee of a self-managed superannuation fund within the meaning of the *Superannuation Industry (Supervision) Act 1993* or provider or acquirer in relation to a custodial arrangement as defined in section 10121A; and

person means:

- (a) a member of a Scheme;
- (b) where the member of a Scheme is an operator—a person who has asked the operator to make a request for a hardship payment;
- (c) where the member of a Scheme is dead—a person who is a beneficiary of the estate of the member.

**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraph 911A(2)(l) — Exemption**

Under paragraph 911A(2)(l) of the *Corporations Act 2001* the Australian Securities and Investments Commission ("ASIC") exempts Novartis Pharmaceuticals Australia Pty Limited (ACN 004 244 160) ("Novartis") from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of:

- (a) general advice reasonably given in connection with the eligible offer (including any general advice given in the offer document) where the eligible offer document for the eligible offer includes a statement to the effect that any advice given by the person in connection with the eligible offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice; and
- (b) dealing in a financial product in connection with the eligible offer where any acquisition by purchase or disposal of the financial product the subject of the offer under the Plan occurs outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in Switzerland,

in the case specified in Schedule A and on the conditions set out in Schedule B for so long as they are met.

Schedule A

Where all of the following apply:

- 1. Fully paid shares in Novartis AG have been quoted on the financial market operated by the Swiss Exchange throughout the 12 month period immediately before the eligible offer is made without suspension for more than a total of 2 trading days during that period.
- 2. Where the eligible offer is made through a trust:
 - (a) the trustee holds the shares on trust for each person (a "beneficiary") who acquires units of shares under the eligible offer; and
 - (b) the trustee causes proper written financial records to be maintained in respect of the activities of the trust and causes those records to be audited annually and made available for inspection by the beneficiaries at an office of the trustee or a place of business of Novartis AG during normal business hours or such other time as is agreed with beneficiaries; and
 - (c) the trustee ensures that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and

- (d) the trustee does not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and
- (e) except as expressly provided by the trust deed, a beneficiary has the capacity to authorise the trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and
- (f) the trustee provides a copy of the trust deed to ASIC at the same time as a copy of the eligible offer document is provided to ASIC in accordance with this instrument.

Schedule B

Novartis must:

1. take reasonable steps to ensure that any eligible employee to whom an eligible offer is made is given a copy of the offer document; and
2. provide to ASIC a copy of the offer document (which need not contain details of the eligible offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
3. comply with any undertaking required to be made in the eligible offer document by reason of this instrument; and
4. ensure that the trust deed contains covenants binding the trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the shares to which the units of shares they hold relate as if they were the legal owner of the shares, including the right to:
 - (a) direct the trustee how the voting rights attaching to the shares shall be exercised, either generally or in any particular case; and
 - (b) receive the income deriving from the shares, including dividends declared by the issuer in respect of those shares.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the *Corporations Act 2001*;

2. an employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
3. "associated body corporate" of Novartis means:
 - (a) a body corporate that is a related body corporate of Novartis; or
 - (b) a body corporate that has voting power in Novartis of not less than 20%; or
 - (c) a body corporate in which Novartis has voting power of not less than 20%;
4. "Australian dollar equivalent" in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates;
5. "current market price" means the price of shares in Novartis AG published by the Swiss Exchange as the final price for the previous day on which those shares were traded;
6. "eligible employee" means a person who is, at the time of the eligible offer, a full or part-time employee or director of Novartis or an associated body corporate of Novartis who is eligible to participate under the rules of the Plan;
7. "eligible offer" means an offer for the acquisition of shares in Novartis AG under the Plan extended only to eligible employees;
8. "financial product advice" has the meaning given by section 766B;
9. "general advice" has the meaning given by section 766B;
10. "offer document" means a document setting out the eligible offer that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and
 - (b) if a summary (rather than a copy) of the rules of the Plan is given — includes an undertaking that during the period (the "offer period") during which an eligible employee may acquire the financial products the subject of the offer under the Plan, Novartis will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
 - (c) specifies the means by which the acquisition price will be converted into an amount in Australian dollars; and
 - (d) includes an undertaking, and an explanation of the way in which, Novartis will, during the eligible offer period, within a reasonable period of the employee requesting, make available to the employee the Australian dollar

equivalent of the current market price of the shares in the same class as those offered under the eligible offer;

11. "Plan" means the Novartis Employee Share Ownership Plan – Deferred and Novartis Employee Share Ownership Plan – Exempt extended only to eligible employees in substantially the form of the terms set out in the letter from Kelly & Co. Lawyers to ASIC dated 22 March 2010 in relation to 'Novartis Pharmaceuticals Australia Pty Limited ABN 18 004 244 160 (the "Company")' Deferred and Exempt Employee Share Plans – Application for Relief;
12. "Swiss Exchange" means SIX Swiss Exchange (previously known as SWX Swiss Exchange); and
13. "unit" in relation to a share means a legal or equitable right or interest in the share.
